## Landmarks approves preliminary designation for Halsted-Willow Group in Lincoln Park

The Chicago Commission on Landmarks gave preliminary approval to landmark four buildings at the corner of Willow and Halsted streets.

Located in Lincoln Park, the four buildings are located at 1732 N. Halsted St., 1727-1733 N. Halsted St., and 1800 N. Halsted St.

The buildings meet Criterion 1, value as an example of city, state, or national heritage. They were used and built by German immigrants, with many commercial uses over the years.

The group also meets Criterion 4, exemplary architecture. The

buildings exhibit a Victorian-era store and flats commercial building type. They also are fine examples of neighborhood mixed-use buildings in the Italianate and Queen Anne architectural styles.

All of them are finely constructed and ornamented with stone, brick, terra cotta, and pressed metal panels.

The building located on the northwest corner of the intersection [1800 N. Halsted St.], is part of a large planned development. It will require consent from the owner for landmark designation. At 1732 N. Halsted St., on

### Former speakeasy

The building at 1800 N. Halsted St. is the original site of Schulien's, a tavern and restaurant that first opened at its original location in 1886.

Back then, Schulien's served Lincoln Park locals as an old-world German tavern. During the bleak time of Prohibition, Matt Schulien kept his tavern going by running a speakeasy in the basement.

(Schulien's then moved to the North Center neighbor-

## Two Lake Shore Dr. projects close in on final plans

Just when you thought there was no more room on Lake Shore Dr. new buildings find spaces to pop up.

Three new buildings may soon grace the North Lakefront if approved by city officials.

The first project was announced in Jan. 2020 and is growing on space located adjacent to the landmark former Immaculata High School building, on the northwest corner of at Irving Park and Marine Dr.

Developers KGiles LLC and CA Ventures are proposing a

planned development that includes a 27-story high-rise and the rehabilitation of the historic Immaculata High School building, which was designed by Prairie School architect Barry Byrne and was built in 1921.

The developers are proposing a new 27-story, plus penthouse building on the current surface lot with 230 senior units of which 60 units will be assisted living and 32 units will be for memory care. It will rise from an existing parking lot.

Just to the south, two new

buildings may rise at the City Club Apartments, a proposal at 3636 N. Lake Shore Dr.

The developer is reportedly now in negotiations with East Lake View Neighbors to review this proposal. The two-building complex will rise in a vacant lot in from of the New York Private Residences, 3660 N. Lake Shore Dr.

The developers first had to come to terms with New York Private Residences regarding ingress, egress and other traffic and use issues.

## Pride Parade organizers haven't filed for 2021 permits

With time ticking away, there are growing indications that the annual Chicago Pride Parade won't be held on its traditional date, the last Sunday in June, this year.

In fact, city officials confirmed Feb. 11 that parade organizers haven't even applied for a permit to hold a parade this year.

That's a pretty significant clue. Parade organizers have regularly applied for event permits in early December for the following year.

The Pride Parade, and Pride Week, are one of the largest tourist draws on Chicago's North Side each year.

The city is not issuing any permits for major events through the end of March due to COVID. And there are questions about what the summer will bring. But it takes months of work to pull off an event the size of Chicago's Pride Parade, so it's only natural to wonder when (or if) the city will have a parade this year.

## Near North Side affordable housing complex breaks ground on Schiller

A new \$25 million affordable housing complex broke ground Feb. 3 on W. Schiller St. The three-building, 48-unit mixed-income rental community project is being undertaken by Evergreen Real Estate Group and Structured Development.

The project, located at 711, 731 and 749 W. Schiller St. is called Schiller Place Apartments. It is located just south of Structured's NEWCITY development, on land that was formerly home of the New City YMCA. The developers hope that Schiller Place will preserve housing affordability in the Clybourn Corridor.

GMA Construction, a Minority Business Enterprise, Veteran-Owned Small Business and Section 3 firm, is the project's general contractor. GMA Construction Group is owned by Cornelius Griggs, a former Cabrini-Green resident who said he often hires workers from within the neighboring community.

Company representatives joined Ald. Walter Burnett Jr. [27th] and officials from the Chicago Housing Authority [CHA],

Illinois Housing Development Authority [IHDA], Hudson Housing Capital, CIBC Bank for the groundbreaking ceremony.

"Schiller Place Apartments helps us continue the revitalization of this area while ensuring longtime residents are not displaced by new developments that, in recent years, have established the Clybourn Corridor as one of the top mixed-use districts in the city," said Mike Drew, founding principal of Structured Development. "With a portion of the units set aside as affordable housing, Schiller Place will allow more Chicagoans to enjoy the many amenities now available in this location, including improved riverfront access through the creation of the Wild Mile."

"The growing appeal of the Clybourn Corridor increases the need for housing that is affordable and accessible," said David Block, director of development for Evergreen Real Estate Group. "Our firm is honored to be partnering with Structured to provide this much-needed addition to the neighborhood, where residents

# Are the golden arches seriously threatened?

I'm a pretty old-fashioned guy. Don't get me wrong, I'm no anti-modernist, but I thrive on the things that bring comfort, coziness, reasoned understanding and uncomplicated responsibility.

I like the things I know will work. The things that cause the fewest problems, the smallest glitches, the least amount of turmoil.

Another friendly signpost for me is homemade Thousand Island dressing and crisp Romaine lettuce. Any form of roasted lamb, au gratin potatoes, baking powder biscuits, chocolate gelato, Stilton cheese, Barry's Red Label tea and vintage port. No great shocks here, just the flavors

of our well-shaped everyday, old-fashioned eating. Uncomplicated, easily prepared and nourishing. Though not available in quick microwavable preparation.

Time, you see, is one of the most valuable ingredients of such savory delights. To cook well, you must be a friend of time. Which is one reason these luscious meals become scarcer and scarcer in the kitchens of America. When customers stop shopping for ingredients, shopkeepers stop stocking them. Treasured items can easily disappear. When was the last time you found oxtails easy to buy? Or kippers? Or you came upon a generous supply of veal kidneys? Where can you find creme fraiche, watercress or fresh horse-radish root?

Tastes change over time. Foods that once delighted older generations often lose their appeal as time and fashions change. Things we once took for granted seem to disappear from the grocery stores and markets of our neighborhoods. Nowhere is that more true than in communities of fast aging Millennials.

Social commentators have been looking closely at the customs and habits, likes and dislikes of the Millennials. And the trends appear, to me, to be of interest. They give us a glimpse of our future.

For instance, it appears that the generation has little appreciation for cloth napkins, fabric softeners or cruises.

But a good eggy breakfast gets me revved up. And no big need to stop midday for a big meal. But I do love blueberries and Special K. I'm not sure what turned Millennials away from cereal. I'm thinking Fruit Loops and Cap'n Crunch.

But of course now half our population seems to be lactose intolerant.

I'm one of those skeptics who can't buy the sudden lactose free, gluten free lifestyle. But I've held my tongue.

I don't use a lot of mayonnaise. Never put it on sandwiches or use it in salad dressings. But you can't make egg salad without the Hellmann's, or homemade potato salad, which I crave.

Besides, I delight in knowing that Napoleon's chef was an Irishman named McMahon who was always trying to please his boss. When he invented the mixture of melted butter and egg yolk that so pleased the Emperor, it was only right that the creation be named after McMahon. Hence mayonnaise. Or more correctly, McMahononnaise.

Vegetarianism appears so rampant among the fun-loving Millennials that I can just picture all the burgers, Sloppy Joes, Italian beefs, T-bones, rib eyes, tenderloins and prime ribs that have been tossed out by the very serious young folk who make up the generation. # Police Beat...

## Cops find gun on Loop street, perp wants it back

Prosecutors say a man who threw a gun out of his car window after an alleged road rage incident in the Loop almost got away with it — until he circled around the block and asked cops to give him his gun back.

Police responded to a call of a person with a gun in a car downtown around 4 p.m. Feb. 7 and spotted a silver Ford Focus that matched the one described in a 911 call, according to Assistant State's Attorney Franka D'Antignac. The caller said the man pointed a handgun at them during a road rage incident moments earlier.

Cops pulled the car over in the 100 block of N. State and spoke with its driver Charles Owens, 36. They didn't find a gun in the car, so they sent Owens on his way.

A few moments later, cops found a loaded handgun on the street nearby. As officers recovered the gun, Owens pulled back around, got out, and told the cops that the gun belonged to him.

Investigators located CPD surveillance camera footage that shows Owens allegedly throwing the gun out of his car.

D'Antignac said Owens, who works as a security guard supervisor, doesn't have a concealed carry license. His Firearm Owner's ID card, which is required for Illinois gun owners, expired in August.

Owens has never been arrested before, according to his defense attorney. He is charged with unlawful use of a weapon.

## Attempted murder charge filed in River North domestic-related hotel stabbing

A man who made headlines after his 5-year-old son shot himself with an illegal firearm in their home three years ago is now charged with attempted murder and domestic battery for allegedly stabbing his longtime girlfriend inside their River North hotel room Feb. 6. The woman is also the mother of his child, prosecutors said.

Judge John Lyke ordered Kevin Collins, 29, held without bail after a bond court hearing Monday in which the judge said prosecutors laid out "a roadmap of escalating domestic violence."

Collins "poses a real and present threat to this victim and any female he comes in contact with as well as this community," Lyke said.

Assistant State's Attorney Franka D'Antignac said Collins and his girlfriend were drinking and spending the night in their room at SpringHill Suites, 410 N. Dearborn, when he called 911 to ask for an ambulance.

Police and EMS personnel went to their 17th-floor room around 3:30 a.m. and found the woman on the couch with a stab wound to her

chest, lacerations on her hand, and head trauma, according to D'Antignac and CPD records.

The woman was taken to Northwestern Memorial Hospital in critical condition, but she has stabilized after surgery, D'Antignac said.

She allegedly told police that she remembers Collins punching her in the head during an argument and recalls seeing blood coming from her chest, screaming for help, and realizing he had stabbed her before she lost consciousness.

D'Antignac said Collins had been arrested six times for domestic violence, including five times for incidents involving the woman he allegedly stabbed. None of the cases resulted in conviction because the victims either refused to sign complaints or failed to appear in court, she said.

In 2018, Collins received a two-year prison sentence for possessing a defaced firearm after his five-year-old son found the gun in a bedroom closet and shot himself in the hand, according to D'Antignac and contemporaneous news reports.

The boy was also shot in the face during a 2016 drive-by.

## Man pleads guilty to brutal attack, let out of prison on the day he arrived

The man who was accused of beating, robbing, and trying to sexually assault a woman he followed from the Damen Blue Line CTA station in Dec. 2017, has reached a plea deal. And, after receiving the state's standard 50% sentencing discount and credit for time spent in jail while awaiting trial, he was released on the same day he arrived in prison.

Around 3:25 a.m. Nov. 26, 2017, a man followed the 23-year-old victim from the CTA station as she walked to her Wicker Park apartment. He pulled her into a gangway on the 1600 block of N. Bell, where he beat, robbed, and undressed her, police said.

A source told this reporter the woman was still unclothed when a passerby found her about 15 minutes after the attack.

Police later released surveillance images of the suspect returning to the Damen Blue Line station after the attack. Deonta Terry, then 27-years-old, turned himself in to police hours later.

Court records said he grabbed the woman from behind, "dragged her into a gangway [and] strangled her unconscious" with his bare hands before he "ripped off" her clothes. Terry took the woman's green coat, purse,

iPhone, and cash, prosecutors said.

They charged Terry with robbery, kidnapping by force or threat of force, aggravated battery, and attempted criminal sexual assault by force.

Terry has now struck a deal with prosecutors, according to court records.

Under the agreement, Terry pleaded guilty to robbery, theft, and aggravated battery by strangling in exchange for three concurrent sentences of six years, four months. Prosecutors dropped eight felony counts in the deal, including attempted criminal sexual assault and kidnapping.

Terry received a 50% sentencing discount for anticipated good behavior in prison and credit for three years and 66 days that he spent in custody before pleading guilty.

According to Illinois Dept. of Corrections records, Terry arrived at Stateville Correctional Center in Joliet Feb. 3 and he was released the same day. Judge Ursula Walowski oversaw the case.

## Career burglar, sentenced to 371 years in prison since 1991, adds seven more

A career burglar who was sentenced to a combined 371 years in prison between 1991 and 2018 is adding another seven years to his impressive total.

Walter Miller, 63, has pleaded guilty (again) to posing as a city worker to burglarize a man's home on the North Side in Dec. 2018 — six months after he got out of prison for another set of burglaries and home invasion.

The victim identified Miller as one of the burglars who pretended to be a city employee to enter his home. The burglary came during a time when police were repeatedly warning residents about conmen who were posing as Chicago workers or contractors to access homes.

Typically, one offender occupies the victim in conversation while the other goes to another area of the home to collect valuables.

Cook County Judge Diana Kenworthy, who oversaw the case, sentenced him to seven years with 747 days credit for time served. Illinois Dept. of Corrections records do not currently list his anticipated parole date. He was also ordered to pay the victim \$1,000 restitution.

Miller is no stranger to the world of burglary and home invasion, according to court records.

Six months before the burglary he just pleaded guilty to, Miller was paroled after serving ten years for a home invasion and five burglaries. Court records show he had been sentenced in July 2008 to six 20-year terms, but he served them concurrently and with a 50% good behavior "discount." So, instead of 120 years in prison, he was freed after ten.

Just seven years earlier, Miller was sentenced to thirteen terms of 12-1/2 years each for burglaries. Those were also served concurrently. So, instead of serving 162.5 years, he was released after six years behind bars.

Back in 1991, Miller was sentenced to five terms of 15 years each for burglaries. Once again, his sentences were served concurrently, so he was in prison for about eight years instead of 75.

## Two arrests, cops hopeful of "big break" in weeks-long violent crime spree

Chicago police are hopeful that they made a major step toward neutralizing a violent armed robbery and carjacking team suspected of com-

mitting crimes across the city and suburbs this winter.

Cops have connected the crew to the carjacking of Lyft driver outside Willis Tower, street robberies, hijackings, and a string of restaurant hold-ups in which gunmen crawled through the businesses' drive-thru windows.

Police arrested two men just after midnight Feb. 10 following a three-hour string of fast food restaurant robberies, including a Northwest Side Dunkin' where the offenders crawled through the drive-thru window with guns. When the men were arrested, they were driving an SUV that was carjacked last week in West Town.

"The [detectives] have a lot to do," a source said, saying the arrests "look promising."

After the Willis Tower carjacking on Jan. 20, Chicago police detectives released two separate community alerts that linked the hijacking to a violent group of criminals that investigators said was responsible for shootings and other violent crimes across the city and west suburbs.

CPD also said the men robbed fast-food restaurants during late evening and early morning hours by crawling through the businesses' drive-thru windows — and cops released video of the crew slithering through the drive-thrus of Dunkin' and McDonald's restaurants with handguns.

Last week, two men crawled through the drive-thru window of a Dunkin' at 5000 W. Irving Park Rd. and robbed the store while displaying a handgun that had a light or laser attached to its barrel, according to a CPD report.

A Subway restaurant and at least two other Dunkin' locations were also robbed late that night. And they're suspected of robbing a Dunkin' on the 3300 block of W. Addison earlier in the day.

Shortly after midnight, cops who were monitoring a CPD "blue light" camera saw two men get out of a recently-hijacked SUV in the Austin neighborhood. Tactical officers moved in and detained the duo. Police say they found a handgun with a light attached to its barrel inside the car.

According to CPD records, the Toyota RAV-4 the men were driving was taken at gunpoint in West Town earlier this week.

Now, the two men are at the center of a "significant" investigation into dozens of violent crimes over the past few weeks.

## Man gets 12 years for carjacking committed days after completing parole for another carjacking

In Jan. 2018, just two weeks after Salvador Reitinger completed an eight-year sentence for carjacking a driver in the West Loop, he tied up a woman inside her Irving Park garage and drove away with her car, prosecutors alleged.

Now, Reitinger has pleaded guilty to the crime in exchange for a 12-year sentence. He's scheduled to be released early in 2024.

Around 8 p.m. Jan. 6, 2018, a 49-year-old woman was in her garage in the 4100 block of N. Central Park when Reitinger walked in, put a handgun to her face, and collected her money, debit card, and keys, police said.

He tied the woman's hands and feet with electrical cords and a phone charger, then drove away in her 2013 Ford Focus with an aging "Bernie" bumper sticker on the back, according to cops.

Unbeknownst to Reitinger, the victim's cellphone was in the car, emitting pings as he allegedly drove to a nearby McDonald's.

Cops followed the phone pings and found a 2013 Ford Focus with a Bernie Sanders sticker parked in the 2700 block of N. Sawyer. Reitinger, then 26-years-old, was in the driver's seat eating his McDonald's, they said.

He ran and ditched a loaded handgun along the way, prosecutors alleged. But cops caught up with him.

A grand jury returned 16 felony counts against Reitinger. Last month, he pleaded guilty to one count of aggravated vehicular hijacking with a firearm in exchange for a 12-year sentence. The other 15 charges were dropped.

He received 999 days credit for time spent in jail before sentencing and the state will lop off half of his 12-year term for good behavior. Illinois Dept. of Corrections records show he is scheduled to be released on Jan. 10, 2024.

Judge Michael Hood handled the case. Reitinger was sentenced to eight years behind bars for carjacking a victim in the West Loop on Jan. 11, 2010. He completed parole in the 2010 case two weeks before his latest hijacking.

## Man kicked 4-year-old in the face at Belmont CTA station

A man kicked a 4-year-old boy in the face at the Belmont CTA station in Lakeview Feb. 12, according to police and prosecutors. Felony charges have been filed.

The boy and his 20-year-old mother were on a Brown Line CTA train that pulled into the station around 1:15 a.m. When the doors opened, the woman noticed two men fighting on the platform, and

she looked onto the train doors to see what was going on, prosecutors said.

They said one of the men, Calvin Williams, 23, walked onto her train car and kicked her young son in the face.

The mother struck Williams on his shoulder and then continued hitting him on the platform until police arrived to break them up, authorities said. Officers took Williams into custody.

An ambulance took the boy to Advocate Illinois Masonic Medical Center, where he was given pain medication, but he did not appear to have severe injuries, according to prosecutors.

A CPD spokesperson said he had a cut to his chin and facial bruising. Prosecutors charged Williams with felony aggravated battery of a child.

"This individual was four-years-old?" Judge Arthur Willis asked after hearing the allegations. When prosecutors confirmed the boy's age, Willis said he found that "extremely aggravating."

The judge ordered Williams held in lieu of \$100,000 bail and said he must go onto electronic monitoring if he can post the required \$10,000 deposit to get out of jail.

Williams has four felony convictions, including two for burglary and one for a 2015 hate crime, prosecutors said.

## The Home Front

Back in late 2018, the decluttering virus hit. This writer faced the dilemma of downsizing to a smaller abode. Maybe readers will recall that more than two years ago I wrote:

Now that the kids have grown up and moved out, a 4,000-square-foot single-family home with 4 bedrooms, 3.5-baths, a family room, media room, game room with wet bar, wine cellar, two fireplaces and attached garage, seemed too big for this writer and his wife.

After the garage sale, a list was made of the cherished pieces of furniture and family heirlooms that must be given away, shipped to our new tiny house in the Blue Ridge Mountains of North Carolina, or stored.

New staging furniture pur-

chased to sell the house, along with original art and framed posters were recycled by my wife to furnish and decorate an Old Town garden apartment which was converted to an Airbnb.

Thankfully, the huge armoire and the grand piano are gone. Yet, I confess, hundreds of books, 10 file cabinets full of home rehab and photo files, and 50 years of newspaper clips are still in my possession.

Then, there are the signed 16" softballs from more than 50 championships, bats, Hall-of-Fame memorabilia, bags of game-worn softball jerseys and jackets.

During our 2018 decluttering experience, Diane Krojanker, president of Let's Organize, a professional home and office organizer, kept repeating her motto: "When in doubt recycle, repurpose or throw it out." She says owning fewer things means you'll have less to clean, and less to maintain. "You'll be able to spend your precious time on what you love."

Luckily, we had access to basement storage spaces at other buildings and didn't have to rent a \$300-a-month storage locker like most folks.



When downsizing, a homeowners worst nightmare is to be paying monthly fees for an expensive storage locker that may soon be forgotten.

Storage horror stories abound, and inspired "Storage Wars," a cable show on auctioned lockers. A forgotten storage locker cost one relative \$31,000 in fees over a decade, and he never visited the space. A friend forgot to pay the storage fees for his family's rare antiques and lost the heirlooms.

Krojanker's first mission was to help us declutter an existing storage room we had at a nearby property. The storage space was stacked with boxes and file cabinets.

They were filled with old business, banking and tax records, public relations files and awards,

and outdated computer equipment. The debris we tossed filled six city garbage cans.

Unfortunately, six empty file cabinets soon were filled once again with files we decluttered from our house. With one basement storage room filled, pretty soon five decades of news clips spilled into two four-drawer files in the building's tool room, and more archival material ended up in lateral files in a small closet housing the buildings gas meters.

Two additional armoires then housed a dozen bound copies of

## CPS basketball getting underway— Catholic League opens with DePaul Prep win, Loyola loss

practices and will start games on Feb. 19.

The IHSA announced is extension of the CPS season to March 20, a week longer than the March 13 limit with applies throughout the rest of the state. This gives CPS teams one month and one day to play as many games as can safely be scheduled.

"We have 10 teams in our league [Red West-North]. So it's nine games that CPS has given us for a league schedule," said Lane Tech Coach Nick LoGalbo. "What the non-conference schedule looks like, I don't know.

Are they going to allow us to schedule and extra game per week or are they going to cap it? I don't know," LoGalbo said.

"Unfortunately, all the Catholic League and 30-mile radius teams have their schedules pretty locked up already. We were going to play DePaul and Pat's and Ignatius. I don't know if we are going to be able to get those teams in."

"I wish I knew more. When [the IHSA] extended [the season] a week, I really thought they

were going to do a regular season schedule and then a conference tournament that last week. But based upon the preliminary schedule I received, the regular season goes all the way to deadline. So I don't think there is going to be any playoff or tournament."

The preliminary CPS rules given initially to coaches do not allow spectators at all. Each team is allowed 20 people--15 players, two coaches and three others. There would also be two people

at the table, three officers, one administrator and a maintenance person. There is not specific allowance for press. However, that may change.

Sixth ranked DePaul Prep played its first game Monday, Feb. 8, defeating St. Joseph 54-37 in St. Joseph's nearly empty gym.

The Rams came out cold. Suffering jitters from the nearly year-long layoff, both teams missed shots and turned the ball over.

After a St. Joseph 7-0 run to open the game and about half of the first quarter, DePaul Prep coach Tom Kleinschmidt dialed up the pressure having his Rams trap the ball handler.

"Slow start coming out. You have to hand it to Joe's. They were way more physical than us. They came and punched us in the face... It's a Catholic League road game so you have to be ready and we weren't. For whatever reason. I'm not making any excuses. We picked up pressure and started getting some live ball turnovers. We started getting some baskets," Kleinschmidt said.

the Chicago Sun-Times Homelife sections from the 1980s and 1990s and placed in the corner of the basement. Our hardwood breakfast table from the big house now serves as a folding table in the building's laundry room.

Another storage space was created by removing old plank-walled storage lockers in another Old Town basement. Recessed lighting, a dehumidifier and sleeve heat/air conditioner were installed to protect hundreds of books, more art and photos, and a bare-bones building office was created.

Treasured heirlooms such as a curved glass curio cabinet, vintage movie posters and this writer's favorite Hemingway and Steinbeck books were moved to the mountain house, which also has four attic storage scuttles for more family artifacts.

So, after more than two years of decluttering, we still have storage places in five locations in two states.

This downsizing nightmare reminds me of that old "Morrie Mages Moment of Madness" commercial on black and white WGN-TV in the 1960s. Picture all sorts of sports equipment—bats, balls, baseball

gloves, footballs and helmets, bikes, skis, workout equipment—floating in a circle in thin air over Morrie's head.

Why didn't I heed the sage advice of Margareta Magnusson, a Stockholm artist, decluttering specialist and author of "The Gentle Art of Swedish Death Cleaning"?

She said: "If you don't love it, lose it. If you don't use it, lose it." The book's grim title deals with an issue we all must face. How to put our lives in order before we pass on so our loved ones won't have to.

Magnusson says there's a word for it in Swedish: *döstädning*, which means, "death cleaning." The idea behind *döstädning* is to gradually remove unnecessary things and get your home in order as you age.

It is likely that your family may only cherish a few sentimental items, photographs, and letters, perhaps some nice pieces of furniture, Magnusson reasons. Family and friends don't need to inherit everything, just a few meaningful things.

the southwest corner, is also part of the planned development, requiring consent from the owners for landmark designation. All buildings are mixed-use structures with ground-floor commercial uses and residential units on the upper floors. They all date back to the 1880s.

The final criterion, Criterion 6, distinctive theme as a district, is met within this designation. The group of buildings display a distinct visual unity, based on consistent scale, size, building setbacks, overall design, use of building materials, and detailing, grouped as an informal gateway to the residential neighborhood east and west of N. Halsted St.

hood at the location where present day O'Donovan's now stands.)

Schulien's operated there until shortly after the death of then owner, Charles Schulien, son of Matt Schulien. Schulien's North Center doors were shut for good in 1999 after operating for over 110 years, ending its reign as longest continuously operating tavern in Chicago. "Charlie" was the last of three Schulien generations to own the bar, and lived his life right above it.

They were so old that they actually owned Chicago Liquor License number two.

Schulien's was known for having magicians perform magic tricks right at their customer's table. The tradition started in the 1920's with legendary magician, Harry Blackstone, Sr. The magician would come around during your meal or, if you notified the waitress early-on, the magician would give you a 10-minute show following your meal. There was no charge, but most people tipped the magicians.

Among the framed pieces of memorabilia that graced the walls in the old Schulien's in North Center was the original notice posted on their Lincoln Park front door advising that they had been shut down by Prohibition.

Right next to it was a framed Chicago Daily Tribune article that wrote of a police raid at the Halsted St. address where over 200 people were arrested in the basement speakeasy, including many police, firemen, judges and politicians.

Richard Pfeiffer, who organized Chicago's Pride Parade for 45 years, died in Oct. 2019, leaving the annual event in the hands of his husband, Tim Frye.

Pfeiffer's parade applications were filed with military precision every year — on the first business day of December between 8:30 and 8:45 a.m. — city records show. Frye filed for last year's parade permit on Dec. 3, 2019, but the event was canceled due to COVID.

The city's Dept. of Cultural Affairs and Special Events said Thursday that no application has been filed for a 2021 parade.

The Northalsted Business Alliance, which organizes Boystown's annual Pride

Fest and Market Days street festivals, "is planning for a wide range of potential scenarios in 2021 including options with limited festival operations due to the pandemic," according to notes from a recent meeting.

But just because there aren't official city-permitted events doesn't mean people won't be partying in the streets of Boystown on Pride weekend. Large groups of revelers overtook Halsted Street on the Sunday when last year's parade would have been held. And they stayed in the streets — sometimes dancing on CPD squad cars — until 4 o'clock the next morning.

Pride parade organizers did not respond to an email seeking information about their 2021 plans.

will be steps from public transportation, retail, restaurants and recreation along the riverfront."

The four-story buildings, each with 16 apartments, are being built on an approximately 26,000 sq. ft. vacant site.

There will be eight market-rate units and the remaining 40 units set aside for households earning between 30% and 60% of the Area Median Income.

With 48 units, the total cost would be approximately \$520,833 per unit.

The development team secured project-based vouchers for 24 units through the CHA. In addition, there will be five units with preference for veterans and an additional five units for individuals sourced through the Statewide Referral Network, which works with households earning at or below 30% of AMI with a head of household who has a disability or illness.

Project funding included federal 4% Low Income Housing Tax Credits awarded by

IHDA and syndicated by Hudson Housing Capital; Illinois Affordable Housing Tax Credits awarded by IHDA, syndicated by Clocktower Tax Credits and sponsored by Housing and Human Development Corp., which will provide on-site social services to residents; a permanent loan from the Illinois Affordable Housing Trust Fund provided by IHDA; predevelopment financing from IFF; construction financing from CIBC Bank; and a first mortgage from IHDA.
