## Walmart to reopen Broadway store

Walmart on Friday announced plans to reopen seven Chicago stores that had closed during the rioting and looting May 30-June 1. One of the stores that will reopen is the one at 2844 N. Broadway in Lakeview East.

Doug McMillon, Walmart CEO, made the announcement at City Hall June 26. No timetable was given for a target opening date.

## Parts of Lakefront Trail merged due to damage

Due to the significant lakefront storm damage and high lake levels, two sections of the North Lakefront trail have been merged to accommodate users: From Fullerton to North Ave., users will merge onto one trail, and from North Ave. to Ohio St., trail users will be redirected to an on-street detour.

And due to general wave damage, the area from North Ave. south to Navy Pier is also closed, though that city order was broadly ignored last weekend by trail users.

## Some at Lane Tech ready to retire Indian mascot

Like Civil War generals on pedestals, the Lane Technical High School Indian mascot may become a thing of the past amidst an intense period of protests against police and claims of white supremacy across the country.

Many students and alumni have found the Indian mascot to be offensive to the Native American culture by trivializing an indigenous population that was slaughtered and forced from the land they once inhabited here for thousands of years.

In a letter sent to parents two weeks ago, the Lane Tech principal said that the school is looking at replacing the Indian mascot with something less offensive. "During this important

time of confronting racist structures within our society and in our school, we have been hearing from various [people] asking to change Lane's mascot," said Brian Tennison. "We champion diversity, inclusion, and understanding, and it's essential that we

live up to these ideals in all possible ways."

A group of students created an online petition that collected thousands of signatures demanding that the school remove the mascot. The school newspaper had removed the logo from its masthead in 2016, and some active students and alumni have tried to get the school to retire their Indian symbol for the past several years.

"The use of the Chief Indian as a mascot is an old, outdated racist tradition," wrote Shantel Edouard.

Defended by some alumni as a tradition and a way to honor Native people, the Indian mascot came under increased fire on

## Inspector general investigating city's pre-riot protest plans

Chicago's Office of the Inspector General (OIG) has launched an investigation of the city's preparations for protests that devolved into riots and looting on the weekend of May 30, according to documents provided by a source to this reporter.

The examination of the city's planning and performance was set into motion on June 10 when IG Joseph Ferguson ordered the Chicago Police Dept. to preserve a wide array of records from between May 25 and June 8.

A representative from the OIG's office who met with the Fraternal Order of Police June 24 told the union the preservation request was designed to learn about the city's protest planning, according to a summary of the meeting that was provided to this reporter.

The OIG did not respond to a request for comment.

According to the FOP meeting notes, 84 police officers who were accused of uniform infractions during the protests and riots will likely receive reprimands. Another 64 excessive force complaints were filed against officers during the uprising, the document says.

### Coming up short

Exactly what Ferguson's probe will uncover remains to be seen, but several shortcomings in the city's preparation have already begun to surface. Officers have

repeatedly pointed out that riots were already occurring in Minneapolis before the fateful weekend arrived, yet Chicago leaders apparently failed to believe that similar uprisings could happen here.

This reporter received an email where a police department spokesperson insisted, "CPD was fully prepared with ample resources to handle a peaceful protest downtown when officers were tasked with reacting to the uprisings."

Among the most serious failures alleged by multiple officers:

- The city's most experienced manager of mass gatherings was not consulted until the day after riots broke out.
- City officials abandoned a proven and tested strategy that suc-

cessfully contained tense protests related to the murder of Laquan McDonald and the 2012 NATO conference.

- A lack of executive leadership as the protests eroded into widespread looting and riots
- Bicycle teams, the cornerstone of CPD's crowd management strategy, were scaled back.

### Expert excluded

The most egregious miscalculation leading into the protests may prove to be a decision to exclude Chicago Police Deputy Chief Steve Georgas from pre-event planning. Georgas is easily the city's most experienced manager of mass gatherings. From the

I'm with him. After months of quarantined lockdown from an unwanted pandemic, we now are forced to respond to every wacky nutjob and disillusioned youth who ever had to suffer the pain of a meat sandwich or parents who actually work for a living.

Some of our Wicker Park neighbors have recently made contact to say that if we should need the police for any reason, we should call them. The Wicker Park Mutual Aid Society. They, not the Chicago Police, will respond to any emergency.

Sounds ideal. Think of the cash Mayor Lightfoot will save relying on bands of untrained Millennials to circumvent crime, and

round up criminals in the artsy-fartsy 'hood.

No details have been given by the ladies as to any follow-up system of detainment of the accused or arraignment of the arrested. Perhaps a Peoples Court-type system is planned. I'm feeling safer already. But I hope no one holds up the farmers market. I'm not sure such a crime could be resolved with long conversations around the heirloom tomato stall.

But America desperately needs a conversation among equals. We need to speak to each other honestly and truthfully. In that process our shared values have never been more critical. What we share as Americans is important. It will be the access way to one another. Our common faith and trust in our nation is implicit. Without it there is little chance of finding one another amid the turmoil, falsehoods, violence and hurt.

The racial disparity in the nation must be addressed with reason and keen judgment if a solution is to be fashioned. The results must be wise. Well-formulated. Dynamically fair.

Often, fairness is all civilized humans can achieve. But often, fairness is everything. It is the guarantee of trustfulness and mutual respect. Fairness creates an environment in which all sides find expression. Certain they can embrace compromise and difference without fear or suspicion.

Fairness is grossly missing from most conversations following the riots and looting of the past weeks. Without a civil vocabulary and a truthful disclosure of concerns, any dialogue is hindered, impeded and ill-conceived. Without the stabilizing factor of fairness, few people of intelligence or reason are able to proceed.

Americans with little regard for American history and even less knowledge of it, charge ahead

rampaging the truth and sacrifice of Americans who lived before us, settling burning issues of their day given the knowledge available to them. So critics resort to shallow theories and questionable analysis of our history. And correct it, if it strengthens their particular and peculiar agenda.

The present, it appears, offers little in the way of lessening the fears and anxieties of Americans on every side of every issue. Without the appearance of fairness, only restless intransigence is available to the frightened.

Never before has it been so obvious that many of our fellow citizens feel there are few places for them to turn. America's great progressive citizens, Baby Boomers and above, are aging. This is significant because following them are few who value the events and people of the past.

These are the generations who marched for civil rights. People who saw the promise of John Kennedy and his brother, Robert. The prophetic actions of Martin Luther King, Jr., the tragedy of Viet Nam, the fall of the Berlin Wall, the collapse of the Soviet Union and a realignment of the nations.

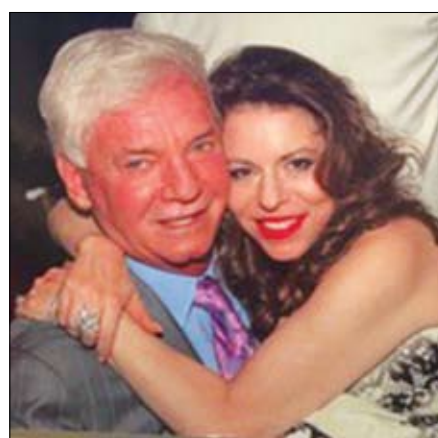

# Cops or no cops? That is the question

Plus, playful puppet performance



**Heart of the 'Hood**

Last week, by a narrow 4 to 3 vote, the Board of Education decided to keep in place a controversial \$33-million contract with the Chicago Police Department, to keep its resource officers in the schools. As the voting took place,

several hundred people marched downtown and across the city during a demonstration organized by the Chicago Teachers Union.

I was walking out my door when I spotted three teachers from Goudy Technology Academy, (5120 N. Winthrop Ave.) headed to the Loop--protest signs in hand. The trio was unanimous about one thing: That \$33 mil could be used in a lot better ways.

"Our kids come from situations where they need counseling...war torn countries, murder witnesses, refugees..." said Hannah Gallagher a drama teacher for the last two years at Goudy, which currently has two security guards, paid for by CPS. "The money could be used for nurses, social workers, counselors.

"Schools should operate like any organization," said Gallagher, a Rogers Park resident. "If you need the police, you call them. They're kids," added Gallagher. "They're still learning too. They're supposed to make mistakes."

Andersonville resident Katie Rocchio, a 15-year, eighth-grade literature and writing teacher at Goudy, agrees with her co-worker. Many times, if you just sit and talk to the student, issues can be handled and settled, she said.

"If you need the police, you call," said Rocchio. "We are already funding the police...we're taxpayers. So why is CPS expected to pay that additional \$33 million?"

There is no real social worker, psychologist, or school counselor at Goudy, said Rocchio. Yet those are the folks that she wants to see those millions go to. That's where the money will be best spent, she said.

"I teach eighth grade and so many young men I teach-- so many things go back to the emotions and stress they're feeling," said Rocchio. "Put a cop in the situation and it worsens things."

For me, this is a tough call. I definitely felt safer knowing that there was a Chicago police officer at the CPS elementary school my kids attended. And I felt even better knowing that cop was a former neighbor of mine.

But then again, I'm from the era of Laurie Dann, who walked into a Winnetka elementary school in May of 1988 and shot and killed an eight-year-old little boy and wounded several others. And what about the Connecticut elementary school, Sandy Hook? Twenty, six and seven-year-old children and six school staffers were killed that horrific day, just before Christmas in 2012. From news reports I've looked through, although Sandy Hook had just installed a new security system, it doesn't appear there was a school cop.

Would some of those kids still be alive if there had been one? It's such a tough call. Who knows?

I can also really see where the teachers are coming from though. I get it. They need nurses, counselors and social workers for their kids. And they need them badly. More than they need a cop.

"We all agree that the money can be directed to so many other things," said Anne Ruiz, a Rogers Park resident who is an 11-

year, fifth grade language arts teacher at Goudy. "The money can go to help communicate with kids and also help parents with resources."

Mayor Lori Lightfoot has said she will pretty much leave the decision to the Local School Councils. The councils will vote within the next couple of months ---before school starts---to make their own decisions on whether or not to have a resource officer. A survey done this spring by CPS found that 68% of responding LSC members favored keeping the officers.

And even though the Goudy teachers don't want \$33 million spent on a police presence at their school, they still would be more than happy to have a working relationship with their local men in blue.

"The police can be part of our community," said Rocchio. "They can stop over at our school and get to know us."

**Pulling some strings...** Pop-Up Puppet-Grams are a fun new program from the Chicago International Puppet Theater Festival, a non-profit organization founded by Chicago master puppeteer Blair Thomas that aims to establish Chicago as a prominent center for the art of puppetry and advance the form. It's a pilot project intended to keep local puppeteers active and working during the city's COVID-19 reopening plans.

Starting July 7, Logan Square resident Mark Blashford will inaugurate the Chicago International Puppet Theater Festival's new Pop-Up Puppet-Grams with his show, "Doorstep Marionette." It's like a singing telegram, live, and can now be ordered via the fest's website at [chicagopuppetfest.org](http://chicagopuppetfest.org).

Lucky recipients get a live, personal, five-minute puppet show featuring a tiny, talented cowboy artist delivered right to their front door, porch, lobby or yard, said Blashford. He said people can expect an expertly-performed marionette who shuffles about in his studio and paints a little picture as a gift for his puppet-gram recipient.

"My show, "Doorstep Marionette," is for kids, adults, and anyone in-between," said Blashford. "Whoever comes to the door is

welcome to watch -- in fact, I love when entire families come to watch. Sometimes neighbors join, especially when I perform in lobbies, which is the best."

The cool-sounding idea came to Blashford after his brother had donuts gifted to him through Grubhub. Then Blashford also saw his own neighbors order ice cream to their door.

"I thought, 'Why don't we send puppet theatre to each other?'" said Blashford. "Folks can't come to see my puppet shows in-person right now, but I can take my puppets to them, perform safely, and brighten their day."

Blashford has been building and per-

forming puppets for about 10 years and working professionally for five. He currently works independently as Rootstock Puppet Co. and as a member of the Chicago Puppet Studio. Blashford said he was inspired at a very young age by Fred Rogers, but these days he is most influenced by the work of renown puppeteers Matthias Kuchta, Albrecht Roser, and Bernd Ogrodnik.

The Pop-Up Puppet-Gram delivery fee is \$75 but you can only send them within the city and to several nearby suburbs. Blashford wears a mask and performs at least six-feet away to allow for social distancing.

# North Center bistro hosts grand reopening

With an expansive mixed-use corner site featuring apartments and an adjoining 30-car parking lot, Chicago Joe's restaurant, 2256 W. Irving Park Rd., long has been in the cross-hairs of North Central condominium developers.

While many great restaurants all over the North Side, such as the Brauhaus and Sabatino's, have closed or are left on the endangered species list, Chicago Joe's recently hosted a grand reopening party to celebrate its 32 years in business.

"We refused offers from developers to keep Chicago Joe's going," said manager Bradley Rompza, son of the legendary restaurant's founder Al Rompza.

The cozy, family-oriented restaurant is known for its craft cocktails, excellent seafood specials, oysters, Big-Joe's burgers, Firehouse chili and a hearty "home-cooking style" daily menu and convivial atmosphere reminiscent of Chicago neighborhoods from the turn-of-the-century through the 1950s, said chef Charles Kowalski, who returned this summer to spearhead a revival of the

kitchen with an all-new menu.

The restaurant at Oakley and Irving Park Rd. in the upscale St. Ben's neighborhood also sports an expanded outdoor dining patio with space for 80 people. The patio and restaurant officially reopened on Thursday, June 25.

"Chicago Joe's is named after Joe Rompza, my grandfather, who grew up in the neighborhood, played handball at the Irving Park YMCA and loved good home cooking," Al Rompza said.

Guests are served lunch and dinner in two spacious dining rooms and a large hardwood barroom that is tastefully decorated with sports antiques and historic Chicago memorabilia.

"Chicago Joe's also is a great place to just have a drink, visit with our colorful regular patrons, and enjoy the historic Old Chicago saloon atmosphere with its museum quality vintage sports memorabilia," said Rompza, who over the years has sponsored several men's and women's neighborhood softball teams, including

Vintage Risk, a legendary team with a roster of Chicago 16" Hall-of-Fame Softball players, as well as this newspaper's co-ed 16" team, The Inside Dirt.

The walls and ceilings at Chicago Joe's are covered with signature baseball bats, batting helmets, vintage hockey sticks, old boxing gloves, historic sporting event tickets, signed championship softballs and a collection of historic black-and-white photos of Windy City sports palaces—from Comiskey Park and Wrigley Field to the original Soldier Field.

There's also a collection of vintage Chicago politician and sports celebrity photos, including Mayor Richard J. Daley, and Chicago Bears Hall-of-Fame tight end Mike Ditka.

Highlighted in the Chicago Joe's historic collection are neighborhood scenes including vintage photos of North Side Chicago saloons and neighborhood scenes such as State St. and Maxwell St., old beer advertising signs, historic Illinois license plates and vintage "L"-train signage along with a collection of historic newspaper front pages from the Chicago Daily News and Chicago Tribune.

For dinner at Joe's seafood lovers can dine on the fish of the day, fried shrimp, and fresh Long Island Blue Point oysters. Another chef favorite is chicken parmigiana priced at \$13.

"Our menu priorities center on excellent seafood appetizers and nightly dinner specials, and a large assortment of sandwiches

and salads," Kowalski said. A dessert mainstay at Chicago Joe's is the Chocolate Brownie.

Another menu highlight is Mrs. O'Leary's Firehouse Chili—a thick and meaty version preferred by Chicago Joe's customers. The restaurant's homemade chili recipe consists of large amounts of finely diced onions, 80% lean ground beef and Mexican-style beans in a saucy base, all for \$5 a bowl.

# Are CPD's 300 statues under threat from mobs this weekend?

With nearly 300 sculptures, fountains and monuments, the Chicago Park District is steward to a truly world-class collection of public art. But increasingly, those pieces of public art are today being threatened by those who wish to destroy them due to social consciousness and political correctness.

Just within Lincoln Park there are statues of President Abraham Lincoln, General U.S. Grant, Alexander Hamilton, Gov. Peter Altgeld and greats of literature such as William Shakespeare, Johann Wolfgang von Goethe and Friedrich von Schiller plus many others. Another Lincoln statue guards a Lincoln Square intersection, while a 13'-tall bronze statue in Edgewater depicting a muscle-bound, chest-baring young Lincoln ponders over a book near Senn High School.

While some of the statues were paid for by wealthy benefactors such as Kate Buckingham (who paid the statue of Alexander Hamilton as well as Buckingham Fountain in Grant Park) many of them were paid for by the nickels and dimes of everyday Chicago residents, many of whom were immigrants.

But who is watching out for them in these days of outrage? Unfortunately, many monuments, memorials, and statues have been defaced, burned or destroyed in the last month, in Chicago and nationwide.

Each day, the sculptures seem to be unguarded and remain a target for those who

act out through vandalism.

And the Independence Day weekend seems like a high-risk time to be a public statue.

In fact, one North Side Horse of Honor, created to honor a fallen Chicago Police officer, has mysteriously left its well-known post, moved by the artist who knew it was a tempting target.

Ironically, Lincoln Park's statues of Grant and Lincoln are significant targets. Both were directly responsible for the Union victory in the Civil War and which ended slavery in 1865.

Many of those engaged in the destruction of statues throughout the United States cite a single source as providing their rationale. That book is the People's History of the United States by the late Howard Zinn, a left wing political scientist/activist. First published in 1980, the book became increasingly popular after it was mentioned in the 1997 Hollywood movie "Good Will Hunting." Today, Zinn's book is the most-read one volume history in American high

schools and colleges.

According to historian Mary Graber, author of Debunking Howard Zinn, the book presents a very biased version of American history and does not contain original research.

"Colleges of education don't require that future teachers take many courses in history, and often they are assigned Howard Zinn's A People's History of the United States. It is being used openly and widely, especially in Advanced Placement U.S. History courses in high schools. We are now going on to the third generation to be educated with a book that is full of historical lies and plagiarisms as I found out in researching my book," Graber says.

In Zinn's book, the Italian-born explorer Christopher Columbus is described as someone guilty of genocide and murder. According to Graber, Zinn did no original research into the life of Columbus and simply plagiarized a slim book written by

a close friend. Zinn's characterization has now made Columbus statues vulnerable throughout the country, including here in Chicago.

Prior to Zinn's book, historians had described Columbus as a daring, but flawed, leader who had sailed into the unknown and made a discovery which changed the world.

"I think most Americans at one time were proud of Christopher Columbus. I am not Italian, and I remember that in the 1960s and the 1970s we were taught to honor and respect him for what he did. What was celebrated was the discovery of the New World. There was gratitude to the man who made the discovery. He was not celebrated as a saint or because he was Italian. But naturally he was a source of pride for Italians. Washington Irving's four-volume history, which Americanized Columbus, was

## Plastic surgery protocols your doctor should be using in a pandemic

People still want to look their best – even when few are looking at them. As the pandemic continues and social distancing remains an important public safety measure, cosmetic surgery is resuming across the country.

The elective medical procedure was prohibited in most states throughout the peak months of the pandemic, but the phasing in of business reopenings has brought it back. Daily operations won't be the same as before, though, due to heightened health priorities.

"It will seem and look a little different when a patient visits the office, but the approach by the professional should always be the same: patient first," says Dr. Scott Miller, a cosmetic and reconstructive plastic surgeon. "Plastic surgery requires

head, heart and hands. Head for knowledge and vision, heart for empathy, hands for technical expertise.

"Patient safety is always No. 1, but now it's incumbent on all surgeons to ensure they and their staff leave no stone unturned when it comes to keeping their facility clean. Strict and consistent health and safety practices have to be followed every day."

Dr. Miller suggests these plastic surgery patient safety protocols patients:

- Several days before a scheduled surgery, patients are pre-screened to go over their recent health. It includes whether they have had any COVID-19 symptoms such as fever, sore throat, difficulty breathing, loss of smell/taste, etc. You need to know if they've traveled anywhere in the U.S. or abroad in the previous

three weeks, or if they've had any contact with people who had symptoms. They'll also fill out a form including these kinds of questions when they arrive.

- Regular and deep sanitization efforts to keep the facilities as germ-free as possible are essential. This includes continually disinfecting common areas and high-touch surfaces, starting from the front-office check-in area to each treatment and exam room before and after each patient interaction. Medical-grade air purifiers that circulate the air are very important. There are also machines that create a suction field over the head of a patient who is receiving facial injectables, clearing the air of potentially infectious particles.

- All patients should be temperature-screened when they arrive. And like many medical and dental offices, plastic surgery facili-

ties are limiting and staggering appointments to stay within social distancing guidelines, keeping their waiting rooms mostly

sparse. New patients' first consultations are often done by video conference. Also, patients should wait in their car until the staff is ready for their appointment.

- Providers and their staff will have to completely safeguard themselves and patients with increased personal protection equipment. Everybody wears N95 respirator masks, gloves, scrubs, gowns and eye protection during direct patient contact. For procedures such as lip fillers, wearing an N95 mask, the surgeon's approach is from above and the side, thus preventing close face-to-face frontal exposure and avoiding droplets in either direction.

"People will keep wanting to help their appearance, to get a renewed look back," Dr. Miller says. "The various ways of cosmetic surgery can still be done safely, and that's a team effort between patient, doctor, and staff. Everybody has to pay careful attention to ensure safety."

## Teach your children how to avoid the money mistakes you made

Numerous surveys show that many Americans live paycheck to paycheck, have little saved for retirement, and lack fundamental financial knowledge.

Part of the problem, experts say, is that financial literacy has not been emphasized in American education; only 21 states require high school students to take a personal finance class. If parents want their children to learn the value of money and how to avoid financial problems as adults, the education has to start at home.

When they understand their parents' financial situation and gain an understanding of financial literacy they are more likely to appreciate the gifts they are given, and why.

Teaching a child to be financially literate will help them understand that they have to take personal responsibility to be financially secure when mom and dad aren't there to put the food on the table for them.

These at-home teaching methods will help with financial literacy:

- **Gardening and investing.** The parent purchases seeds and other starting materials at a garden supply store and has the children keep track of the spending by item on a notepad. As you work together in the garden, keep a time log of each family member working. When it's harvest time, teach them to count up the cost of production. Help them determine the value of their produce by comparing store prices of the same product, minus the cost of production. They will learn that you can start small as an investor, but putting in more effort along the way makes things grow.

- **Working and budgeting.** Kruman says parents can undercut their teaching of financial literacy by handing out spending money whenever their child

wants something. They learn they are rewarded for effort, not just for showing up. With their finite amount of money, they can be taught what they'll have to do as adults – divide it up for bills, spending money, and savings every month.

- **Saving and staying out of debt.** A good lesson to learn about debt would be to show children how a loan would work by you being the lender. Have them think of something that they would like to buy but that they don't have enough money saved already. You could offer to help them make the purchase much earlier than continuing to save for it, but only in exchange for a loan payment that would be made by reducing their chore money. That way, they would learn how debt eats up their earning power. Savings isn't an option, but rather a necessity, so people don't become slaves to debt.

- **Apple slices and taxes.** Chances are your kids have already heard you bemoaning taxes, go get one of those vertical apple slicers, and cut an apple up in sections to represent the approximate portion of your personal tax hit – federal, state, city/township, Social Security, etc. Put those slices next to the remaining part of the apple, and that difference will stick with them.

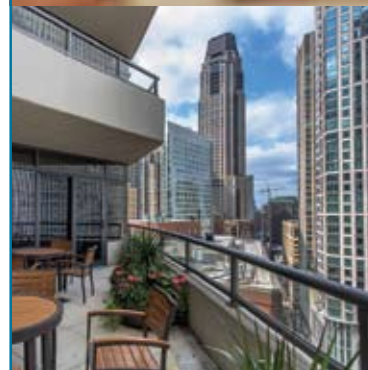
- **Toys and depreciation.** Toys wear out, and adults' expensive items, such as cars, need to be purchased to replace old ones, and teaching an understanding of that principle of depreciation is essential to teaching your kids why people need savings. Help them understand depreciation by asking them to compare prices of toys being sold at a yard sale versus a similar toy being sold at a new price online or in a store.

Parents can give their children years of age-appropriate financial lessons in their own home that will last a lifetime. Start now if you haven't already.

# Police Beat...

## Rogue Pride Parade, cops chill as partiers overtake Halsted St. 'til 4 a.m.

There was no Pride Parade in Chicago this year thanks to COVID-19. But that doesn't mean there wasn't a party in Boystown, social distancing be damned. Police took a hands-off approach with the hours-long pop-up festival, doing little more than block streets so people didn't get run over.

While the Halsted St. bars shuttered early (the city makes them close by 11 p.m. to prevent the spread of coronavirus), the strip was packed with revelers until police ordered them to leave under threat of mass arrest at 3:45 a.m. June 29. There were few — if any — arrests made as police took a back seat and let the night run free.

## Stranger stabs man on street, says "Welcome to Uptown!"

Police are looking for a man who stabbed a stranger on the street after telling the victim, "Welcome to Uptown."

It happened just after 9:30 p.m. June 27 on the 900 block of W. Montrose, according to Chicago police.

The victim, age 27, told police he was walking when the offender stabbed him in the arm with a sharp object and welcomed him to the North Side neighborhood.

An ambulance crew treated the victim at the scene. A police spokesperson said he is in good condition.

The victim described the offender as a Black male between 28- and 33-years-old who stands 5'-10" to 6' tall. He was wearing silver headphones, a light blue polo shirt, and jeans. Area Three detectives are investigating.

## Career felon charged with burglarizing Rogers Park salon

A career felon is charged with burglarizing a Rogers Park business — just three months after the state released him early from prison for his seventh burglary conviction.

Police responded to a burglary in progress call around 9:40 p.m. June 22 at Queen Nail salon, 7063 N. Clark, according to prosecutors. Officers found the front glass door broken and heard a noise inside.

Prosecutors said cops saw Vance Allen, 53, slamming the shop's cash register on the floor. Allen had already collected a keyboard, receipt printer, and other business property to take with him, according to allegations laid out in bond court. The burglary was allegedly captured on surveillance video.

The Illinois Dept. of Corrections did not ask Cook County to hold Allen for a parole violation, so he'll be released on electronic monitoring after he posts a \$100 deposit bond.

State records show he was paroled on March 20 after serving half of two concurrent six-year prison terms he received for a pair of burglaries in 2016. At the time of those burglaries, he was on parole after being released early from a 12-year

sentence he received for burglary in 2009.

At the time of the 2009 burglary, Allen was on parole for a 12-year attempted armed robbery sentence that he received in 2002. And at the time of the armed robbery, he was on parole for two concurrent six-year prison terms he received for burglaries in 1999. At the time of the 1999 burglaries, he was on parole for a 1997 narcotics charge. And he was on parole for a 1993 armed robbery at the time of the narcotics violation. At the time of the 1993 armed robbery, he was on parole for a 1991 burglary. And at the time of the 1991 burglary, he was on parole for concurrent seven-year and three-year sentences that he received for burglary and robbery in 1989.

## Teen in fair condition after shooting near Horner Park

A 17-year-old boy is in fair condition after he was shot near Horner Park June 23, police said.

The teen told police he was standing in an alley behind the 4300 block of N. Mozart when he heard gunshots and felt pain in his back, according to a CPD statement. He said he did not see the gunman or know where the shots came from.

Personnel at Swedish Hospital called police after the boy showed up for treatment around 12:24 a.m. The teen has a gunshot wound to his lower backside, police said.

Investigators who searched the area near the alleged shooting scene did not locate any evidence of gunfire such as shell casings or damage to buildings. Officers did receive a call of shots fired about two blocks away from the Mozart address earlier in the evening.

Area 5 detectives are investigating. The teen does not have prior contact with CPD, officials said.

## Four detained, gun recovered after man shot in River North

Four people are being detained by police after a man was shot in the River North neighborhood June 27.

Someone fired shots at the victim from within a group of people at 35 W. Illinois around 10:06 p.m., according to Chicago police and a witness. Personnel assigned to a nearby fire station saw the shooting unfold, according to a source.

According to preliminary information from a police report, the shooting happened after two groups of people got into a fistfight after someone in the group struck the victim's friend. Someone in the larger group pulled a gun and fired shots during the altercation, according to the CPD report.

An ambulance transported the victim, age 20, to Northwestern Memorial Hospital in fair condition with gunshot wounds to his arm and leg, police said. The man does not have prior contact with Chicago police, according to officials.

Officers searched the area and detained four men near Dearborn and Lake Streets who were allegedly seen running from the shooting scene. Police recovered a gun from a backpack carried by one of the men. A source said that man has a valid firearm owner's identification card, but he does not have a concealed carry license. The man who allegedly had the gun lives in the suburbs and has no adult arrest background, the source said.

The man who had the gun made incriminating statements during a police interview and detectives are seeking charges, according to a source.

Two of the four men were ruled out as being the shooter, according to a source. But the victim had to go into surgery before the other two men could be brought to him for possible identification.

According to CPD records, the shooting victim has a criminal history



## Arson in Lincoln Park, Lakeview

An arsonist set a series of fires in Lincoln Park and Lakeview June 29, according to Chicago police. No injuries were reported in connection with the fires which broke out in the same area where a rash of arson cases was reported last autumn.

The overnight fires are believed to be the work of the same arsonist, according to a source. The firebug apparently started two of the blazes by igniting discarded mattresses near garage structures. Two other fires were set to trash receptacles.

Fires were reported around 12:40 a.m. on the 2600 block of N. Burling. A garage and vehicle were burned after fire was set to a discarded mattress;

that includes multiple armed robberies, including some in the River North area.

Area Three detectives are investigating.

## Cops trying to identify man involved in Lakeview restaurant "extortion"



Chicago police are asking for the public's help in identifying a man who allegedly tried to extort a Lakeview restaurant last week.

## Outdoor potty break in Lincoln Park ends with broken arm and felony charges

A man wound up with a broken arm and a felony charge after he allegedly pulled a gun on a service station employee who asked him to stop urinating on the side of the Lincoln Park business June 27.

Prosecutors said Julio Rodriguez, 34, reached for a gun in his waistband when the worker asked him to stop peeing on the BP station at 1607 W. Fullerton around 12:15 a.m. The employee broke Rodriguez's left arm, which prompted Rodriguez and his companions to leave the scene in a Mercedes.

Officers pulled the car over a short time later and found a loaded handgun wrapped in a bloody rag under a floor mat where Rodriguez was sitting, prosecutors said in bond court.

around 12:58 a.m., after a dumpster was ignited behind the 2800 block of N. Broadway. This fire was set less than 20 feet from where another dumpster was set ablaze Nov. 2, 2019; around 3:40 a.m. on the 600 block of W. Arlington. Police said the offender then took cash from the victim's pants pocket and exited at the Chicago Ave. stop. The victim trailed the offender to the station's southeast exit, but he was unable to keep up with him.

An ambulance transported the victim to Northwestern Memorial Hospital where he was listed in good condition.

According to the victim, the robber is a Black male in his mid-40's with short hair and a gray beard who wore a black jacket.

## Man shot in Uptown Saturday

A man is in good condition after being shot on an Uptown street June 27, police said. No one is in custody.

The victim, age 27, was in the 600 block of W. Lawrence when he heard gunfire and realized he had been shot

around 12:20 a.m., according to initial information from Chicago police. He told investigators that he did not know where the gunshots came from or who shot him, police said.

Witnesses reported seeing a white SUV speed westbound on Lawrence after the shooting.

Officers applied a tourniquet to the victim's right leg to reduce blood loss from the gunshot wound. An ambulance transported the man to St. Francis Hospital in Evanston.

Officials said the victim has a history of contact with Chicago police.

## Armed catalytic converter thieves evade cops in Lakeview, Lincoln Park

An armed catalytic converter theft team that was captured on video in Humboldt Park last week escaped from cops who spotted them in the Lakeview and Lincoln Park neighborhoods June 26.

Officers responded to multiple 911 calls of two men driving a white Mercedes who were stealing catalytic converters from cars on the 1100 block of W. Altgeld at 6:40 a.m.

Police spotted the white Mercedes in traffic a short time later as it traveled northbound on Sheffield near George St. Officers confirmed that the men in the car matched images of two catalytic converter thieves who were seen in a video that circulated last week.

Other officers spotted the car again moments later near Sheffield and Roscoe and again near Belmont and Halsted. But cops were not allowed to pursue the Mercedes and it sped out onto southbound Lake Shore Drive, officers said.

In the video, one man stands near the trunk of the Mercedes with a gun in his hand while the other man climbs under a parked car and emerges with a severed catalytic converter.

The Mercedes' trunk is stuffed with stolen converters.

Catalytic converter thieves typically use saws to remove the devices from under parked vehicles, then sell them for \$100 to \$200 each at scrapyards. The parts are especially valuable because they contain expensive metals.

## Wisconsin man charged with trying to rob Loop bank

Federal prosecutors have charged a Wisconsin man with trying to rob a Loop bank branch June 26, according to court records. Four years ago, the man faced felony charges after he allegedly tried — and failed — to rob a bank in Wisconsin.

Adam Neibauer, 38, is charged with one count of bank robbery by threat and intimidation in connection with Friday's hold-up at PNC Ban, 1 N. Franklin.

An FBI agent said in court documents that Neibauer collected \$14,375 during the robbery attempt, but the crime was foiled by a teller who activated a silent alarm while he carried out a time-consuming hold-up plan.

Neibauer entered the bank shortly before 5 p.m. and said he wanted to get a loan. When a teller introduced him to a loan officer, Neibauer handed over a two-page note that said, among other things,

# Court case over pre-2010 red light camera tickets is back on for City Hall

The city of Chicago won't be able to pull to the curb a class action lawsuit demanding City Hall pay up to drivers who were hit with red light camera tickets before 2010, because the city didn't abide by its own rules in the way it served up notices to those who got the tickets.

On June 12, Cook County Circuit Judge David Atkins rejected the city's attempt to dismiss the lawsuit brought by attorneys representing potentially hundreds of thousands of people who may have received red light camera tickets from 2003-2010, and were excluded from an earlier settlement the city reached to resolve a different lawsuit over similar claims.

The city had argued the new lawsuit was barred by time limits set in place by Illinois law.

Judge Atkins, however, ruled to the contrary, as it was "undisputed" that the city failed to send the notices required by its own

ordinance before demanding payment from people who received red light camera tickets.

"Therefore, where the facts, as alleged, show that (the city of Chicago's) decisions may be found to be void, Plaintiffs are free to attack the decision at any time," Atkins wrote.

The lawsuit was filed in Jan. 2019, less than a year after City Hall had inked a settlement to end a prior class action lawsuit over legally defective red-light and speeding camera tickets sent from 2010-2015.

The new lawsuit was filed in Cook County Circuit Court on behalf of named plaintiffs Fred Hampton and Glenn Williams, and a potential class of hundreds of thousands of additional plain-

tiffs.

The lawsuit was patterned after the earlier class action brought to court in 2015.

In both lawsuits, the plaintiffs accused the city of violating its ordinance, governing the process by which red light camera tickets are administered. Specifically, the lawsuits accused the city of failing to send a second notice of violation to people who were mailed tickets under the city's automated traffic enforcement program. The notices were to be mailed to give those receiving tickets sufficient chance to contest them before the city began assessing additional fees and fines for the unpaid tickets.

Failure to issue the second notice should render any of those tickets "null and void," the plaintiffs represented Cafferty claimed in the new lawsuit.

"The City's misconduct likely coerced thousands of Class members to pay a fine they were not yet required to pay," the new lawsuit said.

To end the 2015 lawsuit, the city ultimately agreed to pay the

plaintiffs \$38 million, including \$11 million in fees to the Cherry & Associates lawyers. Class members got an average of \$58 each from the city as compensation for the \$100 tickets they allegedly wrongly had been made to pay.

However, that settlement only covered those who received tickets from 2010-2015. The new lawsuit said those who received tickets from 2003-2010 should not be barred by that settlement from pressing claims of their own.

In response, the city filed motions to dismiss, asserting the lawsuit was filed too late, outside the time limits set by state law. The city also argued the plaintiffs also failed to exhaust their administrative review options, and had paid the fines anyway.

Judge Atkins rejected all of those arguments.

He noted in a separate case on the same basic question concerning the need for the second notice of violation, another Cook County judge had ruled the word "shall" in the city's ordinance, required the city to send the second notice before collecting the fines. When the city did not send the second notice, it rendered void the ultimate decision requiring payment of the fine.

"The law is clear that if an agency decision is found to be void, there is no statute of limitations prohibiting a person from attacking that decision," Atkins wrote. He said the plaintiffs did not need to exhaust "available administrative remedies prior to bringing" their lawsuit, if the judge ultimately finds the failure to send the second notice of violation voids the payment demands altogether.

And finally, he rejected the city's invocation of the so-called "voluntary payment doctrine." The judge declined to hold against the plaintiffs that they had already paid the tickets, which he said under Illinois law, are seen as having been paid under threats of further action from the city.

published in 1828 and was the most popular history until Samuel Eliot Morison's Admiral of the Ocean Sea published in 1942. So Columbus in a way was American in the American imagination before he was Italian. But he has always symbolized the spirit of adventure, discovery, initiative, courage, vision, and Western ideals. He is an integral part of the story of our origins. That is why those who hate this country, and wish to replace it with a communist regime, as Zinn did, seek first to destroy his reputation through lies and then to destroy all reminders of him," Graber says.

According to historian Krista August, author of the book Giants in the Park, statues are meant to send a message to posterity, both about the person being honored and about the people who paid for the statue.

"Statues are provocative; that is partly their job. They represent history that our predecessors did not want us to forget. They were erected with great emotion, pride, and patriotism because a critical mass of our forefathers wanted to send these messages down through the generations. They were conceived and designed to project into the future, joy, care, wisdom, warning, and love," said August, whose book won the Chicago Writers Book of the Year Award in 2012.

In fact, says August, a quote from Lorado Taft, who create significant sculptures for the Chicago Park District in the 19th/early 20th century, provides a succinct way of looking at public art.

"One thing that separates us from our brother animals is the fact that we can send messages down through the generations, we can send greetings to a world unborn. Conversely, we can look back through the ages and be grateful to those who have

wrought for us. The means by which this is done is art. Through poetry and painting and sculpture, life begins to explain itself," said Taft.

While rigid iconoclast protesters today seek to destroy statues

which depict people which some may find disagreeable or which they do not understand, once statues are removed people will no longer be able to have a very real form of communication with the past.

"Statues are like books; they are a form of communication. Going to a bar or lecture is a way to connect with our contemporaries. But through books, paintings, artifacts, and sculpture we decipher meaning and messages from folks long since deceased. When we have a conversation with someone, we do not ever want to do all the talking! There is a time for us to talk and there is a time for us to listen. We do not have to agree with everything someone says. (We know this from our own family lives.) We do not have to agree with everything we read (nor should we!), and we do not have to admire every statue we encounter. Yet, listening to others from different backgrounds and from different times and with contrary viewpoints is ultimately rewarding and enriching, especially when it teaches us of flaws we share with those in our own history," August says.

“You’re getting robbed, I have a weapon, grab another employee, give me all your money,” according to the FBI.

The teller stepped out of the loan office under the guise of getting cash for Neibauer. On their way to the vault, the teller told another employee that they were being robbed. The second employee activated a silent alarm.

The teller returned to the office with \$7,000 in large bills. Neibauer then allegedly approached the teller area and ordered three cashiers to “give me all the money out of your drawers.”

After getting another \$7,375 from the tellers, Neibauer reportedly told the bank employees to wait five minutes and then do what they had to do. At that point, police began banging on the bank windows because the front door had been locked.

Police entered the bank and repeatedly ordered Neibauer to comply with them as other officers escorted bank employees to safety. Cops later said they found a knife in his possession.

Police eventually arrested Neibauer in the bank lobby. No one was injured.

has continued as an unofficial “Chief” continues to appear at games and other events.

The public has been questioning for years the use of Native mascots in professional football,

who won the last Super Bowl.

“Race-based mascots continue to uphold the structures of racism and genocide that this country is founded on,” said Heather Miller, executive director of the Ameri-

can Indian Center in Chicago. “There’s been studies done that highlight how seeing these images, seeing these symbols used in these ways is very difficult for Native youth and members of American Indian communities.”

In 2018, a Native American student at Lane wrote an opinion piece in the school newspaper, the Warrior, expressing his opposition to the mascot and his reaction to seeing students in headdresses at a pep rally. The student said he felt it was a misrepresentation and misunderstanding of his Native American culture.

NATO protests to sports teams’ victory celebrations, Georgas oversaw the successful management of countless major events of all kinds.

But Georgas wasn’t brought into the mix until the day after the city went up for grabs on May 30, according to multiple sources with knowledge of the matter.

“As much as I personally dislike the man,” one officer said, “he is very competent when it comes to planning and preparing for situations like the riots.”

A CPD spokesperson wouldn’t say when city leaders turned to Georgas for help last month. Instead, the CPD rep said only that Georgas “was an active member of CPD and served as the Incident Commander, leading the command post operations.”

When Georgas announced his retirement after the riots, ABC7 reported that he wasn’t brought into the command post until Sunday, the second day of the uprising.

**Proven strategy abandoned**

Leading up to the 2012 NATO convention in Chicago, an alphabet soup of federal agencies worked with the police department to develop a plan for handling protests that were expected to include anarchists and extremist groups.

It’s a plan that works so well, the city has pulled out the same playbook time after time to han-

dle volatile protests downtown. Inexplicably, those proven plans were jettisoned by whoever is responsible for the city’s May 30 plan.

The genius of the NATO strategy lies in its simplicity: use the city’s geography to contain protesters and prevent outsiders from intervening. Under the long-established plan, protesters have been allowed to march and congregate in the Loop. But police, supported

by CPD’s flexible bicycle teams, never allowed the crowds to cross any of the Chicago River bridges.

Protesters, contained by the river and the lake, marched in circles while flanked by police. When small groups broke away from the pack, CPD bicycle teams would out-flank them and move them back to the herd.

None of that happened on May 30 until it was too late.

The bridges were left unsecured as the riots broke out — until someone apparently decided it might be a good idea to raise them. But the horse was out of the barn by then. Violent crowds were already attacking police on both sides of the river. Rioters and looters marauded the treasured Magnificent Mile.

Physically raising the bridges, rather than protecting them with lines of officers, had an unintended consequence. Fire department and police resources were unable to easily cross the river to address problems on the other side. At one point on Saturday evening, the 1st Police District commander spent more than 15 minutes calling for SWAT “gas teams” to counter a violent mob along Wacker Dr. But the gas teams were all on the north side of the river and they had difficulty getting back across.

Whoever is responsible for the city’s May 30 plans also failed to have equipment in place to prevent vehicles from entering the downtown area. Open access gave looters and other troublemakers a chance to get in on the action, according to officers who spoke with this reporter.

**Lack of leadership**

The riots and looting of May 30 raged for nearly eight hours before Chicago Mayor Lori Lightfoot made any public statement about what was unfolding. She never even asked for calm on

social media. Her first comment was at a press conference where she announced that a citywide curfew would go into effect 45 minutes later.

Chicago Police Supt. David Brown, who had been on the job for only a few weeks, wasn’t seen near the riot zone until after 6 p.m. Saturday — an appearance that was quickly paraded on the department’s social media accounts. But he made no statements and, according to officers who were in the area, he left just as quickly as he arrived.

**Bikes sidelined**

On Sunday, after the first full night of riots and looting, Lightfoot told reporters, “planning for [the previous night] started days before. We had canceled days off, used overtime...We’ve now also shifted to 12-hour days, three watches.”

Several officers who were scheduled to be off on Saturday said that they volunteered to work, but the department turned them down because the city did not want to pay a premium rate.

And, while CPD’s gang teams, tactical teams, and saturation teams were required to work on Saturday, most district bicycle teams — the very units that were the backbone of the city’s long-established protest strategy — were not, according to officers.

Bike teams are “a very, very viable, strategic, tactical unit that we can deploy quickly. And they’re very, very effective in crowd con-

trol, and they can cover an awful lot of ground,” then-CPD Supt. Garry McCarthy said of the bike teams following the 2012 NATO conference.

“The officers could respond quickly, and when they do, they had a readymade barrier, just like any of those police barriers that we use at any event,” McCarthy said.

The police department didn’t cancel days off for Sunday — which would become the second day of riots and looting — until 11:13 p.m. on Saturday, about three hours after Lightfoot’s press conference.

Multiple officers told this reporter that the police department ran out of pepper gas during the weekend of riots. Similar information was reported by WBEZ.

But Tom Ahern, CPD’s Deputy Director of News Affairs and Communications said that is not true.

“CPD never ran out of our inventory of [pepper] gas,” Ahern said. “The supply of [pepper] gas was replenished from our regular distributor in Missouri.”

Ahern did not respond directly to questions about when the city began planning for the weekend of May 30 or who was involved in the strategy sessions.

“The joint operations center was stood up and comprised of public safety departments and supported by other city agencies.”
