Mayor visits Andersonville, beats hasty retreat when asked about Broadway upzoning

Mayor Brandon Johnson joined Ald. Leni Manaa-Hoppenworth [48th] on Clark St. in Andersonville on June 26 for breakfast and then visited the Women and Children First bookstore, 5233 N. Clark St. The assembled press and city workers appeared to outnumber community members.

The mayor's public schedule lists the visit as a press conference in the 48th Ward at the rainbow crosswalk at the intersection of Clark St. and Farragut Ave. But apparently answering tough questions was not on the agenda.

While much of the press conference was innocuous, pertaining to the Pride Parade, transgender and public safety, the mayor appeared

piqued at questions asked by Chicago Tribune reporter Jake Sheridan before beating a hasty retreat to his awaiting motorcade.

Sheridan asked the Mayor about the pending Broadway Upzoning measure due before the City Council's Zoning Committee in July. That will only occur if the city properly notifies property owners of the zoning change and posts public notices on affected businesses. The City has heretofore been sorely lacking in following zoning notification requirements.

Specifically, Sheridan asked the mayor if the upzoning will harm affordability on the Broadway corridor if future developments come to fruition.

The Mayor responded that he views the upzoning framework as the "restoration of vibrancy" in the neighborhood. He repeated the mantra that crime is down and added that Chicago is the number one destination city in the U.S. for the Fourth of July weekend.

The mayor's abrupt departure allowed him plenty of time to attend his next scheduled event at

Budget fraud and reserve risk in Illinois HOAs; A crisis of transparency

Illinois' homeowner and condominium associations [HOAs] are facing a quiet crisis. According to forensic accountant Michael Novak, a growing number of community associations are hiding serious financial irregularities, aided by complicit CPAs and unregulated management companies.

This is a cautionary tale for any and all North Side residents who live under a HOA, which is the most local and impactful level of governance for those HOAs claim to serve.

Key findings that may be found with a forensic audit of an HOA

include governance failures such as board presidents acting without board approval, financial decisions made outside required voting, and violations of Declarations and Bylaws; Unauthorized spending for unapproved salaries and bonuses, and reserve contributions waived without owner consent, and false tax filings where associations filed materially false federal and state tax returns and CPAs and board members failed to correct or disclose errors.

"It's very easy for me to find widespread fraud and abuse," Novak said during a June 25 interview. "The management companies have too much power over the professional consultants."

Novak, who is returning to Illinois after years of working with the State of Nevada Real Estate Division, has helped expose misconduct ranging from tax fraud to falsified reserve studies.

In one high-profile case—Kabir v. 175 East Delaware Place HOA—a Cook County court ruled in favor of a unit owner seeking access to withheld financial records. Novak served as the expert witness in the case, and his testimony went unchallenged. "They were not able to challenge my testimony," he said. "I could admit it, and that was a big factor in deciding the case."

Clarendon Park Community Center ribbon cutting July 7

At long last, the Clarendon Park Community Center ribbon cutting is finally happening. Festivities will be held Monday, July 7.

The famous Chicago Park District former beach house will reopen after a \$13 million overhaul that began in 2022.

The structure's deteriorating condition was the reason why in 2015 it was considered one of the city's most endangered historic buildings. The facility upgrades include new accessibility features, a renovated gym and dance studio, outdoor space and a remodeled lobby.

The Clarendon Community Center was built in 1916 as a bath

house to serve the Clarendon Municipal Beach. At the time, Lake Michigan's shores abutted the building.

The facility included large mens and womens locker rooms and a promenade. Beachgoers could rent bathing suits, towels and lockers for 10¢ per adult, according to the historical records.

In the 1930s, the city filled in Lake Michigan as it expanded Lincoln Park north to Foster Dr., cutting off the bath house's beachfront access. The city then converted the facility into a community center with gyms, club rooms and sports fields.

A summer reading list

As Lemony Snicket warns us all: "Never trust anyone who has not brought a book with them."

Now that the Independence Day weekend has arrived, it's time to talk summer books to take to the beach.

I am a good reader. Curious. Imaginative. Expansive. A hands-on owner of classic tomes in my parochial youth. I hit my stride for

summer-read books in the fourth grade at Visitation School, when I straddled multiple book clubs, religious and secular.

My parents were generous, letting me subscribe, hoping it was giving me more expansive discipline. I used pop bottle returns to finance this enterprise.

My personal list for all the stories I gobbled up included holy folk who were saints. I always wanted the full story. At the time it gave me a reputation for heavenly reading.

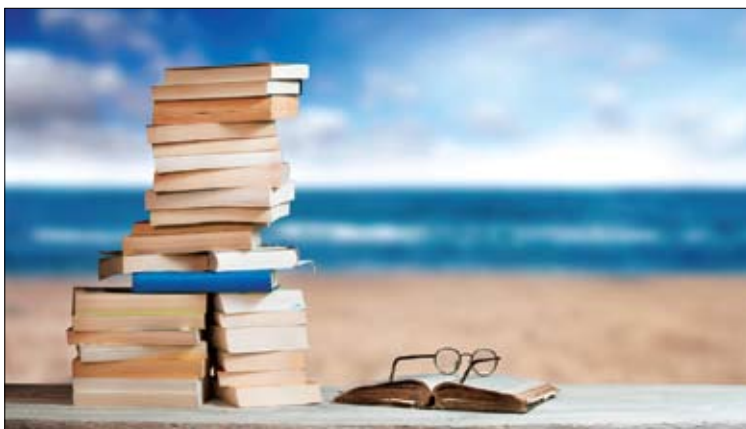
But I needed something more to fill the gaps between miracles and beheadings.

I remember the biography of Will and Charlie Mayo, those young Irish American lads in Minnesota who invented modern medicine. They had a brilliant cache. A book of thrilling tales from their inventive lives. I've never forgotten it. It rivaled the life of St. Dominic for me.

Then there was National Velvet, Robinson Crusoe, and Robin Hood, which wasn't as adventurous or romantic as the Errol Flynn and Olivia de Havilland 1939 film. We only watched the movie 100 times. Which, of course, made us experts on 13th century England. But I read the book. I knew the facts.

Our frequent travels as a family made us budding readers and book experts. Books always went on the journey as a backseat library. We shopped for books everywhere we went. Always taking turns reading out loud to one another in the car.

After a while our dad would be looking for a turn off into some American one-horse town for a quick cold beer. We'd get root

beer floats with our grandmother. And penny candy to energize the rest of the day's journey.

After dinner in some local country hot spot, we'd get ready for bed so we could discover how Huck Finn and Tom Sawyer managed to escape some perilous predicament in Hannibal, Missouri. Once we even drove through Hannibal on our way back to Chicago. What a Mississippi adventure that was for us. Fictions became real before our eyes.

I liked Huck Finn and Tom Sawyer the best back then. Mark Twain remained at the top of our sophisticated reading list. That was something we could brag about in the classroom. Even the Dominican nuns were impressed.

That was the effective and curious formula for acquiring a lifetime of reading. Looking back I'm still excited.

So here is a summer reading for our readers in the hopes of encouraging you in sorting through these timeless summer reads. Four great books to try out. Some big. Some shorter. Some very detailed. Some with big literary brushstrokes. Some brand new. Some vintage.

Four is a good number for the summer.

No one will be surprised that my first recommendation for summer is the fabulous new biography entitled Mark Twain, by Ron Chernow, who was recently in town for the Chicago Humanities Festival. He gives us a deep dive into the mercurial American writer, Twain.

What I like about Chernow's literary work is that it's so enthralling and full, large and ram-

bunctious. Seemingly leaving nothing behind. That's essential for summer reading. It's hefty. And of course Chernow is a good and comfortable writer. He lifts up Samuel Langhorne Clemens, Twain's real name, America's first true literary celebrity. He manages to milk both ease and clarity out of this brilliant human story.

This is no flimsy tribute to a favorite writer. In this work you'll discover something confounding, Twain's coming to life filled with American emotion. Chernow already holds a Pulitzer Prize, so he's A-list. His introduction of the bushy mustached, cantankerous Twain, as the father of American literature, is breathtaking. You'll love all the details of his time from Mississippi steamboats to the ravages of the Civil War. You'll cherish the book's brashness and elaborate Americanism from start to finish. Yes, it's 1200 pages long. Don't let that stop you.

Picasso: An Intimate Portrait, is also a wondrous read, written by the Cubist painter's grandson, Olivier Widmaier Picasso. He made sure he'd gathered the truthful details that fill out the painter's complex, long life (1881-1973). This is a work of grand history for artists.

I've been a student of Pablo Picasso for decades. Searching out the contexts and elaborate emotional life of a foundational modern artist whose efforts redefined the artistry of the 20th century.

A Spanish Roman Catholic living in Paris for most of his life. Redeeming what the artistic eye sees. Too many lovers. Too many painter pals. Too many bullfights. Too much wealth.

But Picasso, the artist, reshapes his artistic vision over time, transforming the aesthetic of the age. It's no accident that the bold muscular politics of Chicago's Mayor Richard J. Daley did not elude Picasso from afar. A devoted communist who never saw America, he was still a modern thinker attracted to the liberating quality of Daley's urban politics. Hence the stunning Picasso sculpture in Daley Plaza, "The Picasso," sometimes called "The Chicago Picasso," which the artist gifted to Chicago more than 50 years ago.

The author is the 60-year-old grandson of a Picasso mistress, Marie-Thérèse Walter, who met the artist when she was just 16 years old, waiting at a Paris bus stop.

Her daughter, Maya Widmaier-Picasso, was Olivier's mother. This work will bring the painter deep into your soul. A worthy summer enterprise at just 320 pages.

To Kill a Mockingbird, the 1960 novel by Harper Lee, is an American classic. A coming of age story set in the American South of the 1930s. Filled with conflicts and human confusion, betrayal at its best in small town America layered thick in moral reasoning. And a true evolving bitter wisdom standing against the cruelty of small towns and small minds.

Lee's heroes lift high the real purpose of life. A must to read and reread. Only 320 pages.

The Catcher in the Rye, a 1945-46 novel by J.D. Salinger, is his only novel. For most of its life it's been controversial. But it's no "White Lotus." Just two days in the life of a 16-year-old boy, Holden Caulfield, expelled from prep school. A wise-cracking story filled with angst and alienation as he searches for life-giving

Chicago ranks among most expensive cities to rent an apartment

65% of population choosing to live in only 35% of city

A new Chicago Rental Market Trends report finds that average rental apartment prices across the city spiked to 19% higher than the national average in May, leaving residents here paying an average of \$3,780 more in housing costs on an annual basis than anywhere else in the country.

Chicago residents everywhere are paying the price for the city's rising rental apartment prices, says Bryce Hill, Illinois Policy Institute (IPI) Director of Fiscal and Economic Research. "The first thing that

comes to mind to explain why housing is so expensive in Chicago is property taxes.

Those are costs that are borne not only by homeowners who occupy their own homes but also by renters."

Multifamily units in Chicago were priced in the neighborhood of \$1,939 in May compared to \$1,639 across the country, or up by nearly 4% over the same time last year. Hill argued that the area's bad fiscal policies spur much of the city's stagnant population along with being largely responsible for population levels now being lower than they were more than a century ago.

"Part of the reason why people are flee-

ing the city, whether they be for other suburbs within Illinois or other states entirely, is because housing costs are so out of control," he said.

"In addition, the services that taxpayers get in return for their high taxes is oftentimes not bearing out when taxpayers think of whether or not the services they receive are worth what they're paying."

Data shows rents across the city jumping 41% over the past decade, including by 6.2% over the first six months of 2024 alone, to an average of \$2,200 a month. Apartments.com reported the average resident now needs to earn almost \$78,000 an-

nually in order to afford an average apartment.

IPI analysis also found nearly half of all city renters now pay nearly a third of their income for shelter, including almost 90% of the city's low-income residents, easily exceeding the federal limit for affordability.

Hill explained what he feels needs to happen. "The city could reevaluate needs," he said. "Do we need to actually pursue the full property tax levy increase or is there room to offer not necessarily relief but to

How technology changed the Cook County Treasurer's Office

When I became Cook County Treasurer in 1998, I walked into an office stuck in the past. Boxes containing \$30,000,000 of uncashed checks lined the floor, collecting dust rather than earning interest. Just four working computers and six typewriters served a staff of hundreds.

It was a wake-up call. But I knew I was where I was meant to be. You see, I've always believed in shaking things up—so that's what I set out to do.

My first interest was the "lack of interest" those boxes of checks were earning for the county. I immediately implemented a lockbox system to quickly deposit checks. That nearly tripled interest earnings in my first year.

Next, we replaced paper-only processes with a computerized network to handle

collections, refunds, deposits, distributions, and more. Automating made deposits instantaneous so interest could accrue in real-time.

Those innovations helped boost the bottom line even further allowing me to phase out 5 satellite offices and ultimately reduce the payroll from 250 to about 60.

We didn't stop there.

We set up our website cook-countytreasurer.com which now serves as a 24/7 portal to office services. Last year alone, the site was visited more than 6.5 million times and since opening, it has been visited more than 100 million times. It's where taxpayers can

search for unclaimed refunds and check for missing exemptions in over 200 languages, helping ensure equity and inclusion in every neighborhood and town.

In 2002, Cook became one of the first counties in the country to offer online prop-

erty tax payments. We created a system for direct bank transfers that was secure and easy to use. Today, more than 850,000 taxpayers pay online each year. If you pay from your bank account, it's free.

In the 2010's we began to allow payments on smart phones and other mobile devices. Since 2017, there have been more than 12 million website visits from mobile users.

Also, in 2017 we began offering taxpayers the option to download their bills. More than 7 million tax bills have been electronically downloaded since that functionality was introduced.

In 2018 we began offering automatic refunds for overpayments. Since then, we've issued 175,000 refunds totaling more than \$150 million. And we're holding more of

your money. Currently, \$122 million in overpayments and more than \$33 million in exemption refunds are available from the Treasurer's Office. Log on today to see if you're owed money.

We've always believed good government works for the people. That's why, for more than 25 years, we've made it our mission to simplify the tax system, embrace innovation, and give taxpayers user-friendly tools.

We collect over \$18 billion in property taxes each year to fund schools, emergency services, and more than 2000 local government units. Those taxes, paid by the owners of nearly 1.8 million Cook County proper-

Anti-Jewish hate spiked by 58% last year in Chicago

Call for public hearings on Antisemitism

Ald. Debra Silverstein [50th] recently introduced a resolution to City Council aimed at addressing the rising threat of antisemitism in Chicago.

According to the police, while hate crimes in general have been decreasing, anti-Jewish hate spiked by 58% last year. Jewish residents make up only about 3% of Chicago's population, but in 2024, they were the targets of nearly 38% of all reported hate crimes in the city.

More than one-third of every hate crime reported in the City of Chicago targeted the Jewish community. This reality is obviously untenable and requires immediate action.

My resolution, which gained the support of a majority of the City Council, calls on the Chicago Commission on Human Relations [CCHR] to hold public hearings on the alarming rise of antisemitism and radi-

calization across the city. It authorizes the commission to hear testimony from victims, community leaders, and expert witnesses, and it asks CCHR to issue a public report with recommendations on how to protect Chicago's Jewish community.

Antisemitism is at crisis levels in the United States, with notable and horrific incidents happening across the nation, including the hate crime shooting of an Orthodox Jewish man who was walking to synagogue in our own neighborhood last year, the recent murder of two Israeli embassy staffers outside the Capital Jewish Museum in Washington, DC, an arson attack at the Pennsylvania Governor's residence, and the firebombing attack of a hostage rally in Boulder, CO.

We need Mayor Brandon Johnson to get behind this resolution and to offer the full support of the city government in addressing the crisis of anti-Jewish hate in Chicago. Empty words and symbolic gestures are not enough. We need real leadership and real solutions so every Chicagoan, no matter their faith or background, can live without fear.

This isn't city planning, it's surrender

Tom O'Gorman was right [June 18]: City streets are a mess of conflicting uses, unchecked speeds, and reckless planning.

Wells St., once the hallmark of a walkable neighborhood, now feels like a video game—beer trucks blocking curbs, scooters flying through stop signs, Ubers swerving around double-parked vans. Over on Eugenie St., a child or elder has to navigate traffic like a stunt actor just to cross the road.

Cyclists fly through red lights. Our sidewalks aren't sidewalks anymore — they're obstacle courses, delivery zones, and bike lanes all at once. Lime scooters left anywhere the rider stops - in the middle of the sidewalk usually. Enforcement? Non-existent.

Into this mess, the City has approved

a 349-unit luxury tower with no plan for where hundreds of new bikes, cars, and trucks will go.

Tom, let's ride Wells together on a Monday morning. Let's count the near misses. Let's ask: is this livable? Is this safe?

This isn't planning—it's surrender. Our streets have become a test site for what happens when developers run the table. The public was promised a future of smart growth. What we got was congestion, chaos, and zero accountability.

This isn't just traffic—it's failure. And it's time to say so. Wonder if the fix is in for this deal.

The hidden cost of Fern Hill's Tower

As longtime residents, directly facing the LaSalle and Eugenie intersection, we must speak out about the serious traffic risks in the proposed Fern Hill development. The block-long building will force heavy traffic onto an already congested block including the busy corner of Eugenie and LaSalle.

The Fern Hill Tower site has only one access point on the west side of N. LaSalle, just a few yards from the very busy North Ave. and LaSalle intersection. Their U-shaped driveway will funnel commercial delivery and service trucks, ride shares, food delivery vehicles, and hundreds of resident and guest vehicles to access the 36-story tower and parking lot. There is a median strip along the 1600 block of N. LaSalle to prohibit traffic heading north on LaSalle to cross over onto the southbound lanes. Consequently, with the driveway positioned on the 1600 block on the west side of LaSalle, much of the traffic will have to go around the block - North Ave., then north on Wells to Eugenie- in order to access southbound LaSalle.

Car and truck traffic already routinely double-park and idle to serve the Eugenie Square townhomes. This is a neighborhood street, not a main thoroughfare. Current traffic at the congested corner of Eugenie and LaSalle brings noise from motorcycles, emergency vehicles, trucks and cars; adding hundreds more vehicles would overwhelm this intersection.

We were told by the developer's paid traffic-study surveyor that the Fern Hill

study was conducted on a random weekday in September, likely in 2023. The entire study was never released. Chances are there was no thought given to the multiple events staged in and around Old Town and Lincoln Park throughout the year. The study was adopted by the Chicago Dept. of Transportation [CDOT].

The "traffic fixes" proposed by Fern Hill and supported by CDOT that attempt to force-fit a private high-rise onto a site far too small to handle it means public safety, pedestrian access, and neighborhood livability are being sacrificed. It also means the likely elimination of the LaSalle-Eugenie-North corridor bus stop that serves hundreds of people from Old Town and Lincoln Park neighborhoods. Locals and visitors both depend on this stop daily.

This isn't responsible planning. It's private profit, overwhelming public infrastructure. While Fern Hill's investment partners collect private rents, Old Town residents lose transit, clean air, sunlight, pedestrian safety, and neighborhood stability.

This tower is simply too big for this site. The harm falls on the public while the financial gains go to private developers. We urge Ald. Hopkins, CDOT, and City Council to stop sacrificing public safety and public transit for private development.

Grant Park softball run over by NASCAR for third straight year

For the third year in a row, the NASCAR race has run over Chicago's beloved game, 16-inch slow pitch softball in Grant Park.

Once the biggest 16-inch slow-pitch league in the Windy City, the game at Grant Park appears to be forever threatened, cast into the wind as a forgotten memory, softball devotees say.

The NASCAR Chicago Street Race is scheduled to return July 5 and 6. The city began closing streets and erecting stands 18 days before the race weekend.

Closures include major roads like Lake Shore Dr., Michigan Ave., Roosevelt Rd., and Columbus Dr.—forming a loop around Grant Park. All streets are scheduled for reopening on July 14.

A recent 90-plus degree heat wave caused parts of the race-track pavement to heave, almost like a message from hell.

This year, the "Bad Apples," a coed team that has played in Grant Park since 1980, were told that their season will be compressed into six weeks and each of the nine teams in Chicago Advertising Coed Softball League [CACSL] will be required to play double headers.

"Our Tuesday night games will be played at 6 p.m. and 7 p.m. each week to squeeze our season into a total of six weeks," said Juan Correa, commissioner of the league. With playoffs, each team will play 13 games.

After a month off for NASCAR and other events, the teams will be required to move to Waveland Park on Saturday July 26 for the CACSL's one-day championship tournament, Correa said.

Grant Park coed league game times will be restricted to a one-hour limit, and a one-and-one ball-strike rule will be enforced. For the second game of the doubleheader, action will continue until sunset.

In addition to the Bad Apples, the league includes the following teams: Energy BBDO, Fleishman Hillard, Publicis Group, KSM, Cramer-Krasselt, Foot Cone & Belding. OMD, and Clune Construction.

Other teams, including the Chicago Sports & Social Club 16-inch softball co-ed league at Grant Park, also was hit with the same mandatory doubleheader schedule.

Old school 16-inch softball players like 63-year-old Correa say they hate the changes. "Bad Apples once were like the Yankees. We won four of five of the last ad league championships," he said. A few years ago, 32 teams once competed in ad league. The government-imposed closing of public parks for the pandemic decimated softball leagues, many of which may never recover.

However, apparently the young

co-ed teams embrace the changes. "All they care about is the post-game partying and deciding what downtown saloon they want to visit for hook-ups," Correa said. "For some young players, game attire is Crocs and pajama bottoms."

For decades, up to 350 corporate, industrial and saloon teams competed in leagues at Grant Park, generally known as the hub of Windy City softball. However, downtown softball at Grant Park took a turn for the worse after the tragedy of 9/11.

Metered parking along Columbus Dr. near the fields was removed for security reasons. Players were forced to park five blocks away and walk to the fields, or cab it.

"NASCAR, public entertainment events, and the Chicago Park District have killed 16-inch softball in the Windy City," said Ron Roenigk, publisher of this newspaper, and retired player-

manager of the "Inside Dirt" coed team which participated in the Media Softball League at Grant Park, Lincoln Park, and Waveland Park.

"There are so many profit-making 'close-off-the-park-to-non-payer' events in Grant Park now that tax-paying Chicagoans have basically lost their recreational front yard for the better part of the summer. It really is a scandal," said Roenigk.

"Most Chicagoans don't have any concept of how much public-park real estate the Park District has leased out to private companies involved in profit-making ventures," Roenigk said.

"The social clubs lock-up diamond permits early in the season, and that action just reduces the days and times available for traditional Park District softball leagues which are rapidly disappearing," Roenigk said.

Chicago man steals fire chief's marked SUV for joyride, skips court

Cops arrested a man after he allegedly stole a Chicago Fire Dept. (CFD) battalion chief's fully-marked SUV from a firehouse near the Magnificent Mile and went on a joyride to Edgewater.

Aaron Johnson, 49, was arrested on April 1 but went home from the police station that evening with instructions to appear in court a week later. He was recently re-arrested on an

active warrant issued after he failed to show up for that court date.

The incident began when the chief of Battalion 1 parked the unmistakable CFD SUV in front of Station 98 at 202 E. Chicago Ave. around 8:20 a.m. Minutes later, the vehicle was gone, prompting a swift response from police—and the battalion chief—after the SUV's GPS began pinging in near Glenwood and Farwell avenues on the North Side, according to a CPD report.

The battalion chief personally located the SUV parked in the 1400 block of W. Lunt, in Rogers Park, with Johnson behind the wheel. Police said Johnson turned off the vehicle and surrendered the keys when the chief requested them. Officers arrived shortly after and confronted Johnson, who allegedly told them he was "having fun."

CPD surveillance footage captured a man resembling Johnson entering the SUV outside the firehouse and driving away, the report noted.

An officer wrote in the arrest report that possession of a stolen motor vehicle is a "non-detainable felony" under the SAFE-T Act, so police released Johnson that evening with instructions to appear in court on April 8. He failed to appear, court records show, resulting in an arrest warrant and his recent re-arrest. He has been rereleased to await trial.

Two men sexually assault woman in Lakeview alley

Two men sexually assaulted a 26-year-old woman in a Lakeview alley on Sunday night, Chicago police said. The assailants remain at large.

According to police, the woman was sitting in an alley behind the 3800 block of N. Wilton when a vehicle carrying two women and at least two men approached around 10:45 p.m. June 29. Two men exited the car and physically attacked her.

The assailants tore off the woman's clothing and sexually assaulted her before fleeing in the vehicle.

Investigators recovered some of the victim's clothing from atop a garage, according to an officer at the scene. Other pieces of her clothing were scattered throughout the alley.

CPD has not released descriptions of the attackers.

Man stabbed to death in domestic altercation at Navy Pier beer garden

A man was stabbed to death at the Navy Pier beer garden on June 29 in what Chicago police described as a "domestic altercation." A suspect, who also sustained a laceration during the incident, is in custody.

Police said the now-deceased man, 56, became involved in a verbal altercation with a 64-year-old man at the beer garden around 5:30 p.m. The argument turned physical when the older man pulled out a "sharp object" and stabbed the victim multiple times, according to a CPD media statement.

The victim suffered cuts throughout his body and was pronounced dead at Northwestern Memorial Hospital. Officers arrested the older man on the pier. He was taken to Northwestern in serious condition, according to CPD.

An internal CPD message shared with this reporter described the stabbing as a "domestic altercation."

Threshold crossed for Opioid overdoses in one day

On Saturday, June 21, there was a spike in opioid overdoses in Chicago. The Chicago Dept. of Public Health noted 37 opioid-overdose related EMS responses on a single day.

A landmark 2015 law in Illinois addressed opioid abuse and its illegal use. According to 720 ILCS 570/414 Sec. 414, an "overdose" on any of the 12 state-listed drugs means a controlled substance-induced physiological event that results in a life-threatening emergency to the individual who ingested, inhaled, injected or otherwise bodily absorbed a controlled, counterfeit, or look-alike substance or a controlled substance analog.

CDPH has urged partner organizations and emergency responders to stay alert in the wake of warmer temperatures, call 911 and administer naloxone or Narcan to individuals who may be overdosing, and consider immediate initiation of medications for opioid use disorder for patients whose overdoses were reversed before discharge from the ED or hospital.

Illinois law offers limited legal protections for people who act in good faith while seeking emergency medical help for an overdose. The Illinois' immediate opioid treatment helpline and can be accessed by calling 833-234-6343 or texting "HELP" to 833234.

Armed carjackings reported in West Loop, West Rogers Park

Chicago police are investigating two armed carjackings that occurred within hours of each other on June 25, one in the West Loop and the other in West Rogers Park.

In the first incident, a 50-year-old man was carjacked at gunpoint by two men in the 2100 block of W. Arthur around 7:39 p.m., according to a Chicago police spokesperson. They said the victim was standing near his 2017 Hyundai Accent when two men approached him, one displayed a firearm, and they forcibly took control of his vehicle. No detailed description of the suspects was provided in this case.

Later, around 12:20 a.m. June 26, a second carjacking occurred near Halsted and Hubbard streets. The victim confronted two masked men

who were inside his vehicle near the intersection of Halsted and Hubbard streets. Both suspects pointed rifles at him, took control of the car, and drove away. Police later located the stolen vehicle, unoccupied, in the 2600 block of W. Monroe.

Wave of daytime car break-ins hits lakefront

Chicago police are warning residents after a string of daytime vehicle break-ins and vandalism targeting parked cars was reported Wednesday along the lakefront in Uptown, Lincoln Park, and Lake View.

CPD said an unidentified burglar or burglars used an object to shatter side windows to gain access to the vehicles and steal property. The break-ins occurred at the following locations: 5100 block of N. Simonds Dr. between 11:47 and 12:47 p.m.; 2700 block of N. Cannon Dr. between 2:05 and 2:49 p.m.; 200 block of W. Montrose Harbor Dr. between 12 and 3 p.m.; 200 block of W. Montrose Harbor Dr. between 12 and 5 p.m.; 200 block of W. Montrose Harbor Dr. between 12 and 4:10 p.m.; 200 block of W. Montrose Harbor Dr. between 12 and 9 p.m., and on the 3600 block of N. Recreation Dr. at 6:20 p.m.

Police advised residents to avoid leaving valuables in vehicles and asked people to report suspicious activity immediately. Pritzker stalker gets probation for throwing stones at governor's Gold Coast mansion

The man accused of stalking Gov. JB Pritzker and throwing rocks at the billionaire's Gold Coast mansion received a probation sentence on June 25, court records show.

Adam Dabash pleaded guilty to felony criminal damage to property in a plea deal that led prosecutors to drop three other felony charges, including two counts of stalking.

Surveillance footage from Oct. 7, 2024, allegedly captured Dabash walking outside Pritzker's home in the 1400 block of N. Astor around 9:45 a.m., stopping twice to hurl baseball-sized rocks at the mansion's windows. He briefly left the scene before returning to throw another rock.

Three windows were damaged, with one rock found inside the governor's mansion and two others found outside. The damage to the governor's property was estimated at \$7,900. Pritzker and several others were inside the residence at the time of the rock-throwing, but no injuries were reported.

Investigators also linked Dabash to earlier incidents on Aug. 26 and Aug. 28, 2024, when he allegedly tossed notes over the governor's fence. Surveillance video from both days showed his face, and his name was written on the notes, though officials did not disclose their contents.

Following his arrest, Dabash allegedly damaged a mattress in his police holding cell and told officers that Illinois has a "m***** f***** for a governor."

Cook County Judge Michael Hood sentenced Dabash to two years of mental health probation and ordered him to comply with several conditions, including submitting DNA to a law enforcement database and undergoing random drug testing. Additionally, Hood issued a stalking no-contact order and a plenary order of protection to keep Dabash away from Pritzker.

Dabash has been on electronic monitoring since charges were filed in October. Hood ordered the ankle

monitor removed during Wednesday's court session.

Chicago man charged with attempted murder in brutal Edgewater alley attack

A 49-year-old man has been charged in connection with a violent attack in an Edgewater alley that left a 36-year-old man critically injured, Chicago police announced. Roosevelt McCree, of the 600 block of W. Elm St., was arrested June 21 in Edgewater, CPD said.

The attack occurred shortly after 10 p.m. Thursday, June 19, in the 5800 block of N. Kenmore Ave. A 911 caller reported hearing screams, including a threat of "I'm going to kill you," followed by the sound of a motorcycle speeding away. A passerby discovered the victim in the alley, initially believing he had been shot, and called for an ambulance.

Medical personnel determined the victim had been beaten in the head with a blunt object. He was rushed to St. Francis Hospital in critical condition and remained unidentified as of early Friday.

McCree is set to appear for a detention hearing at the Leighton Criminal Courthouse on Tuesday afternoon, where additional details about the allegations are expected to be disclosed. He faces charges of attempted first-degree murder and aggravated battery causing great bodily harm.

Man attacked 3 women in Lakeview and the Loop

State and federal prosecutors have charged a Chicago man with attacking three women within hours on June 24, one each in Lakeview and two in the Loop.

Joshua Rowell, 36, has been convicted of "multiple felonies for domestic battery," a Cook County prosecutor said during a detention hearing on Thursday.

That first attack on June 24 involved a woman walking her dog near her home in the 600 block of W. Waveland. The victim told police she saw Rowell walking toward her, so she stepped into the grass to give him room to pass by.

Rowell suddenly punched her in the head with his fist, causing her to drop her dog's leash and fall to the ground, prosecutors said in a detention petition. As the victim tried to shield her face with her arms, Rowell allegedly continued to strike her multiple times in the head and face, with video evidence showing at least nine blows while she was down.

The victim screamed for help, drawing the attention of two witnesses who saw Rowell attacking the woman while she was down, prosecutors said. He fled the scene after yelling at one witness that she would "be next," according to the petition.

One of the witnesses told police that the victim was bleeding so profusely, she thought the woman had been stabbed. EMS transported the victim to Advocate Illinois Masonic Medical Center, where she received stitches under her eye and was treated for a displaced right nasal bone fracture. Detectives circulated a "seeking to identify" alert across the department.

Then, shortly before 4 p.m., a federal court law clerk was attacked as she stood outside the Dirksen Federal Building in the Loop. According to a federal criminal complaint, Rowell approached the victim from behind and punched her in the left side of her face, causing her to stumble into Jackson Blvd. The victim, who was

working in her official capacity, suffered a concussion and was treated at a local hospital.

About 20 minutes later, a 20-year-old woman told Chicago police that a man punched her in the face as she walked in the 900 block of S. Wabash. She was treated at Insight Hospital.

Patrol officers stopped Rowell near the Roosevelt CTA station because he matched the description provided by the third victim, a CPD report said. Investigators quickly linked him to the Lakeview case through the "seeking to identify" bulletin.

Cook County prosecutors charged him with aggravated battery causing great bodily harm, aggravated battery in a public place, and, because he was allegedly carrying a single 9mm bullet, possession of ammunition.

Federal prosecutors charged him with assault of a federal employee.

Court records show he received two 5-year sentences for domestic battery in 2021. His previous felony convictions include possessing a controlled substance in 2018 and possessing a stolen motor vehicle in 2014, according to court files.

Shoplifter admitted he 'stabbed the **** out of' grocery store manager

A 61-year-old man accused of stabbing a grocery store manager in Edgewater allegedly admitted

to police that he "stabbed the [expletive] out of" the victim.

The incident occurred at the Aldi located at 6221 N. Broadway shortly after 2 p.m. June 14.

Prosecutors said John Brown stabbed the store's 41-year-old assistant manager in the thigh during an attempted shoplifting and fled the scene. Cops responded to the Granville Red Line CTA station to search for the suspect and found Brown running along the platform with a knife or tool in his hand, according to a Chicago Police Dept. report.

Brown then jumped onto the train tracks and fled south, dropping an object into the Whole Foods parking lot below as officers closed in, the report stated. Police arrested Brown and recovered the knife.

During the arrest, Brown allegedly shouted, "I stabbed the [expletive] out of him. He put his hands on me. I stabbed the [expletive] out of him," and made multiple statements to police admitting to the stabbing.

Brown has been uncooperative with authorities, according to court records. He refused to provide his name to police, declined fingerprinting, and repeatedly refused to appear in court. He is now acting as his own attorney.

Prosecutors charged Brown with armed robbery, robbery, aggravated battery causing great bodily harm, and aggravated battery of a merchant.

Couple robbed, carjacked at gunpoint in Lakeview

A couple was robbed and carjacked at gunpoint June 24 near Boystown, Chicago police said.

The victims, a 23-year-old woman and a 25-year-old man, were walking in the 700 block of W. Barry when they were approached by four men around 3:25 a.m., according to a CPD spokesperson.

One of the men brandished a firearm and demanded the couple's valuables and car keys. The victims complied, handing over their belongings and the keys to their black Mercedes-Benz sedan, police said.

City canceled Pride North; Police closed The Glenwood bar over expired state liquor license

Ald. Maria Hadden [49th] disclosed the unpleasant news Friday evening that the popular Pride North event in Rogers Park was cancelled by City officials over special event permit requirements.

Hadden posted a community notice online around 4:30 p.m. June 27 announcing the Pride North event would not be happening. "The organizer didn't secure their permits in time. There will be no outdoor festival on the street."

Pride North is organized by Colm Treacy, owner of The Glenwood bar, 6962 N. Glenwood Ave., and the adjacent GW Martini Bar, 6958 N. Glenwood Ave.

This newspaper learned that the Chicago Police Dept. [CPD] 024th District conducted a premise check on the Glenwood Bar on Saturday night and found it lacking a valid State of Illinois "On-Premises Consumption" [liquor] license and shut the premise down.

The State of Illinois Liquor Control Commission website shows the state liquor license for The Glenwood expired on May 31, 2025. It further revealed that Colm Treacy is the 100% owner.

Online social media postings about the Pride North cancellation carried comments on the lack of a valid license for The Glenwood

before police closed the bar.

Treacy declined an offer from this newspaper for a comment on the cancellation of the event by city officials.

Hadden updated her initial statement hours after her initial notice after some comments blamed her for canceling the event. "I didn't deny the permit. CPD and the City did because the organizer failed to complete his application. My office worked to support him in doing so but he was unable to do so. It's a shame. This is also

why people aren't supposed to advertise events before they've secured a permit."

Hadden released her statement Saturday which expounded on the event cancellation. "To give you some background on what happened - the special event process is highly regulated and Aldermanic sign off is only one level of approval required. The organizer of this event has needed support correcting and completing their application every year that I've been in office. And I've been happy to help because this is an important community event."

Hadden explained that city departments were especially concerned this year given the rise in hate crimes, and the City met with the organizer, Treacy, multiple times.

"This week, after [The Glen-

wood] failed to make the required corrections and changes to complete their application, the City denied the permit."

Hadden said she took it upon herself to make the public notice of cancellation because Treacy had failed to do so despite knowing for several weeks about issues with the Pride North permit process.

The Pride North event had faced unwelcome scrutiny in the past. In 2021, festival employees at the admission gate at Morse and Glenwood instituted a mandatory \$20 admission fee for the "free" event. Such city street festivals may only request a donation from visitors but may not demand payment for entry.

After receiving a number of complaints, Ald. Hadden personally visited Pride North to tell festival staff they could not charge a fee and restrict access. She said the organizers had no right to institute a mandatory fee.

Hadden said at the time that future Pride North events would face further scrutiny.

Treacy said he didn't know why the mandatory entrance fee was instituted by his employees despite \$20 admission signs posted at the entry gate. Treacy said at the time that Hadden's complaint was the only one he received and that the alderman was fanning the flames.

Rogue curbside car sellers beware

Chicago has enacted legislation to address "curbstoning," which is the practice of selling cars without a dealer's license on public streets. The city says that this practice can occupy residential parking spots and allow unlicensed sellers to bypass consumer protection regulations, potentially leading to fraudulent sales.

The new ordinance expands police authority allowing them to ticket, fine and immediately tow vehicles left on public roadways without a valid license plate matching the vehicle.

The ordinance prohibits parking a vehicle on a public roadway solely for the purpose of displaying it for sale. This applies even if the vehicle lacks a license plates, provided its make, model, and color match an advertised "for sale by owner" vehicle.

With this new law the city hopes to address the issue of unregistered vehicles taking up parking spots.

The State of Illinois limits unlicensed private sellers to selling a maximum of four cars per year. Selling five or more used vehicles in a year requires a dealer license. Curbstoning often involves individuals or entities operating as unlicensed dealers who exceed this limit and evade regulations designed to protect consumers.

Softball was invented in Chicago in 1887, and the first indoor game was played at the Farragut Boat Club at Lake Park Ave. and 31st Street, only a couple of miles from Grant Park, noted softball historian and umpire Larry Comstock, who played on the historic Chicago Sun-Times Hall of Fame team, inducted in 2008.

"Softball was invented in Chicago, and we're killing it for NASCAR—something invented in North Carolina," Roenigk said. "We've rejected our own child."

"Chicago's game once was played in every park and gravel school yard across the city," recalled Robert Egan, a Chicago Sun-Times player and manager whose team was a five-time champion at the park in the elite Mike Royko Softball Tournament between 2001 and 2009.

At the neighborhood level, serious and skilled blue-collar saloon teams flocked to corner taverns after the game for camaraderie—

the life blood of softball, Egan noted.

"Softball was good for neighborhood businesses, pumping tens of thousands of tax dollars into the city. Now, virtually all of the very competitive neighborhood leagues are dead and the bars are closing. It's a very sad turn of events," Egan lamented.

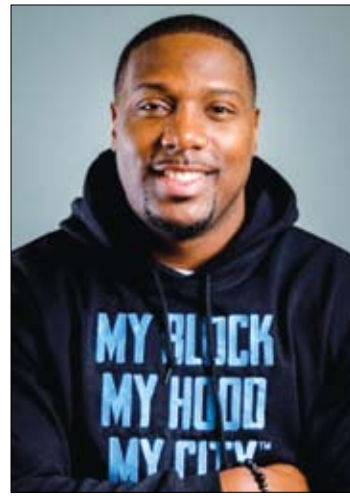

Chicago bids adieu to Sister Rosemary Connelly

Pope, Cardinal, clergy and commoners pay tribute

Chicago bid a fond farewell on June 24 to Sister Rosemary Connelly, RSM, 94, the longtime head of Misericordia Heart of Mercy home located at 6300 N. Ridge Ave. in the West Ridge community.

The morning service for Sister Connelly was officiated at Chicago's Holy Name Cathedral by Cardinal Blase J. Cupich. Fourteen concelebrants included Bishop George Rassas, Monsignors Mike Boland and Ken Velo, and Fr. Michael Pflieger. Fr. Jack Clair, the current executive director of Misericordia was also a concelebrant and gave the homily.

The concelebrants all wore vestments bearing the distinctive Misericordia Heart of Mercy on their stoles. (Misericordia means

"mercy" or "compassion" in Latin.)

Cardinal Cupich delivered a message from the Pope. "His holiness, Pope Leo XIV was saddened to hear of the death of Sister Rosemary, and sends prayerful condolences to you, as well as the members of the Misericordia community."

His Eminence delivered his own statement: "... Sister Rosemary gave proof to the principle that every person is created in God's image and worthy of respect and dignity. A fearless pioneer in making that core value real in the lives of the people she served and their families, she created innovative programs and gathered the resources to bring them to life...."

The 13 pallbearers included 10 nephews of Sister Connelly. The sanctuary was nearly full of

people paying respect, as musical selections included, "Somewhere Over The Rainbow," "Wind in the Willows," and "Lady of Knock" by musicians led by the Holy Name Cathedral Director of Music, David Jonies.

The Shannon Rovers Pipe Band were present to perform "Amazing Grace" and "Oh When The Saints Go Marching In" to the assembled guests as the casket was carried from the cathedral as Cardinal Cupich looked on.

As the Donnellan Family Funeral hearse pulled away under police escort, the cathedral's bells began to peal sonorously.

Dignitaries included Illinois Secretary of State Alexi Giannoulias, former Mayor Richard M. Daley, and former Ald. Tom Tunney [44th].

In 1976, Sister Connelly, 39 children and 35 dedicated staff members moved to the former

site of Angel Guardian Orphanage – the present site of Misericordia. On the way she made sure the bus stopped at Lincoln Park Zoo so the children could visit the animals.

Today, Misericordia serves more than 600 children and adults with intellectual and developmental disabilities – some of whom operate their own restaurant, the Greenhouse Inn, and a bakery, The Hearts and Flour Bakery, giving meaningful jobs to residents.

"She looked like a sweet, white-haired nun until you realized she was made of structural steel," said Carol Marin, the legendary Chicago newscaster, columnist and a Misericordia parent.

"When you think of the number of lives she touched – thousands," political strategist Davis Axelrod told the Sun-Times. "Not just the folks who lived at Misericordia but their families. It changed my daughter's life, and it changed my whole family's life for the better. This whole place exists because of the force of her will."

Sister Connelly was awarded the Univ. of Notre Dame's 2023 Laetare Medal, considered the oldest and most prestigious honor

given to an American Catholic. She also received numerous honorary degrees, awards and honors throughout her life.

She died of natural causes on June 19 at her home on Miseri-

cordia's West Ridge campus after being in hospice care.

She was celebrated on June 25 by the Sisters of Mercy in a special private service before she was laid to rest.

limit the growth? Another area to start would be to pursue pension reform."

Both Mayor Lori Lightfoot and Rahm Emanuel, mayors prior to Brandon Johnson, advocated for statewide constitutional pension reform. "A big part of that is because all the increase in the city's property tax levy is going to pay for unfunded pension liabilities. It's not going to pay for the continuation of services or new services or facilities, virtually all of that is going to pay towards the state's unfunded pension liabilities," said Hill

Another big part of the problem is that 65% of the city's population is choosing to live in only 35% of the city's space, located mostly on the North and Northwest sides.

But for a few popular communities like the South Loop, Hyde Park, Beverly and Mt. Greenwood, vast stretches of the city's West, Southwest, South and Southeast sides are not up for consideration by those Chicagoans who have the option to choose.

The trouble some communities have attracting new residents are equal parts cultural, criminal, economics and educational, and the city's responses to those systemic problems has disproportionately impacted the West and South Sides, while conversely driving development into more affluent areas.

The rental market for those

who can choose their community, see them choosing to avoid the West and South Sides. And the city's unwillingness to deal with the real problems plaguing those communities results in the current unequal housing development.

Strong consumer demand for housing on the North and Northwest sides is a big part of the reason why the city has dramatically increased zoning density on long stretches of N. Western Ave. and soon too on Broadway. Whereas the West and South Sides suffer from historic underinvestment and high levels of vacancy, due in part to the lack of consumer demand that is reinforced by limited construction and unequal housing development patterns.

If new residents coming to Chicago chose to live in those areas, then builders would be building there to meet the demand. But the demand is not there. For decades families have fled those neighborhoods seeking better educational and economic options. Conversely, the downtown area, Near North and Northwest sides, and lately the Near West Side have seen population increases.

Concerns about the quality of life, education, safety, and the availability of jobs and resources has lead many families to choose the suburbs, out of state, or to other parts of the city with better options. These perceptions about quality of life are a significant problem, and play a large role in peoples' decisions about where to

live.

The end result is that the West and South Sides contribute to the lack of affordable housing in Chicago through the internal challenges that limit development. The confluence of systemic political, cultural, educational and economic issues create market forces that today push development into wealthier areas, because that 35% of the city is where people are choosing to live.

On the North and Northwest sides, the housing market is very competitive, with strong demand and homes selling quickly, often receiving multiple offers. These neighborhoods are also considered among the safest in Chicago, while offering a mix of historical and modern architecture, diverse dining options, educational and economic opportunity, and cultural attractions.

The ruling established that audit deliverables such as working trial balances, journal entries, and income tax allocations are part of an association's "books and records" and must be disclosed to owners under Chicago's Condominium Ordinance.

Perhaps most alarming is Novak's assertion that some associations deliberately manipulate reserve studies to obscure future liabilities.

"What they're doing, they're kicking the can down the road," Novak explained. "They're not letting owners know about their wave of reserves. The next time the reserve gets updated, it's going to cause a very big assessment increase shock to the homeowners"

A forensic audit of 175 East Delaware revealed that the management firm Sudler Property Management self-awarded nearly \$450,000 in unauthorized raises and bonuses—without board approval. "It just shows how they have control of the entire situation," Novak said. "They're running the show, not the board."

noon in the mayor's fifth floor press room at City Hall, where he was due to make a special announcement to World Business Chicago.

The mayoral motorcade enables Johnson to evade traffic restrictions imposed upon ordinary city motorists. Indeed, this day in Andersonville, some of the Mayor's vehicles were parked illegally in blocking a bike lane.

In 2024, Illinois Policy reported Mayor Johnson's police drivers accumulated numerous tickets including 14 moving violations for speeding or running red lights.

Johnson had more violations in less than his first year in office than former mayors Lori Lightfoot and Rahm Emanuel accumulated in their respective four-year terms, according to CWB Chicago. They counted 21 total tickets to Johnson's drivers as of Dec. 20, 2024, plus city seizure orders for two of the mayor's four city-owned vehicles for failing to pay tickets.

When former mayor Emanuel's motorcades accumulated a bevy of red light and speeding tickets, he paid them himself.

However, Johnson still expects you to pay your tickets.

The financial discrepancies extend to tax filings. In a June 24 letter to Gov. J.B. Pritzker, Novak cited cases of federal income tax evasion totaling over \$500,000 across multiple associations. "They only paid \$50,000 in federal taxes," Novak said. "They're way short—you know, they owe at least another \$542,000."

In his letter, Novak said he first wrote to Pritzker in 2019, urging him to act "on the chronic lack of oversight affecting Illinois' 18,750 unregulated community associations, which serve nearly 30% of the state's population."

"My experience at the State Parkway Condominium Assoc. and with numerous other Illinois associations revealed pervasive issues, including federal and state tax evasion, financial statement and reserve study fraud, budget manipulation, and proxy and declaration fraud, among others."

Novak says that these problems are not isolated. "They are systemic, impacting countless homeowners—especially the elderly and disabled—at risk of financial hardship and housing insecurity."

Novak has referred five CPAs to the Illinois Dept. of Financial and Professional Regulation for misconduct, including for understating taxable income by \$1.9 mil-

Chicago's 2024 budget was dependent upon \$348 million from fines and fees such as speeding tickets. When introducing his budget, Johnson noted that fines fall hardest on low-income families.

lion, failing to complete audits for nearly a decade, and creating self-review threats in violation of independence standards.

Since then he has worked with the state's auditors to develop programs that identify which community associations should be audited. Those five CPAs, who serve clients on a significant portion of the Chicago

Lakefront, were reported to the Illinois Dept. of Financial and Professional Regulation for professional misconduct. "My recent collaboration with the Nevada Real Estate Division has reinforced my belief that Illinois urgently needs similar reforms, including robust oversight and transparent financial practices," he said.

But despite the evidence, Novak says regulatory action has stalled in Illinois.

"When the governor announced that he plans to seek a third term, I thought the timing was right to mail a letter to him," Novak said. His letter urged revival of the failed Homeowners' Association Bill of Rights Act, which would have created a

dedicated HOA division within the Attorney General's Office.

Meanwhile, Novak warns that management companies and their legal allies are aggressively pushing back against transparency.

In an Oct. 13, 2020 letter from David Sugar of Saul Ewing LLP, the law firm representing 175 East Delaware, regarding a request from Norman Kabir for basic financial records were framed as "fishing expeditions" and met with demands for up to \$20,000 in retrieval fees.

The correspondence was sent to Robert Prince, of Cervantes Chatt & Prince P.C., and states that, "At the present time, the Association anticipates the need for multiple third-party workers to identify and retrieve all of the requested records within the 10 business day time frame, at a cost estimated at approximately \$20,000. The Association also anticipates the need for third-party workers to supervise your examination of those records, and that additional cost is unknown at this time."

As Novak prepares to return to Chicago this fall, he remains committed to pushing for change. "I would rather have regulatory oversight and less work for me," he said. "But if the state of Illinois does nothing, the corruption and waste will continue—unabated."

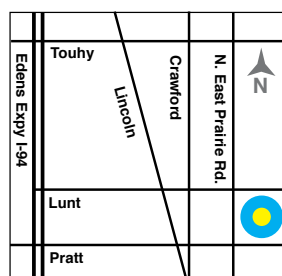
