Public open house in Uptown Aug. 7 over plans for N. Lake Shore Dr.

City and state officials are hosting an open house to discuss future plans for N. Lake Shore Dr. and other related Lakefront improvements. The open house will be held from 3 p.m. to 7 p.m. on Aug. 8, at Truman College, in the main building cafeteria, 1145 W. Wilson Ave.

The Illinois and Chicago departments of transportation are inviting the public to attend to hear about future improvements coming to U.S. 41 from Grand Ave., north to Hollywood Ave.

Interested parties may email comments to the project team at info@ndlsd.org. Although written input on the project is accepted at any time, comments received by Sept. 9, will be included as part of the official record for this meeting.

Since the last public meeting opportunity, the project team has evaluated the five remaining multimodal alternatives through

environmental reviews, technical analyses, and community input. The Recommended Preferred Multimodal Roadway Alternative reflects the results of these reviews, and analyses.

The open house will feature staffed exhibit areas to share and discuss the analyses and proposed project features as well as an audio-visual presentation that will be shown continuously.

Exhibits will review the five finalist roadway alternatives presented earlier, along with their evaluation results, the Recommended Preferred Multimodal Roadway Alternative, and recommended Lakefront Improvements for people walking, biking, and taking transit to, from, and within the north lakefront corridor and Lincoln Park.

Project team members will be present to discuss the project and answer questions.

No reservation is required.

City Council to deputize resident finks to rat-out their neighbor

Several North Side aldermen on July 17 introduced in City Council, and now support, a new ordinance that may end up turning neighbor against neighbor.

The amendment, introduced by Ald. Daniel La Spata [1st], to the Municipal Code (Chapter 9-108) has added a new "Section 9-108-025" establishing a public enforcement pilot program for citizens to submit recorded evidence of covered parking offense violations. The stated purpose of the program will be to empower the public to submit recorded evidence of covered offenses to the city, which they will use in enforcement of various violations.

That is, the sponsors of this legislation want to deputize residents to record and then turn-in their neighbors with evidence the city

can use for the ticketing of other resident's parking and traffic violations.

The amendment is co-sponsored by aldermen Andre Vasquez [40th], Timmy Knudsen [43rd], Matt Martin [47th], Ruth Cruz [30th], Leni Manaa-Hoppenworth [48th] and Bennett Lawson [44th].

Like all ticketing, the adjudication of civilian ticketing will be done within the city's Dept. of Administrative Hearings, not in Cook County Courts, which would have meant the city would have had to share the fines they collect with Cook County.

The proposal calls for the city and Chicago police to adopt rules as may be necessary for the proper enforcement of the evidence provided by deputized neighbor-

hood rat finks.

"We co-sponsored several new laws on pedestrian and traffic safety, including an ordinance that allows for resident-reported bike lane violations," said Ald. Vasquez in his weekly newsletter. The city has established a working group "to explore changing Chicago's fees and fines system to make it more equitable," and an ordinance that would reduce the city-wide default speed limit to 25-mph. "The first two passed City Council, while the speed limit reduction was sent to [the] rules committee. We'll continue to work toward its passage, as we know lower speed limits save lives," he said, without defining exactly what "equitable" referred to.

Illegitimate Cedar PAC seated without consent of Park District

Alderman supports booze bodega in 'Ollie's Market' site; CVS denies interest in liquor license

Throwing the concept of transparency in city government under the bus, and short circuiting the public input process, Ald. Leni Manaa-Hoppenworth [48th] revealed on July 17 that she has decided to support the zoning change request for 'Ollie's Market' at 1068 W. Berwyn Ave. in order for a developer to apply for a liquor license for ancillary packaged good liquor sales.

Digging by this reporter shows that the backstory on this scheme goes back to Feb. 9, when developer Rob Braga, president and managing broker of Building#1

Realty Services, met with the Edgewater Chamber of Commerce [ECC] to seek their support to acquire a packaged goods license for the 1st floor shops located at 1068 W. Berwyn Ave., a building that he owns.

Braga's partner in this retail venture will be Mohammed Abuhashish, the owner of Uptown Deli at the corner of Lawrence and Sheridan in Uptown. Abuhashish also serves on the Uptown Chamber of Commerce.

Braga had previously identified Uptown Deli as the source of produce, sandwiches, and training cashiers for his proposed store; but never ID'd Abuhashish as a business partner.

The ECC gave him his letter of support to allow for the sale of packaged beer and wine, but opposed hard liquor in order to limit problematic hard liquor sales in

the neighborhood, and sent their letter to Manaa-Hoppenworth on Feb. 16.

Braga then appeared before a faux-Cedar Playlot Park Advisory Council on Feb. 13 to discuss the proposed business and lifting the packaged goods liquor moratorium then in effect for that stretch of Berwyn Ave. and nearby streets.

The faux-Cedar PAC approved Braga's request and sent their letter of support to Manaa-Hoppenworth on Feb. 21.

Based alone on these two questionable letters of support for Braga's plan, Manaa-Hoppenworth introduced an amendment before the City Council on March 20, seeking to lift the moratorium which restricted the issuance of additional packaged goods li-

Ward staffer delayed for police oversight role, possible conflict of interest cited in opposition

A staffer in the office of Ald. Leni Manaa-Hoppenworth [48th] was stalled by a key City Council committee hearing on the seven nominees named to the Community Commission for Public Safety and Accountability [CCPSA] by Mayor Brandon Johnson.

Angel Rubi Navarajo, director of neighborhood services and public safety for the North Side ward was stalled by Ald. Chris Taliaferro [29th], chair of the City Council's Police and Fire Committee, as the committee approved the six other nominees to the police oversight board.

The six are Anthony Driver, Jr., Remel Terry, Aaron Gottlieb, Abierre Minor, Kelly Presley, and Sandra Wortham and will serve four-year terms on the commission. As a commissioner, he would receive a \$12,000 salary on top of his annual city salary of \$70,008.

The CCPSA is designed to give Chicagoans real control of the police department as part of an effort to build trust in officers and police brass and to put an end to repeated allegations of misconduct, noted Heather

Cherone of WTTW News.

In a rare move, Rubi Navarajo was sidelined by Ald. Taliaferro in his role as committee chair without objections from the committee's members. Ald. Manaa-Hoppenworth did not speak at the hearing on Rubi Navarajo's behalf.

"It is rare for the City Council to fail to confirm a mayoral appointment; it is nearly unprecedented for one of the mayor's hand-picked committee

world's largest handguns. But I'm concerned that here in Chicago your gun is also a fashion statement. Too big? Too gauche.

But closer examination of our urban condition makes me feel this is not an area open for discussion.

I'm not interested in Preckwinkle's master plan to maintain "Law & Order." If she had two ideas rattling around in her noggin she'd have one of her mari-onettes acting it out. She'd have the mayor in a wig. She'd have the embattled, embarrassing State's attorney, Kim Foxx, try to turn it into a judicial mandate for the courts to maintain. She'd have some wanna be Circuit Court Judges singing out praise for her solution.

But alas, like the murder of Chicago's first police fatality, Constable James Quinn, back in 1853, the wheels of justice need some vital human assistance. Do you recall what transpired then?

Are there any deterrents to the plague of murderous assaults that reach deep into our schools, our churches, our public transportation, driving our children to school, and ability to walk on the pavements of Chicago?

But the addition of a weapon does not necessarily restore the moral order. Or create more nourishing environments for domestic living. But the alternatives seem beyond the scope of human reason. Does that make sense Mayor Johnson? President Preckwinkle? State's Attorney Foxx?

I'm not a bad shot. The contact lenses help. But at times my depth perception is off. The remedy, I've been told, is to have a weapon I can control. But also one that packs a tremendous power of discharging thunder at impact. Something that can splatter a Gnocchi and take out the wall behind it as well. After all, this is not a duel. This is a personal Hiroshima. A wallop wrapped in the flames of rational outrage and irrational fear.

So I'm thinking the 12 gauge Winchester Super X Pump shotgun or the Mossberg Maverick 88. When you pull out a shotgun everyone runs.

To paraphrase W.B. Yeats, what strange beast slinks toward this piteous site and is released in the sad medieval tale of woe?

I know, let's get the the Smith & Wesson Model 29. That was the iconic revolver carried by Inspector "Dirty Harry" Callahan, who took care of San Francisco's bad guys back in 1971.

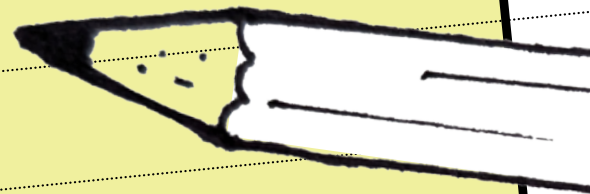

North Side home-sales gains beat the rest of city

Despite lofty mortgage interest rates, North Side existing home sales in the second quarter of 2024 beat residential marketing activity in the rest of the city of Chicago.

Sales activity rose 4.1% across the North Side despite mortgage interest rates generally at 7% or more, combined with steadily rising home prices and a continuing shortage of available homes, according to the Chicago North Side Market Report, an analysis prepared quarterly by Mary Jo Nathan of Baird & Warner's North Center office at 4037 N. Damen Ave.

The comprehensive report tracks sales of detached single-family and attached condos and townhomes in the neighborhoods of Edgewater, Lake View, Lincoln Park, Lincoln Square, Near North Side/Gold Coast, North Center, Rogers Park, Uptown and West Ridge.

"North Side sales of homes, condos and townhomes totaled 2,839 units for the second quarter, reversing a -5.6% decline in the prior quarter," Nathan said.

The strong residential marketing rebound created a modest 0.4% increase in unit sales for the first half of this year. However, because of a shortage of listings the number of residences for sale at the end of June, sales activity declined -4.3% from one year earlier, Nathan noted.

The time needed for a home sold in the quarter to find a buyer fell to 55 days from 61 a year earlier, and the second-quarter median home price for the North Side gained 6.2% to \$430,000.

Overall, the North Side market easily outperformed the city as whole, as rising home prices and high interest rates seemed to slow sales more markedly in other neighborhoods of Chicago, Nathan said. Citywide, sales for the quarter were down -2.1% to 6,932

units, while the median sales price gained 7.2% to \$370,000.

"The second-quarter increase in North Side sales is notable because year-over-year sales had been down for the prior five quarters, so this is a positive sign, and we'd love to see further sales gains," Nathan said. "However, current price levels and the lack of inventory continue to make this a challenging market for buyers. It's a familiar tune but remains accurate."

In West Ridge, Edgewater and Uptown neighborhoods, where inventory rose, saw solid sales increases, while in areas such as North Center and Lake View, where inventory shrank, sales tended to decline, Nathan observed.

Single-Family Homes

Second-quarter sales of single-family homes on the North Side rose 9.4% to 244 units. The median sales price slipped -2.6% to \$1,272,500, marking the 15th consecutive quarter where the median sales price exceeded \$1 million. The average time it took to find a buyer for homes sold during the quarter was 67 days, up from 59 days a year earlier.

"The median price decline stemmed primarily from the strong increase in sales seen in West Ridge and Edgewater, where prices generally are below the North Side median," explained Nathan.

Sales of single-family homes rose 68.2% in West Ridge to 37 units, and 66.7% in Edgewater to 20 units. However, unit sales fell -3.3% in Lincoln Square to 29 units, and -14.3% in Lake View to 36 units.

Home prices on rise

Median sales prices of a single-family home rose in six of the nine communities. When compared with the same period in 2023, the second quarter 2024 gains were:

- Uptown. Up 38.5% a hefty increase to \$1,350,000.

- Edgewater. A solid gain of 37.3% to \$1,064,000.

- West Ridge. Up 29.2% to \$600,000.

- Lincoln Square. Up 5% to \$1,070,000

- Rogers Park. Up 1.4% to \$611,109.

- Lincoln Park. Up a slight 1.1% to \$1,795,000.

Median prices fell -38.6% on the Near North Side/Gold Coast to \$1,350,000. Prices slipped -10.4% in North Center to \$1,267,500, and -2.9% in Lake View to \$1,632,500.

Condos and Townhouses

Attached homes accounted for 2,595 unit-sales during the second quarter, a 3.6% increase from one year earlier. Attached homes consist primarily of condominium apartments and townhouses.

Condo and townhome sales rose in six of the nine neighborhoods that make up the North Side, after only one area posted an increase during the prior quarter.

"Most important for the condo and townhome market, the Near North Side continued seeing attached

sales rebound, registering a 13.1% increase to a solid 878 units," Nathan said. The Near North/Gold Coast area accounted for 33.8% of attached sales on the North Side during the quarter and for 19.2% of attached sales citywide.

Attached sales also rose 9.5% in both Lincoln Square (81 sales) and North Center (104 sales), and gained 5.1% in Rogers Park to 144 sales, 3.4% in Uptown to 242 sales, and 2.3% in Edgewater to 218 sales.

Condo and townhome sales were down -10.4% in West Ridge to 86 units, -4.9% in Lake View to 484 units and -3.2% in Lincoln Park to 358 units.

The median sales price of an attached home on the North Side rose 2.9% for the quarter to \$390,000, while average market time decreased by 7 days to 54 days.

Criminal activity at DNC convention may see added pressure this year from migrants

Uber boosts efforts with domestic violence, human trafficking with free rides, food for survivors

With the Democrat National Convention coming to town in August, arriving also will be those involved in exploitation and human trafficking. Those exploiters will be ramping up for the usual strong demand that seems to follow political conventions.

With all the illegal migrants and recent arrivals in town now, Chicago may see prostitution - and other criminal activity - become even more prevalent this year.

According to the U.S. Dept. of State, globally an estimated 27 million people are exploited for labor, services, and commer-

cial sex. Through force, fraud, and coercion, they are made to toil in fields, factories, hotels, in restaurants and residences. And in Chicago this year, some will be forced to become sex workers managed and exploited by members of criminal gangs who crossed America's southern border.

Reports from several countries who have sent migrants across the U.S. border show a drastic increase in online commercial sexual exploitation and sex trafficking, including online sexual exploitation. Traffickers have always preyed on the world's most marginalized and vulnerable individuals - such as illegal migrants - profiting from their plight.

Digital tools have amplified the reach, scale, and speed of trafficking. Perpetrators use dating apps and online ads to recruit vic-

tims. Then they use online platforms to sell illicit sexual activity of those who may be trapped by their circumstances. They leverage encrypted messaging and digital currencies to evade detection.

A Google news search for the word "trafficking" will find pages of stories about the commercial sex trade, in which hundreds of thousands of women and children are supposedly trapped by coercion or force.

Local police and sheriff's officers will be focusing even more this year on drugs, human trafficking, crime, and public disorder, and distinguishing between illegal immigrants who unwittingly threaten to cut into the turf of Chicago's existing criminal organizations.

Lawsuit: NU Law School discriminates against White male faculty in favor of 'mediocre' minority candidates

A new lawsuit has accused Northwestern Univ. of allowing deans, faculty committees and editors of the school's law review publication of intentionally blocking White male scholars and professors from landing positions in the Streeterville-based Northwestern Pritzker School of Law.

The suit alleges the school fulfilled their desire to hire professors who are Black, female, gay or transgender, even when those others are "mediocre and undistinguished" when compared to more accomplished White male candidates.

On July 2, an organization known as Faculty, Alumni, and Students Opposed to Racial Preferences [FASORP] filed suit against Northwestern in Chicago federal court.

The organization asserts to represent faculty and other members who joined together "for the purpose of restoring meritocracy in academia and fighting race and sex preferences that subordinate academic merit to so-called diversity considerations."

Other defendants named in the action include Pritzker School of Law Dean Hari Osofsky; Northwestern law professors Sarah Lawsky, Janice Nadler and Daniel Rodriguez; Dheven Unni, identified as editor in chief of the Northwestern Univ. Law Review; and Jazmyne Denman, identified as senior equity and inclusion editor of the Northwestern Univ. Law Review.

In the complaint, FASORP asserts Northwestern has for years followed a pattern established in American colleges and universities, where "left-wing faculty and administrators have been thumbing their noses at federal anti-discrimination statutes and openly discriminating on account of race and sex when appointing

professors."

"They do this by hiring women and racial minorities with mediocre and undistinguished records over White men who have better credentials, better scholarship, and better teaching ability," FASORP said in its complaint.

The lawsuit was allegedly filed on behalf of three unidentified tenured White male professors at other law schools who assert discriminatory hiring practices at Northwestern leave them unable to even be fairly considered or interviewed on an equal basis for faculty positions in the prestigious Pritzker School of Law, 375 E. Chicago Ave.

The lawsuit notes that Northwestern has even passed over well known White male candidates with stellar academic credentials.

These allegedly included Eugene Volokh, a "prolific and

internationally renowned legal scholar whose academic works, especially on the First Amendment, are often cited by litigants, courts, and scholars." Volokh clerked for former U.S. Supreme Court Justice Sandra Day O'Connor; and Ernie Young, also a "famous and distinguished legal scholar" who has "published many influential works in the nation's leading law journals" and who clerked for former Supreme Court Justice David H. Souter.

The complaint notes that the accomplishments of both Volokh and Young "exceed those of nearly every professor currently on the Northwestern Law School faculty."

Both men, however, were allegedly rejected out of hand by then Law School Dean Rodriguez and

Three Open Space projects proposed for taxpayer support

Four Open Space projects would receive more than \$2 million in taxpayer funding from the Chicago Dept. of Planning and Development's Open Space Impact tax program under proposals introduced to City Council on July 17. Three of the projects are located on the North Side.

• Larrabee Gateway Plaza, at 1560 N. Larrabee Ave., would receive \$844,000 in taxpayer support for passive recreation improvements that connect to the adjacent Park No. 598. The Chicago Dept. of Transportation would construct and maintain the improvements.

• Goose Island Overlook, located at 1111 N. Elston Ave, would receive up to \$800,000 in taxpayer support for environmental remediation improvements. The property is intended to be transferred to the Chicago Park District once site prep work is completed.

• Stone Scholastic Academy, at 6239 N. Leavitt St., would receive \$137,367 in taxpayer support for construction of a 2,500-square-

foot nature play area. Additional funding for the \$140,000 project would come from Friends of Stone Academy.

The program allocates taxes paid by residential construction projects for open space improvements that offset the impact of new residents on community parks and related resources.

Shots fired, four stabbed at Montrose Beach

Four people were stabbed during two altercations at Montrose Beach on July 21, Chicago police said. Witnesses said shots were fired during one of the incidents, but no injuries were reported from gunfire. So far, no arrests have been announced.

The first altercation occurred when two men argued with a third man in the 4400 block of N. Simonds around 7:47 p.m. Sunday. Police said the third man produced a sharp object and struck both of the other men before leaving the scene.

A 33-year-old man sustained multiple cuts to his arm, and a 32-year-old man suffered cuts to his wrist, according to a CPD spokesperson. Both men took themselves to Swedish Hospital.

Witnesses reported that shots were fired during the incident, and an officer at the scene said they found shell casings on the same block where the men were stabbed.

Then, around 10:10 p.m., two people were stabbed in the 4500 block of N. Simonds, according to police.

An 18-year-old man and a 22-year-old woman were approached by a man who attacked both of them with a sharp object, a CPD spokesperson said. The victims told police the object was a beer bottle that the assailant broke before launching the attack.

Police said the male victim suffered a cut to his back while the woman was cut on her hand. EMS took them to Advocate Illinois Masonic Medical Center in good condition. CPD did not release descriptions of the attackers.

Woman slashed at Loop CTA station, suspect in custody

A woman is recovering after a man stabbed her during a July 21 altercation on the Blue Line downtown.

Police said the victim, 22, was on the CTA Jackson Blue Line platform when she got into a "verbal altercation" with a 55-year-old man around 3:29 p.m. During the argument, the man swung a sharp object at the woman, according to CPD. She suffered lacerations to both forearms and multiple cuts on her hands. Despite that, police said she declined medical attention.

Cops were on the scene almost immediately. They took a suspect into custody and recovered a knife. Charges are pending.

After three are shot, city forces hookah lounge to close

The city has forced a troubled hookah lounge to close after three people were shot outside the business on July 19. It was the second shooting at the venue in 18 months.

By Sunday afternoon, plywood covered the front door and a window that were shot out at Lyon's Den, 2123 W. Division. Bright or-

ange "summary closure" notices were slapped on the board-up and a front window that remained intact after the shooting.

On Friday afternoon, Ald. Daniel La Spata [1st] stated that he shared community "anger" about the shooting and claimed he "immediately" demanded a summary closure of the business.

Police said a gunman in a black sedan opened fire on a group of people standing on the sidewalk outside the lounge at 1:27 a.m. Friday. But a witness told this reporter that they saw a second gunman shoot from a nearby corner. Based on what they saw, the witness believed it was an "ambush-style shooting." Officials now say a fight inside Lyon's Den preceded the shootings.

Investigators marked more than 20 shell casings in three locations on the block. Three men, ages 23, 32, and 45, were in good condition after being shot.

Man charged with making \$3,000 Zelle transfer during Millennium Park robbery

It's the hottest scam going, one that everyone would be well-advised to keep in mind as they wander the streets of Chicago: fake charity solicitors and "homeless" people commander phones and transfer large sums of money to themselves using the victims' electronic banking apps.

We've told you about the scam and some people who've allegedly been caught running it, usually in tourist areas like the Mag Mile and Millennium Park or nightlife districts like Wrigleyville and the Gold Coast.

On July 20, two men asked a couple for a donation near Crown Fountain at Millennium Park. The victims reluctantly agreed to let one of the thieves transfer a dollar to himself. But, after taking control of the phone, the scammer transferred \$2,400 out of the victim's account and fled, a CPD report said.

This week, a South Side man was charged with robbery for allegedly running the same scam at nearly the same location.

Prosecutors said Timothy Harvey, 31, took a man's phone in the 100 block of S. Michigan on May 10 after the victim agreed to give him \$10 via Zelle. After getting the man's phone, Harvey allegedly took it to a group of people nearby, and they demanded \$60 from the victim to return the phone.

The victim gave them \$50 and got his device back. Only then did he realize that someone had transferred \$3,000 out of his bank account.

Detectives determined that the Zelle account that received the money belonged to Harvey, according to a detention petition. The victim also picked Harvey out of a photo lineup.

Judge Antara Rivera rejected the state's detention petition in the robbery case. However, she ordered Harvey to be held in custody for violating probation in a gun case.

Boys armed with machine gun robbed 14-year-old in Uptown

In a shocking announcement, Chicago police said on July 21 that two teenage boys have been charged with using a machine gun to rob a 14-year-old in Uptown.

The robbery occurred around 5 p.m. Saturday in the 5100 block of N. Sheridan. Police said a group of people, including a 15-year-old boy and a 16-year-old boy, robbed the younger boy at gunpoint and then fled the scene.

Police searched the area and located the 16-year-old in the 5000 block of N. Winthrop just after 6 p.m. He allegedly possessed an automatic-fire handgun when cops took him into custody.

The 15-year-old was arrested around the same time in the 1100 block of W. Winona.

Both boys face charges of armed robbery and misdemeanor battery. The 16-year-old is also charged with unlawful use of a machine gun.

Police did not say exactly what kind of gun the 16-year-old had. However, people can easily convert standard models of some firearms, most commonly Glock, into machine guns by equipping them with illegal aftermarket "switches."

Ten years for arsonist who set fire inside Target store in the Loop

A Decatur man has been sentenced to 10 years in prison for intentionally setting fire to the bedding section at a Target store in the Loop.

Ronald Langley, 26, pleaded guilty to arson in exchange for the sentence from Judge Timothy Joyce.

Officials said that Langley entered the store at 1 S. State St. around 7 p.m.

on Sept. 28, 2023, and went to the second floor. He grabbed a can of WD40 and then used it to set a blanket on fire on a display shelf, according to allegations made in court filings. No injuries were reported.

The incident was caught on store cameras and a clip of the fire appeared on TikTok.

Although there were no reported injuries, officials estimated that the store's damage exceeded \$100,000.

Police arrested Langley at a different Target store about two weeks after the fire when a loss prevention officer recognized him.

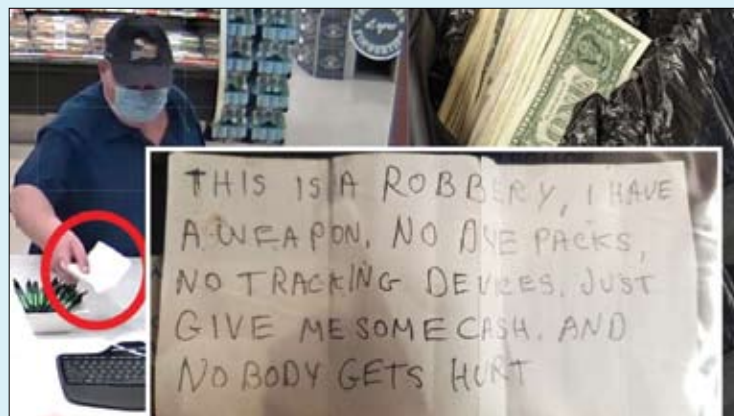
Langley is expected to be paroled on Oct. 2, 2028, after receiving a 50% sentence reduction for good behavior.

Chicago police announced last month that they had charged another man with arson and robbery in connection with the incident. Kenneth Hasley, 37, stole cellular phones from the store by threatening an employee with pepper spray. Prosecutors also charged him with arson in connection with the fire.

Hasley is currently detained and awaiting trial.

14-year-old boy charged with 6 carjackings, 6 robberies on North Side, West Loop

A 14-year-old boy has been charged with 14 felonies in connection with a violent crime spree on July 14, as well as an attempted hijacking in June.

Serial bank robber spent money at taverns to 'escape his loneliness'

A man who prosecutors said has a "long history of theft and fraud related criminal activity" has been sentenced to more than five years in prison for robbing three banks on the North Side. But his defense attorney said he's simply a lonely man who used the money to build friendships at taverns.

Federal prosecutors said Dennis Hammel, 65, committed a fourth bank robbery, too, getting away with six rolls of quarters. They didn't charge him with that heist.

Between Sept. 2022 and July 2023, Hammel robbed Huntington Bank branches inside Jewel-Osco stores, officials said. He presented a note demanding money each time and saying "nobody gets hurt" if employees comply.

The robberies began on Sept. 22, 2022, inside the Jewel at 4335 N. Sheridan.

"This is a robbery. I have a weapon give me some cash, no dye packs, follow my instructions, and nobody gets hurt," read the note Hammel presented to a teller. He got away with \$2,410.

Hammel got six rolls of quarters when he robbed the Huntington Bank at 4042 W. Foster on Feb. 6, 2023, prosecutors claimed.

He struck again on April 20, 2023, inside the Jewel at 3531 N. Broadway in Boystown: "This is a robbery no dye pack, just give me some cash and nobody gets hurt." Officials said he scored \$3,400 that time.

Finally, on July 13, 2023, Hammel returned to the Sheridan Rd. branch and took another \$2,172.

Before he even reached the counter, one of the tellers noticed a birthmark on his neck and immediately suspected that he was the man who

robbed the Boystown location, according to the federal complaint.

The teller activated a silent alarm and watched as the man placed a note on another teller's keyboard: "THIS IS A ROBBERY, I HAVE A WEAPON, NO DYE PACKS, NO TRACKING DEVICES, JUST GIVE ME SOME CASH, AND NOBODY GETS HURT"

The complaint said the second teller slipped a tracking device into a stack of cash and handed it to Hammel. Chicago police officers followed the tracker. Near Broadway and Grace, the cops pulled over a CTA bus that seemed to be moving in sync with the bank's GPS device.

The officers boarded the bus and found Hammel sitting in the back, gripping a black duffel bag that, thanks to the bank's tracking device, was emitting a "chirping" sound.

In a sentencing memorandum, prosecutors said Hammel had been involved in thefts and frauds since he was 25, amassing 14 felony convictions.

But Hammel's defense attorney argued for leniency, saying he has never married, has no children, and has essentially been alone since his parents died in the early 1990s.

"While leaving the banks, Mr. Hammel did not make reckless get-aways in fast cars. He departed on Chicago Transit Authority buses and would later go to a tavern where he would seek to connect with individuals in an attempt to form some sort of friendship and escape his loneliness," the defense attorney wrote.

Ultimately, U.S. District Judge Nancy Maldonado sentenced Hammel to 65 months in prison and ordered him to pay \$7,042 in restitution.

The boy was part of a group that carjacked and robbed four people in the 1900 block of W. Irving Park around 5:40 a.m., according to CPD. As he reported that week, a carjacker driving a white car pulled in front of the victim's Mazda CX3 to block their path, and two gunmen got out, took the victims' valuables, and then drove away with the Mazda. CPD said the victims were two 22-year-old men and a man and a woman who were both 21.

About an hour later, the boy and his accomplices carjacked and robbed two victims in the 300 block of W. Belmont, not far from Belmont Harbor. Two men with guns robbed the couple, a 31-year-old woman and a 34-year-old man, and drove away with

their blue BMW X3. A third robber remained in the previously hijacked Mazda, according to initial information.

CPD said the boy also participated in the attempted carjacking of a 55-year-old woman in the 1100 block of W. Jackson on June 27 and stole a vehicle on July 12.

He is charged with six counts of aggravated vehicular hijacking with a firearm, six counts of armed robbery with a firearm, attempted vehicular hijacking with a firearm, possessing a stolen motor vehicle, and two counts of misdemeanor resisting.

Pickpockets, purse thieves strike dozens of times in downtown Chicago

Three well-dressed thieves entered a Loop restaurant, sneakily stole a woman's purse, and headed out the door.

That's just one of dozens of similar thefts and pickpocket cases reported at downtown bars, restaurants and hotels since early June, according to Chicago police.

On July 15, the CPD issued two warnings about the crime pattern.

The video, recorded on July 2 at Elephant & Castle, 185 N. Wabash, shows two men wearing sport coats enter with a woman around 5:36 p.m.

At one point in the footage, the woman and one of the men sit down at a table as the man appears to rifle through a purse.

CPD said they don't know who committed "an overwhelming majority of the incidents." In addition to the group, several thefts were committed by a solo Black male in his mid-20s or mid-30s, according to the police alert.

The thieves typically use the victims' debit and credit cards to immediately make fraudulent purchases.

The U.S. Navy Blue Angels will perform during Chicago Navy Week, flying their F/A-18E Super Hornets. The team first flew in 1946 and is known for its skilled maneuvers and precision flying. Bye, Bob

Comedian, Bob Newhart, who put a flattering spotlight on Chicago with the opening montage of his 1972 TV show, died July 18 at the age of 94.

Born George Robert Newhart in Oak Park on Sept. 5, 1929, he attended grammar school in Oak Park and later St. Ignatius College Prep in Chicago. He graduated from Loyola Univ. Chicago with a bachelor's degree in business management; shortly after, he was drafted into the army.

After he was discharged, Newhart held a series of jobs; one was an accountant for U.S. Gypsum. He later said that his motto, "That's close enough" and his habit of adjusting petty cash imbalances with his own money showed he didn't have the temperament to be an accountant.

Bored with his accounting work, Newhart and a friend improvised comedy routines as phone calls. Later he parlayed that into his famous, halting-style,

one-sided phone conversations. Newhart started performing as a stand-up comedian in night clubs and signed with a new record company, Warner Bros.

Newhart came to prominence in 1960 when his album of comedic monologues, "The Button-Down Mind of Bob Newhart" became a bestseller and reached number one on the Billboard pop album chart; it remains the 20th-best selling comedy album of all time. That was followed by more successful albums, TV guest appearances, movies and numerous TV series, including the six-season run of "The Bob Newhart Show."

That show received some unusual recognition from American university students when a drinking game was started in the 1980s. Players would watch "The Bob Newhart Show" and take a drink whenever someone in the episode would say "Hi, Bob." The greeting happened frequently and the game spread beyond college campuses.

He also diversified Ravinia's musical offerings across more than 150 annual performances, which included long-standing collaborations with the Chicago Symphony Orchestra as well as bookings such as Bob Dylan.

Along the way, he significantly enhanced Ravinia's infrastructure for musicians and audiences alike, including the enhancement of performance facilities, food and beverage offerings, and the creation of the Ravinia Music Box Experience Center.

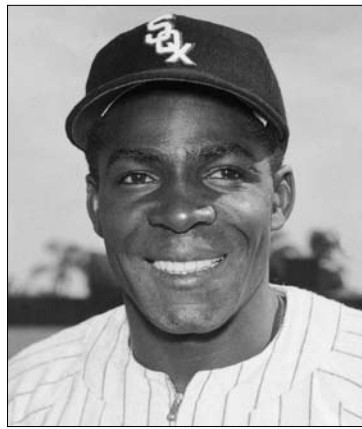

Authorities this year will have to balance prosecution, protection, and prevention priorities in criminal justice responses, at the intersection between forced marriage and human trafficking. Forced marriage, and indentured servitude in the migrant community is highlighted by trafficking.

The unprecedented irregular and illegal migration in the United States in the last three years has created the opportunities for trafficking among migrants, who often assume debts to pay smugglers and criminal cartels, and

are then vulnerable to trafficking when they are unable to repay that money.

Organized criminal gangs - both foreign and domestic - recruit, groom, defraud, threaten, coerce, and exploit victims, taking advantage their immigration status and lack of resources to force them into the sex trade.

Perhaps even more pervasive than the sex trade are those who become a victim of forced labor, or labor trafficking. In the U.S. and around the world, labor trafficking is as common if not more common than sex trafficking.

But there is one source of help

on the streets of Chicago today.

For those seeking to escape, transportation is a critical need for survivors of violence and trafficking. Approximately 90% of human trafficking and domestic violence survivors helped by the Cook County Sheriff's office do not have access to a vehicle. Last week Uber announced the continuation of a partnership with the Cook County Sheriff's Office to support transportation and grocery delivery service needs for domestic violence and human trafficking survivors receiving assistance through the Sheriff's office.

Uber will grant credits for access to free transportation and grocery deliveries for these individuals. The access to transportation provided by this partnership will help these individuals independently seek counseling and employment, shelter, medical care, and necessities.

"You just have to look at the numbers to see this partnership with Uber is making a difference," Sheriff Thomas J. Dart said. "Hundreds of rides and meals provided to victims completely in crisis, in about a year's time."

Uber first started the partner-

ship in 2023 through Uber's Access Fund.

Unfortunately, some governments are part of the problem. The U.S. Dept. of State claims that 13 countries exhibited a policy or pattern of trafficking. Belarus rejoined this list, and Sudan was newly added to the list. For the fifth year in a row, the department assessed 11 countries as having a government policy or pattern for trafficking. This would include Afghanistan, Burma, the People's Republic of China, Cuba, Eritrea, Iran, Democratic Republic of Korea, Russia, South Sudan, Syria, and Turkmenistan.

other members of the faculty appointment committees because they were White males.

Neither Volokh nor Young are plaintiffs attached to the lawsuit, according to the complaint.

Instead, the complaint asserts the Pritzker Law School has consistently chosen to hire "patently unqualified professors" simply because those professors are Black, female, gay or transgender.

The complaint points to the hiring of four Black professors, including three who were women, identified as Destiny Peery, Candice Player, Paul Gowder and Jamelia Morgan.

The complaint claims all of those faculty appointments were essentially chosen primarily because of their race or sex, or both, and came over concerns expressed by Northwestern faculty about their academic depth and credentials.

Further, the complaint asserts dissenters were forced into line by deans and others in the faculty, who allegedly threatened to withhold bonuses and allegedly told dissenters that only Black candidates would be considered for those positions.

And the complaint asserts that after they were hired, none of those professors distinguished themselves.

Player, for instance, "struggled in the classroom, and admitted to colleagues that she did not understand the material she was teaching and couldn't handle the students' questions." She later departed from the law school

in 2019 after students allegedly exposed her for plagiarizing "an exam hypothetical from another source, because Player was too lazy to write her own exam question."

Peery also departed from Northwestern, the complaint claims, after she was quietly warned not to pursue tenure, because she was allegedly not qualified. According to the complaint, Peery then allegedly accused the school of racism, "pretending that she was a victim of race and sex discrimination when racial preferences were the very reason she was hired in the first place."

Both Peery and Player have "failed to obtain another academic appointment after leaving Northwestern, despite the overwhelming discriminatory preferences that black women receive on the academic hiring market," FASORP's lawsuit says.

The complaint notes that since 2021, the university has extended faculty job offers to 21 candidates.

Of those, only three have been extended to White male candidates. But of those three, the complaint said, two went to White male candidates in tax law, a "high-demand, low-supply field" in which very few minority or female candidates are available, and one of those was a "sham" offer, extended to a White male candidate who administrators knew already had offers from the Univ. of Chicago and Stanford, both more prestigious schools than Northwestern.

The other offer to a White male student was extended to a professor candidate with pre-

existing ties to Northwestern, who was allegedly already well known and liked by Northwestern faculty, who had co-authored a study "claiming that race and sex preferences on student-run law reviews" benefit women and minorities. This "delighted the affirmative-action devotees and leftist ideologues on Northwestern's faculty and enabled him to earn their support despite his status as a White man," the complaint said.

The complaint further asserts white males have faced discrimination at Northwestern from the student editors of the school's Law Review, who have routinely sought to appoint black, female, gay and transgender members and editors and to promote scholarly articles authored by black, female, gay and transgender students.

They said the Law Review promotes such articles "while rejecting far better articles written by White men."

The lawsuit asserts the Law Review encourages authors to submit "personal statements" with their work, allegedly to allow editors to determine the race, sex, sexual orientation and gender identity of the authors and "to discriminate against White men."

The lawsuit claims the Law Review in 2023-2024 published an entire issue devoted entirely to "articles written by Black women." That issue further did not disclose "that only articles written by Black women were considered for publication, making it appear as though the normal selection process was used and that those

authors earned their placement in the Northwestern Univ. Law Review by writing better scholarship than the articles that were rejected."

"The student editors and members on the Law Review were told that this was done intentionally to promote the careers of these black women academics because of their race and sex," the lawsuit says.

The lawsuit asserts Northwestern's conduct has violated federal civil rights law which bars discrimination on the basis of race and sex, even if such discrimination is targeted at White males.

The lawsuit asks the court to issue an injunction blocking Northwestern from continuing to allegedly engage in such discrimination and ordering the school

to establish new faculty-selection and Law Review selection policies that are "based entirely on academic and scholarly merit and that explicitly disavows any consideration of race, sex, sexual orientation or gender identity or expression."

They are seeking the appointment of a court monitor to oversee such potential orders.

In response to the lawsuit, a Northwestern spokesperson issued a statement to The Cook County Record, saying:

"Northwestern Pritzker School of Law is among the top law schools in the country, and we are proud of their outstanding faculty. We intend to vigorously defend this case."

The median sales price rose in seven of the nine North Side neighborhoods. Edgewater led the way with a 19.5% gain to \$260,500, followed by Rogers Park, up 15.0% to \$230,000 and West Ridge, up 12.1% to \$185,000.

Other condo and townhome gains were: 9.4% in Near North/Gold Coast to \$432,055, 7.3% in Lincoln Park to \$625,005, 5% in Lake View to \$451,300 and 4.7% in North Center to \$565,625. However, the median price fell -19.1% to \$352,000 in Lincoln Square and slipped -0.1% to \$353,000 in Uptown.

Mortgage rates easing

On July 18, Freddie Mac's Pri-

mary Mortgage Market Survey reported that benchmark 30-year fixed home loan interest rates slipped to 6.77%, down from 6.89% a week earlier. A year ago, lenders were charging an average of 6.78%.

"The 30-year fixed-rate mortgage fell to its lowest level since mid-March, dropping 12 basis points," said Sam Khater, Freddie Mac's chief economist. "However, home buyers have yet to respond to lower rates, as purchase-application demand is still roughly below spring numbers.

censes on Berwyn and nearby streets.

On April 10, Manaa-Hoppenworth’s proposed ordinance was approved by the Committee on Licenses and Consumer Protection. The ordinance then went before the full City Council on April 17 where it passed by a vote of 49-0 and went into effect immediately.

Despite this City Council maneuvering, lifting the moratorium didn’t come before the 48th Ward Zoning Advisory Council until July 2.

The public-at-large wasn’t notified of the lifted moratorium until an announcement by Jorge Ivan Soto, 48th Ward development director, on July 8 at the Edgewater Beach Neighborhood Assoc. [EBNA] community meeting on the proposed store.

Manaa-Hoppenworth based her decision on the two letters of support. The first, the EBNA letter, opposed hard liquor sales, an option that Braga described as a deal breaker.

The other letter from the Cedar PAC ap-

pears to be from a hastily assembled park advisory body that was illegitimately seated without the knowledge or consent of the Chicago Park District [CPD]. (The CPD has stringent guidelines required for establishing PACs including fingerprinting.)

The official, authorized Cedar PAC dissolved in Oct., 2023, according to CPD and community sources. This PAC failed to file their annual report for 2022 and 2023 and dissolved as members moved away or had other commitments.

Braga informed this reporter on July 10 that as a stickler for parliamentary procedure, he thought he could assemble a new Cedar PAC if he had one of the old officers from the dissolved PAC on-board.

While it isn’t known at this time who assembled the new PAC, or where they met, Braga stated that Jorge Ivan Soto, Manaa-Hoppenworth’s staffer, furnished the last minutes from the real Cedar PAC in order for Braga’s faux-Cedar PAC to continue the business of the official PAC and obtain his letter of support for his planned store.

The faux-Cedar PAC letter to Manaa-Hoppenworth was sent on PAC letterhead

and bore the names of three signatures at the bottom; Erik Peterson, Cari Pyka, and Quyen Le. Quyen Le is married to Peterson and is the past treasurer of the dissolved Cedar PAC.

Also on July 17, Erik Peterson responded to questions posed by this newspaper saying that his Cedar PAC wasn’t speaking for the CPD. He admitted that his letter to Manaa-Hoppenworth ‘perhaps needs some clarification’ and admits that his Cedar PAC ‘may not technically be active’ but that he has been paying dues.

On July 18, Audrey Champelli, communication manager to Manaa-Hoppenworth, furnished a copy of the faux-Cedar PAC letter of support to this newspaper.

On July 19, Amy Thibault, lead director of external communications for CVS Pharmacy, in an email to this newspaper regarding the CVS store at Foster Ave. and Broadway, said “We have no plans to seek a liquor license for that store at this time.”

Despite the public homage to the late Ms. Ollie Latiker from the planned store owners, she would likely agree that this is no way to conduct business.

Manaa-Hoppenworth. Rubi Navarajo also worked for Ald. Andre Vasquez [40th] and U.S. Rep. Jesus “Chuy” Garcia.

Ald. Samantha Nugent [39th] also objected noting that Navarajo could be asked to vote against a policy position taken by Ald. Manaa-Hoppenworth or to implement a policy as a City Council staffer he opposed as a CCPSA commissioner.

In a remarkable journey, Navarajo came to the U.S. with his mother from Guatemala when he was two-years old. He graduated from Arrupe College of Loyola Univ. in May, 2023, where he was student body president. In 2022, he was a Congressional intern.

In a LinkedIn statement in May, Rubi Navarajo said he was both honored and

humbled to be nominated by Mayor Johnson. “The work that lies ahead is voluminous, difficult, exciting, and most of all, hopeful,” he wrote. He didn’t answer questions from this newspaper about what personal experience and skills he might bring to the commission.

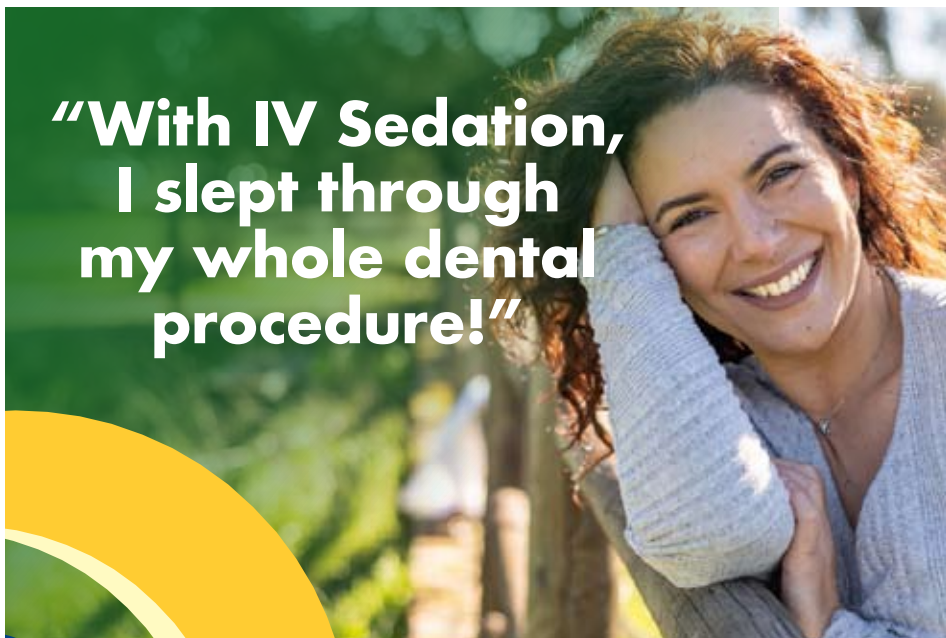
The ordinance creating CCPSA did not prohibit commissioners from working for the City Council, although it laid out requirements to ensure equitable representation. The ordinance requires two commissioners to be between the ages of 18 and 24, although it doesn’t specify what unique skill sets people of that young age hold.

In a statement after the Police and Fire Committee vote, the six approved CCPSA

members wrote, “The CCPSA will continue to advocate for the confirmation of [the] Angel Rubi Navarajo appointment.”

In a statement, the Chicago City Council Latino Caucus expressed disappointment in seeing the only Latino candidate held up by members of the Police and Fire Committee.

“As a DACA recipient and devoted public servant, Angel is incredibly qualified to serve this four-year term. He went through a rigorous vetting process ... The City of Chicago Law Dept., the nominating committee, and the Mayor’s Office all determined there were no conflicts of interest and he was the best candidate for the job.”

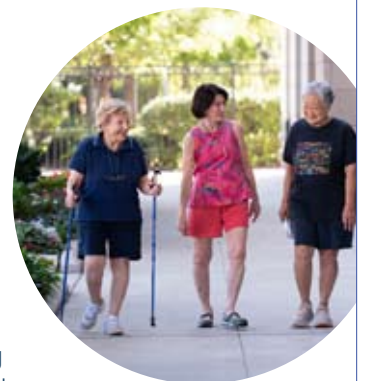
