LEGAL NOTICE

COOK COUNTY REAL PROPERTY ASSESSMENTS FOR 2017

This publication constitutes official notice of the changes in assessment to all owners of real property in Lakeview Township. The 2017 assessment changes as published herein are those determined by the Assessor of Cook County.

It is the duty of the Assessor to appraise all taxable real property in Cook County at its fair cash value as of January 1, 2017. Fair cash value is described as what the property would bring at a voluntary sale in the normal course of business or trade. The Assessor is required by law to assess said property in a fair and just manner.

The Assessor does not determine property taxes. Property taxes are determined by the spending needs and requests of municipalities, school boards, park districts and other local government agencies which provide public services to property owners. The Assessor's sole responsibility is to estimate the value of real estate property.

In Cook County, real property is classified according to its use. The classification system is used to determine the percentage of the fair cash value at which the real property is assessed for purposes of taxation. Accordingly, real property is assessed at only a fraction of its fair cash value, depending on its use and classification.

Changes in assessment for land and improvements are lists separately. The dimensions of the land are also listed:

- A - Acres
- B - Back Lot
- N - Irregular Lot
- S - Square Feet

Cook County uses a Permanent Index Number (P.I.N) system as a means to identify individual real estate parcels. The PIN consists of a 14-digit number. The first two digits identify the area or survey township; the second two digits identify the sub-area or section; the next three digits identify blocks.

Note:
Blocks are defined as follows:
Blocks 100 to 199 are located in the N.W. Quarter
Blocks 200 to 299 are located in the N.E. Quarter
Blocks 300 to 399 are located in the S.W. Quarter
Blocks 400 to 499 are located in the S.E. Quarter

The next three digits in the series identify the specific parcel or lot. The last four, (where applicable), identify individual condominium units, non-operating railroad parcels or leasehold's of exempt parcels.

Whenever possible, the assessment list will be listed by the street name and the street or house number of the parcel. However, the Cook County Assessor's Office official records rely on permanent Property Index Numbers (P.I.N.) only. No assessment of real property shall be considered invalid due to an incorrect listing.

Famous Northwestern Terra Cotta and previously undiscovered pattern molds found in university's maintenance shed

Several years ago I had the privilege of visiting the Univ. of Wisconsin-Milwaukee's Historic Preservation Dept., on a memorable road trip to examine the original molds they had acquired. The molds had been rescued by a professor from the Architecture Dept. from being trashed by Carson Pirie Scott & Co., when it came time to clear out an old storage facility they kept in Wisconsin.

Now tucked away in a field house, among lawnmowers, field equipment and other such mundane objects, were these oversized and incredibly detailed pattern molds (and plaster and composite

ornament), in surprisingly good condition. They were badly needing a new home, and so I went up to assist in finding the right place for this vast collection of molded plaster ornament.

Now known as the Sullivan Center, this structure at 1 S. State St. was designed by Louis Sullivan for the retail firm Schlesinger & Mayer in 1899. The trajectory of the building's planning and construction was such that renovations or additions continued throughout the 1890's and into the 20th century.

The building's story stretches as far back as the great fire of 1871, when bavarian immigrants and newly displaced merchants Leopold Schlesinger and David Mayer began a partnership.

In 1881 the two men had moved their dry-goods store into the Bowen Building on the corner of State and Madison. Ten years later (1891), they hired Adler and Sullivan to prepare bold plans for the removal of the Bowen building's attic and the addition of two stories across the Bowen Building, as well as adding the adjacent four-story structure to the south. In 1898 Schlesinger and Mayer decided to remove the original building and replace it with an entirely new building designed by Sullivan. He subsequently created a nine and 12-story proposal, and though they eventually started with a nine-story portion of the building on Madison St., Schlesinger and Mayer came back several years later wanting a 20-story building. They eventually settled for 12 stories, barring a previously added portion of the structure which did not structurally support more floors.

Though the building was originally planned to be marble, a

stonecutters strike in 1898 forced builders to switch to terra cotta (ultimately, a more lightweight and inexpensive material).

In the end, Sullivan constructed a magnificent steel-framed building detailed with terra cotta and ironwork. The facades were added to match the bottom stories of the building and the entirety was painted white. The building was given a round corner entry for dramatic appeal, that opened access from the corner of State and Madison.

Sullivan emphasized the vertical dimension with unbroken lines of piers and recessed spandrels. The main portion of the building comprised a corner entrance pavilion and tower, flanked by 12-story elevations. In the tower, Sullivan reproduced the skyscraper effect, but on the elevations he emphasized the horizontal dimension by using unbroken stringcourses to unite expanses of Chicago windows.

Though its doors opened in 1903, Schlesinger and Meyer remained in business only a year before rival retailer, Carson Pirie and Scott, moved into the building, hiring Daniel Burnham to complete final additions in 1906 (adding five additional bays).

Samuel Carson and John T. Pirie were Scotch-Irish immigrants, who, in 1854, founded a business that would become one of Chicago's leading department stores.

In 1890, Robert Scott entered business as a partner leading the firm to change its name to Carson by the mid-20th century, beginning in the 1960's, Carson Pirie Scott & Co. operated 11 stores around Chicago. It was during this era that the last renovation was completed by Holabird & Root on the State St. corner.

In 1960, the firm added the last three bays, completing the building as it exists today. It became an official Chicago landmark in the 1970's.

The patterns and/or molds that I saw in person date to this last development by Holabird & Root, which replicated the facade ironwork done by the Winslow Brothers. The collection contains remarkable artifacts that stand alone as individual pieces or cohere as a group. The delicate patterns represent the craftsman's hand in a complex method, one that harnessed new technology to magnify intricate hand-drawn forms that would complete the architecture.

Further, they help picture how the repeating ornament ties disparate materials together, pushing the limits of stone and metalwork simultaneously. Sullivan intended the high relief storefront to complement the terra cotta cornice on the top floor, and supervised the craftsmen meticulously to that end.

The original modeler for the building's ornament was Kris-

tian Schneider, a Norwegian-born craftsman who proved an important collaborator, establishing the subtlety required by Sullivan. Schneider was, at the time, employed by the Northwestern Terra Cotta Co. that was located in Lincoln Park at Wrightwood and Clybourn, but Sullivan employed him separately to make the clay models for the cast iron ornament surrounding the show windows along the base of the store. The decorative panels are also generally credited to George Grant Elmslie, Sullivan's chief draftsman after Frank Lloyd Wright left the firm.

The ornament originated from the influence of Celtic metalwork, and was elaborate enough to let natural light and shadows play on the lower floors. The bronze-plated cast iron itself exemplified a blending of modern technique and traditional handwork, at a time when metalwork was refined to become a distinguishing feature in the new architecture.

With the Winslow brothers at the helm of manufacturing, the Carson Pirie Scott's ironwork stands as a perfected means of making large panels of exceptionally thin metal, the state of the art in casting at the time.

Sullivan was concerned specifically that the ironwork in the building be executed so as "not to show any bolts or screws in any part of the work, except where absolutely necessary. Where the use of bolts and screws is unavoidable they must be symmetrically and artistically located subject to the approval of the architect, whose attention must be called to such proposed arrangements."

The original ironwork reconstructed this absent element to restore the integrity of the original design.

Saint John the Baptist gets a makeover at the Art Institute

A newly restored “Scenes from the life of Saint John the Baptist” by Bartolommeo di Giovanni is among the paintings and objects on display in “Saints and Heroes: Art of Medieval and Renaissance Europe,” which opened earlier this year at the Art Institute of Chicago.

Scholars believe the painting adorned a Florentine home in the late 1400s. It was a spalliera painting—a painting hung at shoulder height. It was originally part of a series of paintings that would have decorated a room.

The artist used several wooden panels joined together to form one big canvas. He then applied gesso, a white layer made of chalk and animal glue, on the canvas. The white background ensured the colored paints stood out. In this painting, the artist had drawn

incised lines to mark out the perspective of the building, says Daniela Leonard, fellow in paintings conservation at the Art Institute.

Before this painting could go on display, it was treated and restored to its near original form. “The treatment undertaken for this painting was relatively last minute and unplanned. It had earlier been viewed in storage with poor lighting and was believed to be suitable for display as it was,” says Leonard. Not until the painting

was brought up to the conservation lab for reframing did the curator and conservationists decide that it needed restoration.

The painting had been previously restored back in the 1960s. The restorers toyed with the idea of painting on top of the old restoration to better match the original surroundings. But they decided against it. “It was easier to remove the older restoration and then apply our own paint as needed,” says Leonard.

This amazing building was transformed by the visions of multiple architects (and preservationists), and the pattern molds are an important remnant of a history entwining Sullivan’s visionary design with the work of multiple firms, foundries and craftspeople who shaped a central corner of Chicago.

With this in mind, the molds in the university collection are notable for helping unveil a complicated construction process, unfolding over many years.

On a more sentimental note, artifacts from the former Schlesinger & Mayer building are largely responsible for inspiring or kicking off the Bldg. 51 collection back in 2006. A terra cotta stringcourse panel and a copper-plated cast iron newel post are the first two items acquired in my serious and passionate effort to gather together important pieces of Chicago architecture while operating urban remains for the past 10 years. When, in 1991, a flood brought disaster to the basement

Formally alleging defamation, false light, intentional interference with business expectations, intentional interference with contract and intentional infliction of emotional distress, Tadros wants a jury trial and seeks compensatory damages of at least \$38 million. Bow Truss Coffee founder demands \$38M for alleged ‘hit piece’

Bow Truss Coffee founder Philip Tadros is back in court, now seeking \$38 million from Crain’s Chicago Business in a self-filed defamation lawsuit over a July 2016 Crain’s article he called a “hit piece.”

Tadros, already engaged in legal battles with business partners and employees, filed the most recent complaint July 7 in Cook County Circuit Court. He named as defendants Crain Communications, Inc.; Keith Crain, Rance Crain, KC Crain and Christopher Crain, the family members who run the business and weekly publication, as well as editor Michael Arndt, reporter Peter Frost and former Crain’s publisher David Snyder.

Tadros is representing himself in the action, according to court records.

The article in question was published under the headline: “One

of Chicago’s most connected entrepreneurs has made more than a few enemies.” Tadros said Crain’s used “the most salacious information they could find” and marketed the piece as a special report to draw more attention to the trouble the North Side coffee roaster was experiencing.

Frost’s article ran in the July 9, 2016, edition. In November Tadros sued investor Alan Matthew, alleging defamation for comments he made in the piece. In that complaint Tadros said the article “was written with reliance on Bow Truss’ confidential financial and accounting information. Only a Bow Truss officer or investor would have had access to this information.”

In accusing Crain’s of defamation, Tadros said the article was conceived as a “hit piece” and said placing it on the front page underscored the commitment to making him look bad. The complaint highlighted Tadros’ objections to

the article, including assertions he lived a luxurious lifestyle while his businesses underperformed, “has a knack for burning through other people’s money” and employs “questionable accounting practices,” while allegedly implying he violated Securities and Exchange Commission rules about public offerings.

Tadros said Frost interviewed him for the piece and also noted he communicated with Arndt and Snyder before publication “to address the several inaccuracies and misrepresentations.” However, he said they were content to base the piece on sources, including anonymous ones, whom they “knew had a pre-existing bias” against Tadros, he alleged.

In addition to Bow Truss, Tadros is involved with ventures like Doejo, Aquanaut Beer Company, Budlong and Funded Foods. Earlier this year, Bow Truss workers walked off the job to protest unpaid wages, forcing Bow Truss to close its 10 locations. Later, 10 former Bow Truss employees filed a Cook County Circuit Court complaint against Tadros and co-owner Darren Marshall, alleging violations of various federal and state wage and hour labor laws. That case has since been removed to federal court, where it remains pending. In court filings there, Tadros has denied the employees’ allegations. In an emailed statement, Tadros said: “Everyone has been paid.”

The employees’ lawsuit came about a week after celebrity investor Marcus Lemonis countersued Tadros in response to a \$26 million suit Tadros had earlier brought against Lemonis, accusing Lemonis of trying to devalue Bow Truss so he could buy it. Tadros’ lawsuit further alleged Lemonis attempted to destroy Bow Truss altogether when the sale fell through. In May, a Cook County judge dismissed Lemonis’ countersuit, and granted Tadros the chance to amend his complaint and continue his action against Lemonis. Tadros’ lawsuit against
