Greyhound on the way out, new Goose Island development closer to reality

An eight-acre Greyhound Bus service facility at 901 N. Halsted St. may soon sprout some giant new high-rises after the Chicago Plan Commission approved a plan by Halsted Pointe to put a high density development on the south end of Goose Island.

And with this plan, Goose Island starts its transition from being an ugly industrial duckling to a big, fat golden goose.

The project is bounded by Halsted St. to the west, Hooker St. on the north and the Chicago River to the east and south. It should come to command the skyline after being completed in four phases, creating as many as 2,650 residential units - but only 1470 parking spaces, retail space, and a hotel.

Developers Onni Group's pro-

posal represents a major shift for Goose Island, which from its founding has served as a home to heavy industry, not people. This project ushers in sweeping rezoning changes of the North Branch Corridor of the Chicago River, opening the formerly industrial-only adjacent lands to new mixed-use developments like The River District to Halsted Pointe's south, and the Lincoln Yards project further north.

With approval from the Chicago Plan Commission, the project will now seek approval from the zoning committee and full City Council.

The plan will include five towers of 65, 46, 45, 30 and 28 stories. The signature building on site will be located on the southern point of the island. It will be erected in

Phase 3, is also supposed to create the majority of the development's open space. The 65-story, mixed-use tower will rise 691' with 1,015 residential units. Retail space on the ground floor will encompass 18,800 square feet, with parking including 600 spaces for this phase. Open space plans for this phase include 853 linear feet of riverwalk and 109,400 square feet of open area for the planned market plaza.

Approximately half of the entire site will reportedly be retained as public open space, with parking and loading located below ground level. Greyhound will still lease the site through Jan. 2022, with demolition beginning directly afterwards. The first phase may take between 24 and 30 months to complete.

DePaul College Prep to require vaccines to attend school

Catch the virus, no school for you

DePaul College Prep H.S. in Roscoe Village told parents Aug. 25 that the school will now require its students to get a COVID vaccine if they want to attend the school.

Principal Megan Stanton-Anderson said non-COVID-vaccinated students could technically still pay the annual tuition and try to attend the school, but that she would be instituting new policies that would prevent those students from participating in school activities, as well as making it more difficult for them to earn a diploma.

Classes begin for all grades on Sept. 7 for the school at 3300 N. Campbell Ave.

Stanton-Anderson's new policy would require non-vaccinated students to take weekly COVID tests. If they are exposed to the virus they must quarantine at home for 14 calendar days, with the days counted as an unexcused absence.

"Remote learning will not be available for quarantined individuals and days of quarantine will be counted as a normal absence," she says.

If a non-COVID-vaccinated student tests positive for the virus, they are required to quarantine at home and "remote learning will not be available."

"Students may return to school after their 10th day of quarantine if they have been fever-free for 24 hours and are asymptomatic," per

Stanton-Anderson's policy. "Days of quarantine will be counted as a normal absence."

Stanton-Anderson's policy also penalizes vaccinated students who test positive for COVID. They will also have to quarantine for 10 days, will be prevented from remote learning and their absences will be counted as unexcused.

"Vaccinated students who test positive for COVID will have to quarantine for 10 days, will be prevented from remote learning and their absences will be counted as unexcused," says principal Megan Stanton-Anderson.

"In the interest of the health and safety of the entire DePaul Prep community, the protocols, practices, and policies shared here are non-negotiable," a letter from Stanton-Anderson and school President Mary Dempsey reads. "Parents and students who are not able to comply with these are asked to reconsider their position or seek alternative placement for the 2021-22 school year."

DePaul College Prep is run by the Vincentians, who also run DePaul Univ. in Lincoln Park. The high school was formerly called Gordon Technical, which closed in 2014.

Two hour response time for robbery? No cops available for a man shot on the street? Detectives pulled from cases to patrol Lollapalooza?

Welcome to Chicago 2021

After armed robbery crews swept across the downtown in July, striking five times on July 27, then robbing 14 more people two days later, Chicago police leaders did the unthinkable: They took most of the city's robbery detectives away from their investigations to patrol Lollapalooza.

For more than three straight

minutes on Aug. 1, a Chicago police dispatcher read out dozens of 911 calls waiting to be assigned to police officers in their district — but no officers were available. A "shots fired" call was 178 minutes old. A robbery was waiting for more than two hours. A domestic waiting for more than three hours. A 115-minute wait for a burglary.

After a series of bump-n-run carjackings broke out last week, one of the victims' automakers contacted CPD to help them locate the stolen car. CPD told the car company that the assigned in-

vestigators don't work on Sundays and Monday.

On Aug. 15, a man fell to the ground, critically wounded with multiple gunshot wounds on the 5100 block of W. Fullerton. For six minutes, not a single cop was available to respond, even though an officer who monitors CPD's surveillance cameras confirmed that there was a shooting victim on the ground.

Welcome to Chicago 2021, where police leaders have pulled several hundred cops from local districts to form a "Community

Safety Team" that's supposed to build relationships with citizens. But the move has left local districts grossly understaffed, driving up response times when people are in their greatest need.

"It would be better to re-staff the districts so beats are patrolled and calls are answered instead of these useless [community] interactions," one frustrated CPD insider said last week. "Cops are planting flowers and cleaning alleys. People are calling 911 for help and waiting over an hour. That's not a very positive experi-

ence for them."

Audio clips of pending 911 calls are available for citizens to hear by the widely-followed @Chicago_Scanner Twitter account. When one listens, most ask themselves if any of those citizens are likely to have a positive impression of the CPD after waiting hours to get some help.

When a reporter recently asked CPD Supt. David Brown about the department's slow response times earlier this summer, he said

God save the Queen and remember the Everly Brothers

Before the Beatles or the Rolling Stones, in the unfolding of 1950s America, there were the Everly Brothers. A twangy, harmonious duo whose tunes reflected the angst and innocence of being an American teen.

Though I was just a child, I knew that they must have their fingers on the pulse of the pimply crowd of blue-jeaned adolescents.

Remember some of their hits? "Cathy's Clown," a Rockabilly tune that let boys know that love might make them act foolish.

Or "All I have to do is Dream," a little hymn to the unpredictability of teen-age love.

And of course their show stopper, "Wake Up Little Susie." That's the teenage nightmare about a couple of kids in love who fall asleep on a date and wake up at four in the morning when the movie they watched is long over.

Unfolding here is the terror of scandal, being out all night. The horror of having to explain how they innocently fell sound asleep for hours with the fear they will not be believed.

*Wake up, little Susie, wake up
Wake up, little Susie, wake up*

*We've both been sound asleep
Wake up little Susie and weep
The movie's over, it's four o'clock*

And we're in trouble deep.

In the world of the 1950s the tune must have been a shocker. Every parent's nightmare. Every teenage couple's paralyzing fear.

The Everly Brothers harmonized, country-style, while telling the excruciating agony of being in love and mis-understood.

Perhaps they rocked the comfortable sensibilities of American parents, especially in small town USA. I'm not sure this was as dangerous in the world of urban teenagers. Especially in places like Chicago where the firm hold of parochial control wrought by clergy and high school nuns already instituted strategies to disable such accidental teenage mischief.

I started pondering the stories of the Everly tunes because Don Everly, the last surviving brother died last week at 84. Brother Phil left us seven years ago. They certainly captured a powerful moment of adolescent life before the British invasions and the Summer of Love changed things forever.

Falling asleep in a movie theater is almost a comic relief by comparison today.

The brothers trudged along as time changed music. Splitting up in 1973, though they held remarkable popularity in Britain.

That's what I was ruminating about as I read a British tabloid. The Daily Mail had fresh ammunition for the warfare in the House of Windsor. Their report-

ing is always very anti-Prince Harry and Meghan, they are no friend of the Sussex Royals. So they gleefully reported that the Queen was going on the offensive with the Duke and Duchess. She's going after them with an army of fact-checkers and lawyers. She'll sue them as often as it takes to keep them from reporting falsehoods.

Then another article about how step-mum, Camilla, Duchess of Cornwall, was never going to forgive them for making hubby Charles so sad over Megxit and their withdrawal from royal life.

Wait. She won't forgive them? Didn't she break up Charles and Diana's marriage?

Then there was a story that the Queen did not want Prince Andrew, Duke of York, to lose his senior honorary status in a Royal Brigade. Despite all the damaging publicity he is receiving for his sexcapade with teenagers with his buddy Jeff Epstein.

That's when I thought, if only the Everly Brothers had written a musical version of these stories. All the intrigues of royal family squabbles. The naughtiness of Charles and Camilla. The way it so devastated Diana, the Princess of Wales.

The way it did damage to budding teens, Will and Harry, when they realized their papa was an adulterous scoundrel.

When they discovered papa wanted to marry his girlfriend,

writing her poetry that sounded just like an American teen might.

Then there's the angry Queen, 95-years-old, still treating her children like they are teens. She probably blames Mick Jagger and Paul McCartney for the rock-and-roll way they turned out. Perhaps the Everlys could have rewritten some of their hits to fit the Royal House of Windsor.

Maybe Charles and Camilla know the heartbreak of waking up in a movie theater at 4 a.m.

There's just so much room to evaluate the actions of "cheating hearts," and that doesn't cover the rumors that future King William was cheating big time with their friend the Marchioness of Cholmondeley. Maybe they just went to the movies.

*The movie's over,
it's four o'clock*

And we're in trouble deep.

Of course, it's all terribly sad that so much drama at the palace is unfolding as the government of Great Britain is botching the capitulation of Afghanistan and losing face with their handling of the COVID crisis, Brexit and Northern Ireland.

Perhaps the Royal House of Windsor is finally being seen for what it really is, an anachronism and drain on the culture of a traumatized nation. Her Majesty the Queen has ruled with polished excellence for 70 years. But she is surrounded by a family of moral failure and limited abilities, of serious ineptitude and low values.

Britain is no longer the nation of Rule Britannia. It's much more a land of "Wake Up Little Susie." Led by a Prime Minister of questionable character, himself. I believe America has been hoodwinked by television productions like The Crown.

There are few options remaining as the Queen comes to the end of her days. What will follow is already here. A cast of wasters. Poorly educated social misfits. The ultimate dysfunctional family. Not the children of Chaucer, Shakespeare, Milton, Barbara

Park District removes ring/signage from recent drowning site



New signage and a life safety ring were installed, and removed, at Pratt Pier last week after the drowning of a 19-year-old man on Aug. 22. It was the second drowning on the pier in the last two years.

Double losses hit hard this week

Despite yet another recent drowning, the Chicago Park District removed life-saving equipment and signage that neighbors had installed on Pratt Pier.

Read on, please.

Last week, I wrote about a young man who died after drowning at Pratt Pier in Rogers Park. At that time, I knew nothing about him, other than information that had been released by the Chicago Police Dept. and what I had heard down at the lakefront shortly after he went missing in the water.

Well, now I do know about him, thanks to his first cousin, Estefania Diaz. Through her own heartbreak, Estefania took the time to talk about her beloved family member. I felt that you too should know about this incredibly bright and much-loved fellow.

Miguel Angel Cisneros Jr., fondly referred to as "Maicky," was just 19-years-old when he drowned on Aug. 22, after jumping off the pier into the water. Apparently, Miguel was flailing and begging for help before drowning, witnesses said.

The thing is, his death was completely avoidable. Miguel was just six feet from the pier while in distress. Yet there was not one single piece of life-saving equipment nearby. Had there been, there's a good chance that Miguel might still be alive today.

Before I tell you more about this promising young man though, I have to tell you what happened last week. On Friday night—prompted by what happened to Miguel—longtime Rogers Park resident Jim Ginderske did a great deed and went and installed what residents of this neighborhood have long asked for—a life ring on the pier. On Monday morning, the Chicago Park District stunned neighbors when they removed the life-saving device.

It was a move Ginderske called, "absolutely despicable."

"Miguel was six-feet from the pier and nobody had anything to throw in," said Ginderske. "These things are scientifically proven to save lives if people are in the water and need help. It's so obvious and so basic."

Lake Michigan is "completely unpredictable," and we need a way to keep people alive until the fire department gets there, said Ginderske.

"They're gone before the first responders arrive," he said. "We absolutely must have something that's readily available. This was completely avoidable."

The park district removed the safety device at Pratt Beach because it was not authorized by the District, "however we are currently exploring supplemental safety equipment for sanctioned swim locations," said its director of communications, Michele Lemons. The park district urges the public to enjoy our beaches safely by entering the water only when lifeguards are on duty (beaches officially close at 7 p.m. Labor Day for the season) and respecting the flag system that notifies beach goers of current water conditions, said Lemons.

Ald. Maria Hadden (49th) has been vocal regarding the life ring need. After the one on the pier was removed Monday morning, she went on social media and asked that people please call the park district at (312) 742-7529 (menu option 1, menu option 3) and leave a message with its board in support of the safety devices.

"We've been demanding life rings for a couple of years and they keep telling us their lawyers say they're concerned with liability," Hadden said in a post. "We're concerned with saving lives. Rogers Park residents installed a life ring last week since the park district wouldn't."

Since we're talking about water here, dare I say that the park district is all wet?

A "vibrant spirit" with a solid future

Miguel—the eldest of three boys—lived on the South Side, and it's still unclear what brought him all the way to the Rogers Park lakefront early that morning. What is clear though is how utterly devastated his family

is. He leaves behind his parents, Maria and Miguel and two younger brothers, Joel and Samuel, as well as grandparents and a loving high school sweetheart.

After receiving a scholarship, Miguel had been scheduled to leave this week for an Ivy League school, to the prestigious Columbia University, in New York. He'd arduously waited out the pandemic and was ready "to take the streets of Manhattan by storm," his mother wrote on a gofundme page that was set up to cover funeral expenses. (The funeral was Monday. As of Tuesday morning, more than \$66,000 had been raised). Miguel was going to major in Economics and minor in Political Science, with hopes of attending law school afterwards, said Estefania.

He'd attended high school at St. Ignatius College Prep, where he learned to love rowing and became a dedicated member of the rowing team.

"Miguel was the boy who made it despite the odds," said Estefania. "He was a great success story of hard work and a love for education."

"He grew up and lived on the South Side of Chicago," Estefania continued. "He had hopes of making it out of the neighborhood and into New York City. He was overjoyed when he was accepted. He spent every summer in high school as a caddy in Nantucket in a program that allowed him a college scholarship."

"He could talk to anyone," Estefania added. "He was extremely personable. He was also very goal-oriented. He had wanted to go to an Ivy League since elementary school."

The life ring installation was a tiny little silver lining to this dark, dark cloud. But the park district blew that when they took it down. There was also new signage, which when I walked down Tuesday morning was also gone. But we thank whoever put it up.

There were finally clear and visible warnings not to swim off of that pier. But now they're gone. Yet they were and are desperately needed. Two people have already drowned there in as many years.

Tax-weary Chicago homeowners review 2020 exemptions

Second of two articles on property taxes.

Tax-weary Chicago homeowners—especially seniors—are strongly advised to put on their bifocals and carefully read the 2020 second-installment tax bill that arrived in their mailbox last week.

In an effort to pump up tax collections, Fritz Kaegi, reform-minded Assessor of Cook County, is cracking down on those who took legal tax breaks - called "exemptions" - illegally.

Under law, every property owner who resides in his or her home is entitled to a Homestead Exemption. Owners over 65 years of age are entitled to a Senior Exemption. If a senior's annual income is less than \$65,000, he or she also may qualify for a Senior Freeze.

Reportedly, the Assessor's staff have removed tens of thousands of Chicago Homeowners and Senior Exemptions, and the Senior Freeze. The Senior Freeze is especially cherished by elderly retirees surviving on a fixed income because they know that their tax bill will not go up every year.

Last week's Home Front column shirttail previewing this column said: Two Chicago homeowners' tax exemptions mysteriously disappear and their bills skyrocket.

On Aug. 24, a day after the first article of this two-part series was published, the Assessor issued a two-page press release asking: "Homeowners: Are you missing exemptions on your property tax bill?"

The press release said: "If a homeowner believes they are entitled to an exemption that is not reflected on their tax bill, they can apply for what is called a Certificate of Error. The Certificate of Error process provides homeowners an opportunity to obtain missing exemptions for up to three prior years, in addition to the current tax year. Homeowners can now apply for the 2020, 2019, 2018 and 2017 tax years."

The Assessor's release was accompanied by an elaborate graphic of a typical 2020 tax bill showcasing a "Tax Calculator" and breakdown of how the three exemptions reduced the sample tax bill by \$1,598—from \$2,372 to \$774.

Certificate of Error applications with copies of supporting documentation can be filed online, by mail or in person. Visit: www.cookcountyassessor.com/exemptions.

On the Assessor's website, click on the "Exemptions" icon, scroll down to "Certificates of Error" and follow the prompts. For the standard Homeowner Exemption and the Senior Exemption property owners will be asked to upload a scanned copy of their driver's license, and Docu-sign an Occupancy Affidavit.

Warning: for the "Senior Freeze" you may need help from your accountant to verify net income and other financial numbers from your 2019 federal income tax return. In addition to verifying that your net income is under \$65,000, there also will be an Occupancy Affidavit to sign.

"Homeowners are strongly encouraged to apply online as representatives of the Assessor's Office can easily provide updates on the status of applications," the release said.

This year, many exemptions were "auto-renewed" to make the process more convenient for homeowners, the Assessor said. Apparently, in many cases exemptions were mysteriously "auto-removed," causing a spike in taxes and an uprising by many irate taxpayers.

So, always remember to double check your property's exemptions, especially if your taxes are escrowed and paid by your mortgage lender.

Here are two examples of how missing exemptions impacted the final tax bills:

• **North Park:** The owner of a two-story frame home near Legion Park received a 2020 bill of \$11,833, up a whopping 33% from the \$8,890 paid in 2019 when three exemptions were in place. Close analysis showed the \$2,943 tax increase was directly due to "lost" Homeowner and Senior Exemptions, plus a deletion of the homeowner's qualified Senior Freeze.

• **Irving Park:** The owner of a stucco bungalow in the Villa Historic District received a 2020 bill of \$10,145, up a hefty 7.3% from \$9,447 in 2019. Analysis showed the increase was directly due to "lost" Homeowner and Senior Exemptions.

The Homeowner's exemption recently was increased to \$10,000 from \$7,000, and the Senior Exemption was hiked to \$8,000 from \$5,000. Those amounts are deducted from the equalized assessed value of a home to which tax rates are applied in order to determine the individual tax bill.

Also, more seniors can qualify for the Senior Freeze because the Illinois Legislature recently increased the maximum annual income to receive the freeze to less than \$65,000 from less than \$55,000. "The property-tax bill is determined by four factors: the assessment, the equaliza-

tion factor, or 'multiplier,' the tax rate and the exemptions," said Michael Griffin, a Chicago real estate tax appeal attorney.

However, predicting a hefty property tax increase when the 2021 bill arrives in 2022 really centers on two wild cards—the tax rate and the state equalization factor, which can't be challenged by taxpayers.

The equalization factor, or "multiplier," is established each year for Cook County to bring property tax assessments in line with other parts of Illinois. The factor is determined by the Illinois Dept. of Revenue.

The main engine that drives up property-tax bills is the amount of money spent by local government. For example, homeowners who read their 2020 tax bills will see the continued increased spending for schools and police, firefighter and teacher pensions.

Property owners who think they are over assessed should appeal now, Griffin advises.

The Assessor is now working through the appeals process for 2020. For 2020, all of Chicago is being reassessed.

Check your mailbox for Second Installment property tax bills, nearly 1.8 million bills in the mail

Cook County Treasurer Maria Pappas has mailed out nearly 1.8 million Second Installment property tax bills. Payments are due Oct. 1.

The new bills will bring the total amount billed countywide for 2020 to more than \$16.1 billion, an increase of more than 3.4% from last year. A recent analysis by the Treasurer's Office found the tax increase is hitting commercial property owners and Black and Latino suburban property owners the hardest.

Taxpayers also may use the website to search for \$72 million in available refunds going back 20 years and to verify property tax exemptions, which can lower the tax bill. Homeowners may be missing out on \$43 million in exemptions.

To search for refunds or missing exemptions, visit cookcountytreasurer.com and select the purple box labeled "Your Property Tax Overview." Search by property address or enter your Property Index Number (PIN), or the results under "Have You Received Your Exemptions in These Tax Years?"

Late payments are charged 1.5% per

month, as required by Illinois law.

According to data produced by Cook County Treasurer Pappas, businesses in Cook County and Black and Latino suburban property owners are bearing the brunt of 2020's property tax increases, according to a first-of-its-kind analysis of tax bills by her office.

The county will collect more than \$16.1 billion in property taxes this year. That's an increase of \$534 million, or more than 3.4%, from last year. Second Installment bills were posted online August 12 and will be mailed to taxpayers later this month.

The analysis, along with more than 100 pages of detailed tables on suburbs, townships and Chicago, is available at cookcountytreasurer.com.

Key findings include:

- Commercial and industrial property owners in Cook County – in its suburbs and in Chicago – are carrying a heavier share of the increased tax burden. Businesses are being billed more than \$7 billion, an increase of \$410 million, or 6.2%. Homeowners are being billed \$8.9 billion,

an increase of \$114 million, or 1.3%.

- Property tax increases are hitting majority Black and Latino communities – both their homeowners and businesses – the hardest. These communities make up six of the top 10 areas with the largest tax increases for homeowners and seven of the top 10 increase for commercial properties.

- In the south suburbs, where taxes are already greater than in other parts of Cook County, some property owners are paying three to five times as much in taxes as the owner of an equally valued property in Chicago.

"Our research shows that inequities in the property tax system persist, particularly for businesses and Black and Latino property owners, and especially in the south suburbs. The 2020 property tax increases are exacerbating financial stresses in these communities and thwarting economic progress and generational wealth-building," Pappas said.

Not all property owners will see their bills increase because a number of factors determine property taxes. For 2020,

the Assessor's Office lowered the assessed values of many properties elsewhere in Cook County, citing the economic effects of the COVID-19 pandemic. The value of all residential properties was reduced by about 10%. Not all commercial properties received COVID reductions.

Elected leaders in several suburbs increased the overall amount taxed, meaning property owners in those communities will see much higher bills.

The analysis found commercial and industrial property owners generally will see bigger increases in their bills than homeowners, as the overall tax burden continues to shift to them. The higher taxes come as many businesses continue to struggle with a loss of revenue as a result of the COVID-19 pandemic.

In 2020, business properties in the south and southwest suburbs took on another 1.5% of the tax burden, compared with a 1.1% shift from residential to commercial in the north and northwest suburbs and a 1.3% shift from residential to commercial in Chicago.

Four Montrose Harbor bridges to be rebuilt

Last week the City of Chicago Plan Commission voted to approve a \$20 million rebuilding of four pedestrian bridges in Lincoln Park at Montrose Harbor that separate pedestrians from truck and car traffic.

Those bridges include the Montrose Ave. bridge over the pedestrian path south of the Cricket Hill; the Wilson Dr. bridge over the pedestrian path north of the football/soccer field; the Simonds Dr. bridge over the pedestrian path just west of Montrose People Beach, and the Simonds Dr. bridge over the pedestrian path just west of Montrose Dog Beach.

The four were originally constructed in 1936 and Chicago Park Dist. officials claim that their concrete support structures have deteriorated to the point that they need to be shored up.

The City says that the bridges' original limestone facades and other ornamental flourishes will be recycled and re-installed on the new structures. New lighting will also be added, and the pedestrian underpasses below the bridge will receive new curbs and pavement.

The Chicago Dept. of Transportation [CDOT] says construction is expected to start in the spring of 2022. Work should be completed by 2023.

Residents who live near Montrose Harbor may wonder why they've heard nothing from the city about the coming bridge work. According to Chicago Architecture, that may be because of an interesting technicality in the city's ordinances.

Generally speaking, anyone embarking on projects in Chicago that are large or special is required to send a letter to the neighbors letting them know about the plans well ahead of time. In this case, CDOT is required to tell anyone within 400 feet of the bridges. Since the bridges are deep inside Lincoln Park, the only entities that had to be notified were the Chicago Park District, and the Dept. of Asset and Information Services.

Investigation launched after cop attacks woman walking her dog at beach

Chicago's police oversight agency is investigating after a Chicago police officer physically struggled with a Black woman who was walking her dog at North Avenue Beach Aug. 28. The incident was captured on at least three different phone videos, including one made by the woman herself — before the cop knocked the device from her hand, according to her lawyer.

A number on top of the officer's squad car indicates that he was assigned to CPD's traffic enforcement unit, which patrols Lake Shore Dr., and would not typically be assigned to a beach security assignment, according to a person familiar with the department's operations.

Nikkita Brown went to the beach with her dog around 12:12 a.m. and was approached by the officer because the park was closed, according to a statement from her attorney, Keenan Saulter.

Brown asked the cop to stay six feet away due to her concerns about COVID. Saulter said she told the officer during the initial interaction that she and the dog were leaving the park.

Another video, filmed by someone inside a vehicle shows the cop "shooing" Brown away from the beach before he appears to grab for her phone and then grapples with her for more than a minute as she screams.

Saulter said the videos show the officer "violently attacks her for absolutely no reason. He attempts to tackle her, all while groping her body as she screams for help. This unprovoked attack lasts for approximately two minutes, during this time Ms. Brown's phone is knocked from her hands and she is knocked out of her shoes.

"Ms. Brown saw a group of approximately four White people walking some distance behind her, but in view of this officer just prior to the beginning of their engagement," Saulter's statement said. "This was an obvious case of racial profiling."

Brown went home and called 911. A sergeant from the 18th (Near North) District responded and took her report, according to Saulter.

The CPD said in an Aug. 29 tweet that it "is aware of a video circulating on social media regarding an incident involving a Chicago Police officer and a woman walking her dog at North Avenue Beach. CPD promptly referred the matter to @ChicagoCOPA when we became aware of the incident."

One critical, another injured in separate shootings downtown

A man is in critical condition after a woman shot him on a street corner in the heart of River North Aug. 29, police said. Earlier, another man was shot multiple times as he drove with family members on Wacker Dr. in the Loop.

In the most recent case, a 32-year-old man was shot by a woman during an argument on the 400 block of N. Clark around 10:21 p.m. Aug. 29, police said. Witnesses told police the altercation began at Illinois and LaSalle, where the woman pulled out a gun and fired shots. She then followed the man to the corner of Clark and Hubbard where

High on drugs, man drove wildly through Mag Mile before crashing into DIOR's 3,000-pound security window

The man who allegedly drove recklessly through the Mag Mile neighborhood before crashing into the DIOR store, 931 N. Rush St., on Aug. 26 received probation last month for a case that started as a home invasion in which he held a knife to a 77-year-old woman's throat after he drove recklessly through Logan Square, according to court records.

"He grabbed the knife, and he ran towards me, and he grabbed me by the neck right here, and pulled me to the floor," the woman told CBS2 news after the Dec. 2019 incident.

Regarding Friday's episode, prosecutors said Adrien Gutierrez, 35, was high on cocaine and benzodiazepines when he began driving erratically through the downtown area around 11:30 a.m.

He drove his red Camaro the wrong way down several streets, jumped a curb while doing a U-turn, narrowly missed several pedestrians as he drove down a sidewalk, struck an occupied car, and then plowed into the DIOR store's 3,000-pound reinforced display window.

After causing \$250,000 to \$300,000 worth of damage to the boutique, he ran into the store and pulled the fire alarm before he tried to disarm one of the Chicago police officers who rushed in to arrest him, according to the allegations.

Police and witnesses allegedly saw a "white powdery crust" on Gutierrez's face.

Prosecutors charged him with felony counts of attempting to disarm a peace officer and criminal damage over \$100,000. He is also charged with

she fired again, striking the victim in his back, according to a preliminary CPD report.

Police officers in the area who heard the gunfire saw people running and responded quickly, which allowed them to place the woman into custody and recover a firearm on the 100 block of W. Kinzie. Witnesses identified her as the shooter, according to a CPD statement. Charges are pending.

The victim was taken to Northwestern Memorial Hospital in critical condition. Online records show a Des Plaines address for the man, but his current residence could not be immediately verified.

Investigators found several shell casings at the scene of the initial confrontation on LaSalle. Another casing and blood drops were seen outside Boss Bar, 420 N. Clark. At least two cars were damaged by gunfire, according to a passerby.

Loop shooting

A 21-year-old was in good condition after someone shot him while driving on Lower Wacker Dr. at Michigan Ave. around 12:30 a.m. Aug. 29, according to police.

The man was driving with his pregnant girlfriend and another passenger when someone opened fire on their car from a silver BMW, police said. Another motorist stopped and drove the victim to Northwestern Memorial Hospital for treatment of gunshot

several misdemeanors, including resisting, reckless driving, leaving the scene of a property crime accident, and driving under the influence of drugs.

According to a Chicago police officer who spoke at his bond court hearing, Gutierrez remained hospitalized Sunday for a heart condition and blood on the brain.

Judge Charles Beach said state law prohibited him from holding Gutierrez without bail. Instead, Beach ordered him held in lieu of \$350,000. Gutierrez would need to post \$35,000 to get out of jail.

Beach also ordered Gutierrez held without bail for violating the probation he received for the Logan Square incident on July 7.

In that case, Gutierrez was accused of crashing his pickup truck into several parked cars and then forcing his way into a senior citizen's apartment after he ran from the scene.

Once inside the woman's home, he grabbed a knife, held her by the neck, and forced her to the floor. He then allegedly ran from the home and began taking off his clothes.

Prosecutors originally charged him with home invasion with a dangerous weapon, aggravated battery of a senior citizen, aggravated assault of a senior citizen, resisting, leaving the scene, criminal damage, and criminal trespassing, according to CPD records.

On July 7, he pleaded guilty to a single count of aggravated battery of a senior citizen in exchange for the probation sentence, prosecutors said Sunday.

Area Three detectives are investigating the case.

In addition to Sunday's shootings, police have confirmed several cases of shots fired without injuries in the downtown area over the past two weekends. At 2:55 a.m. Aug. 28, shots were fired between cars near Lake Shore Dr. and the Chicago River, according to witnesses. Police found an SUV abandoned on the drive near Ontario with several people running away from it minutes later. Shell casings were found inside the truck, which was riddled with bullet holes, and a gun was found at the scene, according to a CPD report. Cops found even more shell casings on the roadway.

About an hour later, just after 4 a.m., police officers reported hearing about 18 shots fired in River North. Cops found shell casings from two weapons, including a rifle, near the intersection of Orleans and Hubbard.

Shots were fired in River North several times between 3 a.m. and 4:30 a.m. last Sunday, Aug. 22, according to police records. One bullet went through the window of a hotel guest room on the 500 block of N. State, according to one report. Another bullet went through the window of a 10th-floor apartment on the 300 block of W. Superior. In another case, a man reported that someone began shooting at him on the 300 block of W. Chicago.

Other people reportedly saw a man walking around that area shooting at people without provocation. And a driver called police after someone shot the windows out of his SUV on the 300 block of W. Chicago, too. No arrests were made.

Driver who struck three Lakeview pedestrians, on probation for killing 93-year-old woman

The driver of a BMW SUV that struck two pedestrians, then circled back and struck a third person before crashing into a fence in Lakeview Aug. 29 is identified in CPD reports as the same man who recently received probation for striking and killing a 93-year-old woman with a BMW SUV in Edgewater.

Two crash reports filed after Sunday's incidents identify the driver as Rayon Allen, 32. One report lists his home address on the 5500 block of N. Kenmore in Edgewater while the other says he lives on the 3800 block of N. Broadway. And, according to CPD records, the SUV involved in Sunday's crashes is the same car that fatally struck the woman in 2018.

Without identifying the driver by name, Chicago police said in a media statement that a man and woman, both 39, were crossing the street at Irving Park and Broadway when they were struck by a BMW around 12:49 a.m. The driver made a U-turn and headed south on Broadway, where he struck a 55-year-old bicyclist who was trying to help the first two victims.

The BMW then crashed into a fence on the 3800 block of N. Broadway, and officers arrested the driver at the scene, police said. A CPD crash report said the BMW ran into a fence at Gill Park and also crashed into a fence at a BP station while making the U-turn.

Police said the 39-year-old woman and the 55-year-old man were taken to Advocate Illinois Masonic Medical Center in critical condition with head trauma. The 39-year-old man was taken to St. Francis Hospital with leg pain while the driver was treated for bruises to his face at Masonic. The crash investigation is still underway, and no criminal charges have been filed as of 11 a.m., according to Officer Roberto Garduno, a CPD spokesperson.

Two traffic crash reports secured by this reporter list the driver as Allen and say the BMW X5 involved in the incident was uninsured. According to the reports, the 39-year-old pedestrians live at separate addresses in Lakeview, while the bicyclist lives less than two blocks north of the crash scene in Uptown.

Allen recently received 30-months probation after pleading guilty to reckless homicide for striking and killing 93-year-old Lorraine Campione as she walked in the 5500 block of N. Sheridan on Sept. 24, 2018.

Police said two other drivers yielded to allow Campione to cross a driveway around 11:20 that morning, but Allen made an improper left turn in his SUV, overtook a vehicle on the left, and hit Campione.

Police said that Allen continued to drive forward after striking the elderly woman, which caused her body to become wedged under the front left driver's side tire. Allen got out of his SUV and tried to remove Campione by pulling on her leg, according to witnesses. When that failed, he allegedly tried to take other motorists' cars. That also failed.

The BMW involved in Sunday's crash is the same BMW that killed Campione, according to vehicle identification numbers shown in CPD reports from the two cases.

Just a few months ago, Judge James Obbish sentenced Allen to probation and ordered him to participate in a "victim impact panel" after Allen pleaded guilty to reckless homicide with a motor vehicle. Obbish also or-

dered Allen to submit to random drug tests, provide a DNA sample for indexing, and get permission from authorities before leaving the state.

One of Sunday's crash reports said the "driver [was] arrested on suspect DUI," but finalized blood alcohol testing results were unavailable.

Warning issued after intruders claiming to be cops knock down doors on North Side

Twice in the past week, residents on the city's North Side have been startled by the sounds of strangers trying to knock down their doors while claiming to be police officers, according to a community alert from Area Five detectives. No injuries have been reported in the two cases, which occurred miles apart.

According to the alert, the first incident unfolded around 9:46 p.m. Aug. 21, at a home in the 3300 block of W. Grace. The victim heard knocking on their apartment door and voices outside saying they were police officers, the alert said. Police found the apartment's back door pried open.

Some may say the victim was victimized twice because it took more than 45 minutes for a police officer to become available to respond to their 911 call for help, according to CPD dispatch records. Understaffing and "backlogs" of calls for emergency responses are plaguing the city's neighborhoods, which have been stripped of patrol officers by CPD's current leadership.

Then, a similar incident was reported more than five miles west around 5:51 p.m. Aug. 25 in the 3800 block of N. Oketo. A man called 911 after voices outside yelled, "Police! Police!" while trying to knock down his door, according to the alert. The victim found his door open and the hinges broken, but the men were gone.

"Bump-n-run" auto theft crew strikes again in Lakeview

A bump-n-run auto theft crew struck again in Lakeview Aug. 27, according to a CPD report, but they weren't able to drive the victim's car away.

It's the latest in a series of similar auto thefts and attempts last week. One of the earlier thefts took place just a block away from the scene of Friday's incident.

A 34-year-old woman told police she was driving south on the 3100 block of Inner Lake Shore Dr. when a black BMW tapped the rear bumper of her white Jaguar around 11:30 a.m. Aug. 27. When she got out to check for damage, two young men jumped into her car and tried to drive away with it. But, for some reason, they couldn't get the car to move. So, they bailed out and fled in the BMW.

The woman was not injured. Witnesses told police they saw a couple of women recording the attempted auto theft as it happened, but the ladies were gone when officers arrived.

According to a CPD report, the people who tried to take the woman's Jaguar were two Black males between 16- and 23-years-old. One had short braids. The other had an Afro hairstyle and wore navy pants with a bright red stripe on the side.

Pulp fiction convention rockets into Chicago

Convention celebrates 20 years of early adventure stories

You may have certainly heard of Spider-Man, Batman, and Luke Skywalker but much of their inspirations go back to the days of “pulp” which included characters like Doc Savage, The Shadow, and Flash Gordon, respectively.

These earlier icons will be honored along with all the other larger than life heroes of the pulps at the 20th Windy City Pulp and Paper Convention which will be held Sept. 10-12, in Lombard's Yorktown Center.

The three-day event draws hundreds of aficionados from all across the country to celebrate this uniquely American form of popular literature. Attendees hear from pulp-fiction historians, see original vintage pulp art displays, watch films adapted from the great pulp stories, bid on rare pulps and pop culture artifacts

and peruse over 150 tables of hard-to-find collectibles including rare issues of such seminal publications as Adventure, Astounding, Black Mask, Doc Savage, The Shadow, Spicy Detective, Weird Tales, and thousands more. In addition, pulps, paperbacks, and other vintage material will be for sale in the dealer's room.

Friday night's auction contains 200 lots from the estate of Robert Weinberg, including many Weird Tales issues. Saturday night's auction contains material from the estates of Glenn Lord (for many decades the literary executor for Robert E. Howard's estate) and August Derleth.

Among the rare Robert E. Howard material Saturday night is a copy of his first book, “A Gent From Bear Creek” (1937 by Herbert Jenkins), as well as a copy of Clark Ashton Smith's “Ebony and Crystal” (1922 in an edition of 500, with this copy being inscribed by Smith to Robert



E. Howard). Perhaps even scarcer than “A Gent From Bear Creek” are approximately 210 issues of “The Summit County Journal” from June 23, 1967 to Dec. 31, 1971. This newspaper serialized many of the Breckinridge Elkins stories in the late 1960's and early 1970's.

Pulp magazines are inexpen-

sive fiction magazines that were published from 1896 through the 1950s, which thrived in the years between the two World Wars, vied with radio and the movies as the era's most popular form of mass entertainment. These periodicals, printed on coarse pulpwood paper and boasting eye-grabbing, often lurid cover paintings, introduced to the American reading public such immortal writers as Dashiell Hammett, Zane Grey, Raymond Chandler, Ray Bradbury, L. Ron Hubbard, Robert E. Howard, H. P. Lovecraft, and Robert Heinlein.

The term “pulp” derives from the cheap wood pulp paper on which the magazines were printed; in contrast, magazines printed on higher quality paper were called “glossies” or “slicks.”

In their first decades, pulps were most often priced at 10¢ per magazine, while competing slicks cost 25¢ a piece. Pulps were the

successors to the penny dreadfuls, dime-novels and short fiction magazines of the 19th century.

Modern superhero comic books are sometimes considered descendants of “hero pulps” and widely recognized as the inspirations for such pop-culture mainstays as Star Trek, Star Wars, and virtually every comic-book hero from Batman to Spider-Man to Zorro (who originated in the pulps).

That struck a chord with me because I've always loved that line from that song and have somehow tried to live by it.

And those are my Charlie stories. Nothing too exciting, but they sure were to me. Two talented, smart men died last week... one young, one old. Both were beloved by many. We join their families in mourning and send our sincerest condolences.

Alleged Lakeview package thief charged with year-old Red Line robbery

A man who's currently facing burglary charges for allegedly stealing packages in Lakeview earlier this year has even bigger problems to deal with after police recently recognized him as the person who robbed a CTA Red Line passenger on the North Side over a year ago.

In February, prosecutors charged Demetrius Robinson, 19, with burglary after a man who lives in an apartment building on the 700 block of W. Belmont allegedly saw him and an accomplice raiding packages in the mailroom.

Robinson was carrying a backpack that contained items missing from open pack-

ages cops found in the mailroom, prosecutors said. According to the state, he ripped through boxes and took their contents while the accomplice worked as a lookout.

Now, prosecutors have charged Robinson with robbing a man on the Red Line near Thorndale on the evening of July 10, 2020.

During a bond court hearing this week, Assistant State's Attorney Darryl Auguste

said the victim was going home on the Red Line when two men boarded the train along the way.

Both men demanded the victim's money while punching him in the face and body near the Thorndale station, according to Auguste and CPD records. They took his phone, credit cards, and headphones, then exited at the next stop.

Auguste said CTA surveillance cameras recorded the attack and investigators circulated images of the robbers to police across the city.

At least one of those officers recognized Robinson from an earlier arrest, so detec-

tives included his picture in a photo line-up that they recently presented to the robbery victim. The victim picked Robinson out of the group, Auguste said.

Robinson has no adult felony convictions, but he was convicted as a juvenile of two robberies and a burglary in 2017.

Judge Charles Beach set bail at \$50,000, meaning Robinson must post \$5,000 to get out of jail. If he does post bond, he'll be required to go onto electronic monitoring, Beach said.

it's "normal."

At 5:53 a.m. Aug. 15, a ShotSpotter gunfire detection system alerted an officer in a CPD nerve center on the West Side to 14 rounds fired at 5156 W. Fullerton. The cop notified the dispatcher, who repeated it. "Fourteen rounds fired. 5156 W. Fullerton on the corner." A minute later, "shots fired" calls started coming in from citizens. Thirty seconds later, a "person shot" call at the same location.

But the dispatcher never assigned the call to anyone. She didn't have anyone to give it to.

"Fire's on scene at that shooting," an officer assigned to the local district's front desk said four minutes after the ShotSpotter alert. "We got a car available or no?"

"Negative, sir," the dispatcher said. "We don't have any... Are they out of roll call yet?"

"They haven't even started roll call yet."

At 5:59 a.m., a sergeant tells the dis-

patcher he'll head over to the shooting from the station. Five minutes after that, another officer heads that way.

The victim, a 38-year-old man, was critically wounded, police would later say.

Every single police district, even the city's most violent, has lost significant numbers of officers since Brown took over as superintendent in April 2020.

Sometimes entire shifts are being handled by fewer than 20 cops. After we reported last month that the Central District, which includes the Loop and South Loop, was being patrolled by just 18 cops on a recent shift, we received a copy of the next night's schedule for the district. There were only 13 cops working the streets that night.

The city's second-worst police district for murders and shootings, Englewood, has recently operated with a third of its beat cars idle due to lack of staffing, according to schedules reviewed by this reporter.

While Brown's decision to move beat cops to citywide units is a big part of the de-

partment's problems, CPD's overall workforce is falling sharply, too — from 13,011 cops when he started to about 12,200 cops this month, according to the city's inspector general.

To help fill the gap, Brown is pulling detectives away from their cases at least two days a week to babysit high-crime corners and, yes, walk around the Lollapalooza festival.

"This has been happening for months with no end in sight," an officer said. "Each of the five areas is being forced to do this."

"Detectives are falling behind on investigations," the source continued. "It might not seem like a big deal, but some detectives are deployed out three or four days of the week. Cases aren't given the proper attention needed." Photo line-ups and searches for video evidence are critically delayed, the cop said.

That officer's claims are supported by stories this reporter has received from violent crime victims directly.

One victim of the July robbery spree couldn't believe his ears when — several days after he was held up at gunpoint — a detective finally got in touch with him and offered an apology for the delayed follow-up.

"He was assigned to other duties and was not serving as a detective for the entire week," the victim told us. "Lollapalooza? I didn't ask."

No one has been charged with any of the robberies.

A recent carjacking victim asked a news staffer this week if he should expect to hear back from detectives quickly. Our guy told him not to get his hopes up.

"You weren't kidding," the man wrote back a few hours later. "[His auto maker] called us to say they're tracking the vehicle, but beyond verifying the car is stolen, nobody at CPD will assist or even take location data. They were told 'the guys handling carjacking don't work Sunday or Monday, call back tomorrow.'"
