Zoning approved for Big Deahl Dayton St. development

Zoning has been approved for the updated Big Deahl development, generally located at 1450 N. Dayton St.

The v-shaped project site is bound by N. Kingsbury St. to the west, W. Blackhawk St. to the north, and N. Dayton St. to the

Structured Development, who built the nearby NEWCITY development, is in charge of the proposal. They plan to update an existing planned development, and the project will produce four separate buildings. The site will be divided into five sub-areas for the four buildings, with the final sub-area holding a privatelyowned public space.

The underlying zoning for the lot is now C2-5 and ultimately a planned development.

The first building will consist of a 27-story mixed-use building rising 299'-tall. It will be rooted with retail space on the ground floor, hold 110 parking spaces, and 327 dwelling units.

Designed by GREC Architects, the structure flanks the street with active uses on the ground floor. Parking and service areas are placed in the back, screened from the park with art and land-

Topped by a green roof, the 27-story market-rate project will utilize a variety of materials in the design. The different facades relate to the surrounding neighborhood, while different colors connect to surrounding buildings. The materiality changes with the height of the building. Materials at the base are rendered in a smaller scale, while larger scale materials are used at the top of the tower.

The second structure will rise five stories. Also designed by GREC Architects, the residential building will hold 36 dwelling units and rise 64' with 36 parking spaces in the base of the structure.


Hancock unit owners hear harrowing details of gunshot on 57th floor

A gunshot heard on the 57th floor of John Hancock Center on Jan. 29 left two bullet holes inside a condo unit and a condo association scrambling to get information to frightened owners.

At about 8 p.m., a resident of a unit on the 57th floor called down to the building's doorman to report "a loud noise" the resident believed was a gunshot. When maintenance workers arrived at the unit, they found bullet holes in two walls.

At an emergency meeting of 175 E. Delaware Place Homeowner Assoc. on Feb. 8, property manager Jennie Kobzarev gave a detailed report on the incident. She said when police arrived at the Hancock Center residences at 8:19 p.m., they first met with the residents of the unit in the lobby



At 9:23 p.m. Jan. 29, the Chicago Police Department's SWAT team arrived at the John Hancock Center after a shooting was reported on the 57th


and then went up to the unit with the building's chief engineer and a maintenance worker.

Is Land of Lincoln being cancelled?





Forty one monuments, sculptures, commemorative plaques and artworks on the public way in Chicago - 27 on the North Side - are now being considered for cancellation by City Hall bureaucrats and social justice activists.

Chicago activists say some public art is 'over-simplified, one-sided view of history'

A group of community activists lead an effort to determine what public art is appropriate to display in Chicago.

This group calls their effort the "The Chicago Monuments Project [CMP]," and they hope to engage with various communities to question the appropriateness of public art on display in Chicago. Their website claims they hope to "bring the perspectives required to do this work on behalf of all Chicago's people."

As many saw last summer, monuments, plaques and memorials have become a focal point for conversation, protest, violence and activism in Chicago.

Almost all the objects selected and city officials are now dedicat- for consideration by the CMP ing their time and experience to were created between 1893 and memorative plaques and artworks the late 1930s. Their origins can be traced to the World's Columbian Exposition, which brought hundreds of sculptors, architects, and artisans to Chicago to design and construct an image of Chicago that aligned with the culture of the day.

> City Hall has now created a 30person committee to review the city's collection of monuments and recommend solutions. Cochairs include Cmsr. Mark Kelly, Chicago Dept. of Cultural Affairs & Special Events, Bonnie Mc-Donald, CEO of Landmarks Illinois, and Jennifer Scott, a public historian and curator.

Out of a collection of over 500 monumental sculptures, comon the public way and in Chicago parks, 41-pieces of public art have been identified for public debate. Twenty-seven are located on Chicago's North Side.

The committee is inviting local citizens to review the artworks that have been identified, suggest others, and share opinions on the role of monuments in Chicago's public spaces.

These sculptures have been criticized by some activists for their romanticized and reductive images, or are considered prime figures for reaching back centu-

History is not about mind reading or the judgments of thoughts

Is anyone asking themselves why Mayor Lightfingers is still mayor of Chicago?

I was no fan of Rahm Emanuel, but looking back, he's lookin' good. China will be lucky to have

What is it that makes our current mayor so appealing? Is it the quality of her live press conferences? Her brilliant strategies for handling the pandemic? Her defensive bridge raising to dispel rioters? Her uncanny ability to resolve any issue regarding Chicago Public School teachers? Her quick denials that her staff continue to run out her office door to the private sector?

Or her spending over \$280 million in federal COVID-19 money on the Chicago Police payroll?

Her savvy resolve to topple historical statues of American statesmen and military heroes who lived outside our present cultural and historical context?

What a colossal failure she has been.

What a tragic political low-watt bulb she has turned out to be.

Did she really work as a federal attorney?

Chicagoans recently were told that among the 41 public statues awaiting "comfortability" votes, four were American presidents. Abraham Lincoln (16), George Washington (1), Ulysses S. Grant (18), and William McKinley (25).

Yes, that's right. Two favorite sons from Illinois who saved the Union when all seemed lost. Lincoln and Grant.

And Lincoln then doubled up to save the 14th amendment, forbidding slavery by the Constitu-

tion, itself. Lincoln worried that his Emancipation Proclamation could be undone by a post war Congress. He insisted that the issue of slavery had to be ended by the Constitution, once and for all.

His getting the amendment passed was his greatest triumph.

So I am uncomfortable letting any committee be judge as to Lincoln's suitability for heroic remembrance.

My fear is that there is no suitable "intelligentsia" here in Chicago to knowledgeably act on the issue. Just Lightfinger's stooges

We have only those infected with "Lightfootitis." That's an acute widening of the feet and a narrowing of the mind at the same time.

It makes fair judgments difficult to render. And cannot much withstand the off-kilter understanding of history in our postmodern world. History is not about mind reading or the judgments of thoughts.

Sculptor Augustus Saint-Gauden's statue of Lincoln in Lincoln Park, near the Chicago History Museum, is among the singular artistic treasures of Chicago. And the nation.

Made from life-casts of the dead president's hands and face. You see, art is as profound a judge as history can be. As unrelenting. As unforgiving. The Lightfinger brigade doesn't get this.

With all this pseudo-turmoil spinning, I turn the saga around to Larry Hoover. The infamous convicted Disciples street gang leader. Hoover has been in prison for some 50 years. Some say that he led a busy life on the inside as a gang don orchestrating power beyond his prison confines. His influence was mighty, as if he never left the West Side of Chicago. Allies stress that he was often in isolation. That prison for him was unfair. Imagine the good he could have done from the other side of the cell door. Perhaps the long prison stretch has given Hoover a deeper artistic aesthetic. Is this what reformer columnist Mary Mitchell has in mind when she raises the "unfairness" issue? Or does she want him to simply walk out of the prison yard, free of what crime has cost him in personal freedom?

Is this something more than the Sun-Times trying to increase subscriptions among the incarcerated set? For some time the Sun-Times has followed Hoover's career choices, saying perhaps he deserves a fairer shake. Brutes are often misjudged. Their intentionality is often suspiciously suspect.

Hoover reminds me a lot of my pal Prince Ernst of Hanover. The Hanover family could easily be sitting on the throne in Britain today if they weren't Roman Catholic. Prince Ernst is currently suing his son, another Prince Ernst, because he made some tax deal on some castle his father gave him. The deal forgives a 27 million Euro tax bill still owed the German government.

The senior Prince Ernst doesn't like deals with Chancellor Angela Merkle's government. So he's out to stop junior.

The senior prince is still married to Princess Caroline of Monaco. Grace Kelly's daughter. The Prince is a direct descendant of King George III of England. "Mad King George."

We need an election before the mayor blows up Lincoln like he's Kaiser Bill on a horse.


And Grant becomes a dead ringer for a Japanese war criminal, Tojo.



Happy one year anniversary to Honeybear Café

Despite pandemic restaurant survives and gives back



Heart of the 'Hood

When Prudence Faklaris and her husband, George, opened the Honeybear Café in East Rogers Park in Feb. 2020, getting a table was nearly impossible due to the crowds waiting to get a taste. It was exactly what the neighborhood had desperately needed, a place serving a hot, fresh and delicious breakfast and lunch. Neighbors, including me, were jumping for joy.

The Faklaris' had begun to renovate the restaurant the prior November, yet they decided not to advertise their plan but to open "quietly" to introduce themselves "organically."

However, Rogers Parkers had a different plan and showed up to support them and check them out the moment they opened, which was on a Wednesday, said Prudence Faklaris.

"We were embraced almost immediately and by the time the weekend came word spread like wildfire and we had lines out the door. We ran out of food. It was electric and magical," she said.

"It was so exciting to see something you have worked so hard to achieve take off right out of the gate. We will never forget how lucky we were to have landed in Rogers Park because if not for this awesome community... because what came next was terrifying."

You can all probably guess what Faklaris is talking about. The "terrifying" COVID virus that has caused restaurants to shutter and close throughout the city for almost a year now.

Four-and-a-half weeks after opening they were told to close up. "It felt like a joke at the time but as we all know now it was anything but," she said. "However, Rogers Park showed up for us again and rallied behind us and have been oh-so supportive."

The couple had settled on the site at 7036 N. Clark St. after being approached by the previous owners, Pete & Mary Frominos, who had owned A&T Grill for 40 years. They had raised their own family there, and one of their sons was a childhood friend of George's so there was a decadeslong tie to the restaurant.

"We didn't have too much knowledge of the neighborhood prior to taking over the restaurant but we were very intrigued by the charm of the location," said Faklaris. "The restaurant spoke to both of us and it just felt right."

Prudence and George had met in a restaurant setting, and it was their passion and dream to own a place together and watch it grow. "We got to work on the remodel immediately and poured our blood, sweat and tears into it. It needed a facelift which we gave it and put our own spin on it by incorporating things we both like."

The makeover resulted in a clean, inviting, and homey place where folks like me can relax and enjoy either a regular meal like bacon and eggs, or something far more fancy or unusual such as the crazy-delish sounding RP Strong Biscuit, a hearty loaf biscuit stuffed with Andouille sausage and crumbled chorizo, griddled with jalapeño and onions then topped with two eggs over easy, smothered in house-made chorizo gravy and sliced avocado atop crispy hash browns.

And the charm really doesn't stop at the food and décor because Honeybear is truly a family affair, which adds to its appeal. If you happen to be there on a morning when the adorable Faklaris children are hanging around, you might meet nine-year-old Dimitri, seven-year-old Nick, or Olivia, who is five. It sets Honeybear apart from the few other breakfast/lunch joints in the 'hood.

So they're open just a month, and the pandemic lockdown hits. We've seen what the economic lockdown has done across the city, destroying long-standing businesses. Can you imagine just opening a place and then having that ton of bricks fall on you?

But that didn't stop the Faklaris'. They sprang into action. Although they had obviously just undertaken a huge responsibility and had bills to pay and a family to support, shortly after COVID hit, they began feeding the people on the front lines.

They first started with the staff at St. Francis Hospital in Evanston on a weekly sometimes biweekly basis. "We wanted to do more so we partnered with a company called Off Their Plate who worked with restaurants to get food to other front line workers," Faklaris said. "We filled several orders multiple times a week."

Since then, with the help of the Rogers Park community, Honeybear Café has donated more than 24,000 meals to organizations and hospitals such as Evanston Family Health Center, Helping Hands and St. Mary's Little Sisters of the Poor, Mercy Hospital, Lawndale Christian health centers, Jessie Brown VA Medical Center, Swedish Covenant Hospital, Sarah's Circle and Breakthrough Urban Ministries, to name a few.

"We are constantly in fear of closing and it's been a real struggle but we try to remain hopeful and positive that we can weather the storm and make it," said Faklaris. "It's like a game of Chess. We just try to maintain giving high quality food for a fair price and kids always eat free to help our families during this time."

Pretty generous for a restaurant that was only open a month when a pandemic struck, don't you think? This was not an already established eatery doing all this giving. This was and thankfully still is a mom-and-pop shop, newly opened.

Many thanks to Honeybear Café. Really.

Faklaris said there's one person in particular that she doesn't know how to thank enough, Belia Rodriguez, president of the Rogers Park Business Alliance. Rodriguez made sure that Honeybear had a website and built one

for them in a day. "She truly is an angel on Earth," said Faklaris. "She made sure we could sell egift cards and just was there for us and still is."

These days, Honeybear continues to give back to its community. The restaurant just launched a Rewards Program to encourage people to use their website when ordering as opposed to Grubhub and Uber. For every dollar spent you earn a Honey buck. Once 100 Honey bucks are collected, you receive a code for \$10 off. You also get \$10 off for birthdays and \$3 off for liking and following its social media pages. They are also collaborating with artist Kristianna Jacques and collecting for a kid's art supply donation drive for the children of Rogers Park. There is a contactless donation box in Honeybear's entryway and supplies can be dropped between 8 a.m. and 2 p.m. Wednesday through Monday.

There are a lot of restaurants out there but Honeybear seems so intent on giving back even when they too have challenges. It's heartwarming to see someone being so generous when they are faced with their own set of circumstances.

"Honeybear is truly a labor of love and sometimes that's all you need," said Faklaris. "We have poured everything we have into it and it is an extension of our family, our livelihood, and we love it so much. We hope that comes across. Our goals are to keep fighting to make it to the warmer months so we can have indoor and outdoor seating again. We

are working with the Love Fridge Chicago to set up a refrigerator outside in our parking lot to help keep the community that is less fortunate fed -- it's like those free libraries you see except with food. Take what you need, leave what you can type of thing. We are really excited about that."

"We can't believe a year has passed by already, so much has happened in the year it feels longer, but we are truly blessed to have made it to the year mark especially with the challenges 2020 has brought," continued Faklaris. "We love our family-run operation and hope to be a staple in Rogers Park for many years."

We hope so too. Here's wishing Honeybear Café a long and successful Rogers Park run. We thank them for all they continue to do in our community.

Get over there and check out their savory food, their welcoming ambiance, and their friendly, big-hearted owners if you can.








Police Beat

Cops seek 2 men in River West apartment party slaying



On Feb. 21 Chicago police detectives released surveillance images of two men and a vehicle that they've linked to a Sept. 2020 murder at a short-term rental apartment party in River West.

According to the police, the two men in the images and Patrick Clinton, 34, attended a party in a nightly rental unit at 728 N. Morgan until around 3:20 a.m. on Sept. 12.

Police said the suspect seen dressed in a black hoodie with a gold Air Jordan logo pointed a gun at Clinton as he left the party and the suspect seen wearing all black clothing tried to grab Clinton

When Clinton pulled away from the second man, the suspect in the Air Jordan sweatshirt fired two rounds, killing him, according to police.

The two offenders then drove away in a gray or silver sedan, investigators said.

prevention agents who tried to stop him from stealing \$215 worth of booze from a Target store in the Loop.

Prosecutors charged Kenneth Hall, 54, with two counts of aggravated robbery and false impersonation of police during a bond hearing Jan. 18.

Around 2:15 p.m. Jan. 17, a Target security guard intercepted Hall as he tried to leave the store at 1 S. State with stolen alcohol inside two Target shopping bags, according to a CPD report.

Hall pulled down his sweatshirt to reveal a sweater bearing a CPD insignia and told the security agent that one of his "officers" paid for the booze, prosecutors said. Hall, who allegedly didn't have a receipt, then turned away and tried to walk out a different door.

When another Target employee confronted him at the second exit, Hall put his hand in his sweatshirt, indicated that he had a gun, and threatened to shoot the security guard, prosecutors said. The first loss prevention agent arrived as that was happening and both guards backed away thinking that Hall had a gun.

The confrontations were allegedly captured on store surveillance video.

Police found Hall at the Roosevelt Red Line CTA station with Target shoppings bags containing liquor nearby, according to CPD and pros-

ecutors. A Chicago Police Dept. uniform shirt was also found discarded

Hall allegedly told cops that he got the insignia and sweater from either a thrift store or his grandfather. He has never been a police officer.

Judge Susana Ortiz set his bail at \$5,000. He is required to go onto electronic monitoring after he posts the \$500 deposit required for his release from jail.

They were identified as the offenders involved in an Sept. 12, 2020 incident in which a 27-year-old male victim was shot in the chest in the 3600 block of S. Rhodes. The offenders were placed into custody without incident and charged accordingly.

Catalytic converter thefts skyrocket as precious metal values soar

Catalytic converter thieves, the scourge of car owners across Chicago. have been a problem for years. And reports indicate the crime is becoming more popular and more lucrative thanks to skyrocketing precious metal prices.

No you haven't arrived at a CNBC business report in error.

Here's what's up.

You probably already know that converter thieves use saws to remove catalytic converters from under vehicles and then sell the devices at scrapyards or on the black market for \$100 to \$200 each. The converters, which reduce harmful emissions, are especially valuable because they contain small amounts of expensive metals.

The price of one of those metals, palladium, is currently selling for nearly \$2,400 per ounce. Five years ago, it was trading for \$500.

Another metal inside the devices, rhodium, is even more expensive: \$23,400 per ounce currently, up from less than \$2,000 per ounce five years ago. Last year alone, rhodium prices increased more than 3000%, according to Hagerty, an automotive news

Legitimate scrapyard operators are required to get identifying information from people who sell catalytic converters, so thieves typically turn to the black market to move their inventory. And the prices being paid are rising along with the precious metal

SUVs have been popular targets in Chicago because the vehicles' high clearance makes it easier for thieves to crawl underneath with a saw.

Hagerty reports the Toyota Prius is "particularly attractive" to thieves because the cars run cleaner than most vehicles, so the precious metals in their converters are less depleted than standard cars.

The odds of being hit by catalytic converter thieves are still relatively low, but the cost of replacing a stolen one is increasing. Hagerty ballparks

the current repair price at between \$2,000 and \$3,000.

Lakeview package thieves charged with burglary

Two men are facing burglary charges after police caught them with stolen packages in Lakeview on Feb. 13, according to prosecutors.

A man who lives in an apartment building on the 700 block of W. Belmont called police after seeing two men opening packages in the mailroom and taking contents from the boxes, prosecutors said.

Police searched the area for men who matched descriptions provided by the witness. Cops arrested Demetrius Robinson, 19, and Malik Shaw, 22, nearby about 10 minutes later. The witness allegedly identified them as the two people he saw stealing packages in the mailroom.

Robinson was carrying a backpack that contained items missing from open packages cops found in the mailroom, prosecutors said. According to the state, Robinson ripped through boxes and took their contents while Shaw worked as a lookout.

Prosecutors said Robinson has no adult felony convictions, but he was found guilty of robbery as a juvenile. Judge Charles Beach set his bail at \$5,000 and ordered him to stay in the house from 7 p.m. to 7 a.m. if he can post a \$500 bond to get out of jail.

Shaw has a pending gun case, according to prosecutors. Beach ordered him held without bail for violating the terms of bail in that case. The judge set his bail on the burglary charge at \$10,000 and ordered him to observe the same curfew if he becomes eligible to post bond.

Man gets 6 years for robbery while on electronic monitoring

A Lincoln Square man has pleaded guilty to committing an armed robbery in Uptown while he was supposed to be on 24/7 electronic monitoring for another armed robbery.

In Nov. 2017, Ayuub Ararsa was accused of committing an armed robbery in West Ridge. Prosecutors charged him with two Class X felony charges of armed robbery, two felony counts of burglary, two felony counts of unlawful restraint, and two felony counts of aggravated battery with a deadly weapon. A judge initially ordered him held without bail.

Just two months later, though, Judge Mary Brosnahan allowed him to go home on electronic monitoring by posting a \$10,000 deposit.

Then, in Aug. 2018, Ararsa was still on electronic monitoring when he and Sean Rosario allegedly robbed a 17-year-old at gunpoint of \$130 cash and a pair of Beats headphones in Up-

"Give me everything you got," Ararsa allegedly told the boy while taking the headphones from around the victim's neck.

Rosario, with a handgun at his side, warned, "Don't try to follow us. We'll shoot you," police said.

Rosario was 18 and Ararsa was 19 at

Driver of stolen car jumps into Chicago River to escape cops, gets rescued by CFD

A Hickory Hills man sped away from cops on the Mag Mile in a stolen car Feb. 20, crashed, and then tried to escape from police by swimming across the icy Chicago River, according to a CPD report.

"But for the actions of the Chicago Fire Dept., he probably would have drowned in the cold water," Judge Charles Beach said during a

Police said they tried to stop a car for a minor traffic violation on the 800 block of N. Michigan around 9:30 a.m. But the driver sped away, struck another car, sped west on Chicago Ave., and eventually out-distanced officers who were following it, prosecutors

CPD officers continued to track the stolen car via the city's sprawling surveillance camera network until it crashed into an embankment just

the time of the second robbery.

Police responded to the boy's 911 call and immediately located Ararsa and Rosario in Ararsa's backyard. Ararsa was arrested on the spot, his ankle monitor still attached to his right leg. Rosario ran from the yard but was arrested nearby. Police said they found the victim's headphones in an alley close to Rosario and \$250 in Rosario's

Prosecutors charged Ararsa and Rosario with one count of Class X felony armed robbery with a firearm each.

Ararsa has now pleaded guilty to aggravated robbery in both crimes. Judge Brosnahan sentenced him to four years for the first hold-up and six years for the one he committed while on electronic monitoring.

But the sentences will be served concurrently and reduced by 50% for good behavior. Plus, he'll receive 1,041 days credit for time spent in jail and on electronic monitoring before entering his plea.

With all discounts applied, Ararsa is scheduled to walk out of prison on Nov. 12.

Rosario also pleaded guilty to his role in the second robbery. Brosnahan sentenced him to six years, too. He'll also receive a 50% sentence reduction plus 933 days credit for time spent in jail. Rosario remains in Cook County custody, so the state has not yet estimated his parole date.

Attempted robbery charge filed in Streeterville attack

A man who's charged with stealing a woman's phone and kicking an arresting officer in his groin a week before Christmas was charged Wednesday with battering another woman in a robbery attempt in Streeterville that same week.

"When I get out of these handcuffs," James Killingsworth allegedly told an officer who arrested him on Dec. 19, "I'm going to beat your b*tch ass." He then kicked the cop in his personal parts, according to prosecutors.

Now, Killingsworth is charged with punching a woman in the face during a robbery attempt in Streeterville two days before the incident that landed him in jail.

On Wednesday, prosecutors said a Chicago police officer who had "previous interactions" with Killingsworth identified him as the assailant from surveillance photos that detectives circulated recently as they investigated the newly-charged crime.

east of Goose Island.

Prosecutors said Al-Shamali jumped out of the crashed car, hopped into the nearby Chicago River, and tried to swim across. Police called in the fire department and marine units to pluck Al-Shamali from the frigid waters.

According to police, the owner of the stolen car left it running while she ran into a grocery store recently. It was gone when she came back out. Cops said they found the keys and a prescription bottle bearing Al-Shamali's name inside the crashed car. A BB-gun pistol was in a holster on the back seat.

Al-Shamali spoke up during his bond court hearing to say the BBgun wasn't his, it just happened to be on the back seat.

"Sir, I don't need any help, thank you," his assistant public defender, Courtney Smallwood, cautioned.

After being advised of his right to remain silent, Al-Shamali told officers, "Why don't you shut the f*ck up?" But he didn't offer any further insights, according to prosecutors.

Judge Beach set bail his bail at \$5,000. Al-Shamali will need to post \$500 to get out of jail before trial.

According to prosecutors and police, a woman was walking in the 400 block of

E. Ontario whenKillingsworth ran up, punched her in the face, and tried to take her phone around 3:15

p.m. on Dec. 17. The victim wrestled with Killingsworth, 26, and managed to maintain control of her property, prosecutors said. She then allegedly watched as he ran into a nearby Buena Beef and then a 7-Eleven store.

Detectives later obtained surveillance video from the two businesses and sent images of the attacker to cops in a "seeking to identify" bulletin. At least one officer identified Killingsworth from the footage. But, prosecutors said, the victim was unable to identify Killingsworth in a photo line-up last month.

Killingsworth has been held in lieu of \$25,000 bail since prosecutors charged him on Dec. 20 with trying to steal a woman's phone and battering the cop.

In that incident, a witness stuck out her foot and tripped Killingsworth as he ran away with a woman's phone on the 1000 block of N. State, according to prosecutors.

A CPD sergeant who happened to be across the street saw what happened and intervened.

That's when Killingsworth allegedly threatened to beat the cop and then kicked him in his groin Assistant State's Attorney Bob Groebner said during a December bail hearing.

When Judge David Navarro listened to the state's allegations in December, he noted that the alleged crime "seems different than just a theft." The judge suggested that the incident might be properly classified as a more serious robbery

On Feb. 17, Judge Susan Ortiz gave Killingsworth a recognizance bond in the Streeterville attempted robbery case.

Killingsworth remains jailed on the case that was charged in December.

Snow memories haunted by ice dams from Hell

Chicagoans lamenting about the "Blizzard of 2021" burying our streets, alleys and yards should turn the clock back to their childhoods, when the white stuff was considered a gift from the gods.

In the 1950s and early 1960s on Halsted St. in Old Town, a big January snow was a chance to build a snow fort crowned with a roof of recently discarded Christmas trees. My fort was made from rectangular snow blocks cast from wooden orange crates. The fort even had a window.

If the snow was wet and heavy, it was considered "good packing," which meant it was easy to make great snowballs. Once enough snowballs were stockpiled in the fort, battles could last for days. If you ran out of ammo, the victors rubbed your face in the white stuff.

Halsted St. brats also would volley snowballs from their sunken front yards into the open doors of the "Red Devil" electric street cars that rumbled down that busy street. Occasionally, the conductor would jump off the streetcar, cuss at us, and throw a snowball back

As a young teenager, "skitch-

ing" was considered a great urban sport, especially when side streets were ankle-deep in unplowed snow.

Teen boys would hide behind parked cars on Dayton St. and when a car skidded to a stop at Willow St., two or three lads would stay low and grab a handful of auto bumper and go for a ride without skis that sometimes lasted a half block.

Snow pranks included tying a home-made cloth dummy to a street-light pole and swinging it out into the snow bound street in front of a slowly moving car. Those nasty pranksters probably grew up to be cops, corporate executives, or newspaper writers.

Fast forward to 2021, when

Chicago is reeling from more than 40 inches of snow over the past few weeks. After nine consecutive days of snowfall, the city came within a snowflake of beating the 78-year record established in 1943.

Yet 2021 is no match for the Great Snow of 1967, when cars and buses were frozen in time for days on the Outer Drive. Nor 1979, when Mayor Michael Bilandic's snow crews fell asleep at the wheel. That snow-job debacle led to the election of Mayor Jane Byrne in 1980.

Today, our problems include no U.S. Postal Service mail delivery for up to 10 days, or the controver-

Why is state trying to hide public notices?

Do you want to know what the city is planning for down your block? Is it senior housing, a mental health center or liquor store? A nightclub, fight club or drug rehab center? Or perhaps a taxpayerfunded development? You'll find out first by reading the public notices in the newspaper.

Every year an Illinois legislator proposes a bill to stop public notices from being published in your friendly neighborhood newspapers, and allow units of government to post them to their websites instead.

They must think they are saving taxpayers money, and that this newspaper you're reading is no longer relevant.

This year is no different. House Bill 811 has been filed but not yet been assigned to a committee. As other bills that have come and gone before it, HB 811 is a bad idea. Lawmakers should reject it, as they have in the past.

This newspaper's publisher has put in calls to each State Rep. in our coverage area and written personal letters asking that they oppose HB 811.

Newspapers have played a vital role in providing transparency about government through the publication of public notices. It's worked for more than 150 years.

Now, in addition to print editions, the digital reach of newspapers through their websites and the statewide public notice site run by Illinois newspapers, notifying the public has never been more efficient, effective and impactful. Posting notices to newspaper websites and the statewide site are at no additional cost to government, nor the voter, and is intended to provide even greater transparency and greater public access to these notices.

Depending on the notice type, posting them in this newspaper costs between \$35 and \$41 per week. In total, state and township spending on public notices is about 00.005% of their budget. No that's not a typo, it's a very small amount they pay to be transparent to the voters. And for that money the state gets a certified, 3rd-party independent guarantee that their public actions are being seen by the general public.

The Illinois state government wants to take public notices away from newspapers.

There are nearly 7,000 units

of government in Illinois. Only about half of those units have a website. How efficient and effec-

tive would the government be at reaching the general population of Illinois with a record like that?

Be honest, when was the last time you visited a government website you

were't forced to visit to conduct some obligatory or mandated task? These are not well-read websites; unlike most newspapers and their own news sites that do draw very high traffic.

Units of government are required by statute to post meeting dates, agendas and minutes. Yet, many don't. There are more

than 1,400 townships in Illinois, and the vast majority don't have a website. For the ones that do only

Newspapers have played a vital role in providing transparency about government through the publication of public notices.

It's worked for more than 150 years.

53% comply with the required posting of meeting dates, agendas and minutes. Why would different results be expected from the same government units if they control the posting of public notices?

And what do you suppose the additional costs would be for our governmental bodies to put on new staff and added resources to get 100% compliance? We think it might be more than \$41 a week.

We all know there is money to

be saved by being more efficient. How about taking a realistic look at eliminating the seemingly redundant units of government? Illinois has far more units of government that any other state.

Florida has more than 7 million more residents than Illinois but fewer than a quarter the number of government units. Drainage districts, road districts and mosquito abatement districts could and should become part of the function of county governments.



pers won't reduce taxes. Realistically no unit of government is going to lower its tax levy. So, if the Legislature really wants to lower public notice expense, and ultimately property taxes, it should address the number of governmental entities in the state.

For over 150 years now, local newspapers across Illinois have provided access to public notices and verify compliance by government units. They also serve as a permanent record, in print, of public notices that cannot be altered by a government entity sometime down the road like some Orwellian nightmare.

Like this newspaper you're reading, the majority of the more than 400 newspapers in Illinois are small businesses. Like every other small business, newspapers have been hit hard by the pandemic. Allowing the government to remove public notices from newspapers will make it even harder for newspapers to do what they do best - serve and inform their communities.

Call your State Rep. and tell them you oppose HB 811.

Active uses will be placed along the street in front of the parking. The building's base will rise 17 feet and be faced with masonry. The upper four floors are clad with metal panels. The sides of the building facing the park will be distinguished with brick de-

kept in touch with police, management of Hancock Center's commercial property, and the commercial property's chief of security, who was at the building at the time of the incident.

She says residential management offered to let police into the unit where the gun was fired, but they declined, choosing instead to wait four hours for a search warrant. When the SWAT team finally entered the unit, the occupant was no longer there. Surveillance video was found, showing the suspected shooter leaving the building through a loading dock soon after the gun was fired.

Residents were notified of the incident at 10:28 p.m. by email and automated telephone messages.

"I was hesitant to give wrong information," said Kobzarev at the meeting. "In retrospect now, I wish we had sent the first notice earlier because I started getting emails from the residents asking what was happening."

She says police remained at Hancock Center until about 1:30 a.m.

Suspect's key fob not deactivated

Kobzarev says building personnel have been checking every day to see if the shooter's key fob has been used but they are not allowed to deactivate it.

According to the condo association's attorney, the unit from which the gunshot originated was occupied at the time of the incident by someone who was not the unit

"The owner of the unit determines whether or not the key fob – the access fob - is to be deactivated," said David Sugar, a partner at Saul Ewing Arnstein & Lehr. "It is not within the purview of the association to deactivate a fob when the owner of a particular unit says no, do not deactivate the fob. In this instance, the owner of the unit specifically directed management not to deactivate the fob. So that is why the fob for this unit remains active."

Sugar reassured unit owners that "the door staff have been notified and alerted to contact the police if this particular individual returns to the building and is seen."

The condo association then voted on whether to file for eviction of the occupant of the unit but the motion failed.

The incident has left some residents wondering if their condo association could have done more to inform and reassure

Four unit owners wrote to Barry Bowen on Feb. 5, asking him to resign as president of 175 E. Delaware Place Homeowner As-

"The upsetting events of Jan. 29 and 30 have highlighted the inadequacy of your continued role in the leadership of our HOA," read the letter.

They say Bowen has failed to implement their City of Chicago Emergency Preparedness for High-Rise Buildings procedure plan. For a Category 1 high-rise building

such as John Hancock Center, that would include safety drills twice a year under the supervision of a certified Fire Safety Di-

"Those of us who live in the building have not received guidance on emergency evacuation," wrote unit owners Kathy Gregg, Michael Gregg, Thomas Jenkins, and Dennis Kmetz.

The group also expressed concern about Bowen not residing at John Hancock Center. They say Bowen, who lives in Winnetka, was not at the building as the incident unfolded.

"The full-time residence of the president is both a practical and cultural necessity," they wrote. "Clearly, you regard 175 E. Delaware Place as a hobby or an investment, not as your home."

Bowen responded to similar concerns expressed at the condo board meeting three days later.

"I reiterate that as board president - or we as board members - have no role in an emergency situation," said Bowen. "The board sets policy and works with management to implement policy but management manages the building. Management manages situations. It's not the board's or my role to be involved in that. We have a professional management company that takes care of that."

The owners also complained about police officers not wearing face masks in elevators and common areas of the residential building on the night of the incident. Kobzarev acknowledged this during the Feb. 8 meeting and said she had shared the concern with 18th District police commander Jill Stevens.

ries to a symbol of the country's non-native origins. The CMP is asking city residents to consider monuments and memorials that promote incomplete, distorted, or harmful views of history, and consider having them removed from public spaces.

Their website claims that the CMP "is calling out the hard truths of our history - especially as they relate to racism and oppression. Histories and stories shown in many of our monuments are false and harmful representations that are offensive to many people."

CMP feels telling a "true and inclusive history is important, as is addressing who gets to tell those stories in public space." Their priority now is to address "ignored, forgotten and distorted histories."

"This is an opportunity to recontextualize the existing public art collection and create new work that embraces the stories, people and narratives that have been overlooked. New commissions should embrace a variety of creative approaches including temporary installations, performance, earthworks and artist-driven public engagement."

"The city's public art collection should provide accessible platforms for ongoing dialogue and community building that are sensitive to the diverse needs of audiences that will come into contact with the work. The city's approach to developing new work should prioritize communities with a history of disinvestment, and connect to other initiatives and programs that aim to uplift and celebrate Chicago's neighborhoods."

CPM claims their mission is to "grapple with the often unacknowledged - or forgotten - history associated with the City's various municipal art collections and provides a vehicle to address the hard truths of Chicago's racial history, confront the ways in which that history has and has not been memorialized, and develop a framework for marking public space that elevates new ways to memorialize Chicago's history."

The project plans to catalogue monuments and public art on City or Park District property; appointing an advisory committee to determine which pieces warrant attention or action; make recommendations for new monuments or public art that could be commissioned; and create a platform for the public to engage in a civic dialogue about Chicago's history.

The committee says they will publish their recommendations on the existing mon-

uments and new work to be developed.

Some activists feel these pieces of public art reveal the realities of living in a rapidly growing 19th-century industrial metropolis, and presented a highly idealized and orderly vision for Chicago in which traditional neo-classical architecture and sculpture was integrated into a well-manicured, natural setting.

Constructed on a heroic scale and designed to overwhelm, the buildings and sculptures paid tribute to an idea of Progress, placing the Western tradition, Western Europe, and America at the apex of world civilization.

Today, many activists have a different interpretation of progress.

Some members of the CMP committee think the art from the World's Columbian Exposition attempts to align itself with great European empires, past and present, that set the terms for monuments for the next 50 years. They claim that many of Chicago's monuments were based on mythologies of the City's founding that posed white explorers, missionaries, armed forces, and settlers against the indigenous tribes and nations of the region. They claim that art patrons of that time were also responsible for an "idealized representation of American statesmen and military heroes."

CMP has identified for public discussion art pieces they feel promote a narrative of white supremacy presenting inaccurate and/ or demeaning characterizations of American Indians, memorializing individuals with connections to racist acts, slavery, and genocide. They think some pieces present a "selective, over-simplified, one-sided views of history," and do "not sufficiently include other stories, in particular those of women, people of color, and themes of labor, migration, and community building."

They blame the art pieces for creating tension between people who see value in these artworks and those who do not.
