

LEGAL NOTICE TO PROPERTY OWNERS

This legal notice includes a list of properties of real estate on which 2016 property taxes (due in 2017) are delinquent and subject to sale as of February 15, 2018.

NOTE: This list may include some properties on which the taxes were paid after the list's preparation on February 15, 2018. It is the property owner's responsibility to verify the current status of payment. This list does not include all the properties in Cook County that are delinquent and subject to sale. For a complete listing of the properties in your neighborhood that are subject to sale, please consult your neighborhood newspaper.

Under Illinois law, the Cook County Treasurer's Office must offer properties having delinquent real estate taxes and special assessments for sale. **IF YOUR PROPERTY IS LISTED IN THIS NOTICE FOR SALE OF DELINQUENT REAL ESTATE TAXES, IT IS IMPORTANT FOR YOU TO TAKE ACTION SO THAT YOUR TAXES ARE NOT SOLD.** The tax sale is scheduled to begin **FRIDAY, MAY 4, 2018.** The sale of taxes will result in a lien against the property that will add, at a minimum, hundreds of dollars in fees to the amount currently due. Sale of the tax and continued failure by the owner to redeem (pay) may result in the owner's loss of legal title to the property.

Prior to sale, delinquent taxes may be paid online from your Bank Account or Credit Card by visiting cookcountytreasurer.com. Personal, company, and business checks will be accepted only through April 6, 2018. After April 6, 2018 all payments must be made by CERTIFIED CHECK, CASHIER'S CHECK, MONEY ORDER, CASH, or CREDIT CARD. Please note that under Illinois law, the Treasurer's Office cannot accept payments of delinquent taxes tendered after the close of the business day immediately preceding the date on which such taxes are to be offered for sale.
