## Man sentenced to 65 years for role in River North slaying of off-duty cop

A Cook County judge on March 9 sentenced a man to 65 years in prison for playing a role in the shooting death of off-duty Chicago Police Officer John Rivera in River North two years ago.

Jovan Battle, 34, apologized to Rivera's family before being sentenced by Judge Michael Clancy. Prosecutors never accused Battle of firing a gun in the case, only of directing the shooter to the car where Rivera was seated.

Rivera, his girlfriend, an offduty probationary police officer, and a fourth person had just entered Rivera's parked car on the 700 block of N. Clark when they were shot around 3:29 a.m. March 23, 2019.

The group was heading home after spending time together at Stout Barrel House, 642 N. Clark, according to CPD records.

Menelik Jackson and Jaquan Washington, got into a fight with a group of Hispanic men at the former Rock and Roll McDonald's, 600 N. Clark.

According to prosecutors, the parties went their separate ways, but Jackson and Washington went looking for the group and encountered Battle along the way.

When Jackson asked Battle if he'd seen a group of Hispanic guys in the area, Battle directed them to Rivera's car, police said. Jackson allegedly walked up to Rivera's driver's side window and opened fire, killing the 23-year-old off-duty cop and critically injuring a man in Rivera's back seat

There were "no problems, no words were exchanged, no robbery demand, no carjacking demand" before the shooting, now-retired CPD Deputy Supt. Anthony Riccio said at the time.

Battle later told police he helped Jackson because they are both members of the Gangster Disciples street gang.

Jackson and Washington are still awaiting trial.

Jackson allegedly murdered Rivera just two weeks after a judge decided to release him from curfew and electronic monitoring restrictions that he received in an

## Double Door's former landlord can't continue suing city despite 'alleged' aldermanic vendetta

A state appeals panel has sealed off a lawsuit that alleged former Chicago Ald. Proco Joe Moreno illegally targeted a building owner for political retribution after he evicted a popular concert venue.

Brian Strauss owned and operated 1572 N. Milwaukee Ave., where Double Door Liquors was a tenant before it was evicted. After the nightclub closed, the city enacted a zoning ordinance changing allowable use for the property. After a federal judge dismissed Strauss' civil rights lawsuit and remanded the state law claims, Cook County Judge David Atkins dismissed Strauss' challenge to the zoning ordinance and Moreno's conduct.

Strauss appealed to the Illinois First District Appellate Court, arguing his complaint sufficiently alleged the zoning ordinance violated his state law due process and equal protection rights as well as a claim for inverse condemnation, and that the tort claims aren't barred by the Local Governmental and Governmental Employees Tort Immunity Act.

Although the panel agreed with the city's concerns about whether Strauss filed his complaint as an individual or as a representative of the corporation that owned the building, it affirmed Atkins' dismissal on other grounds.

The panel said the question is whether the city had a legitimate interest in changing the zoning and pointed to Strauss' complaint in which he described his problems with Double Door: noise complaints, patron's illicit substance use and property damage.

"A more restrictive zoning classification could be an attempt to prevent those problems from

recurring," Connors wrote. Although Strauss alleged "Moreno was the driving force behind the zoning ordinance," that doesn't preclude new restrictions having broad public benefit.

Strauss' complaint alleged Moreno tried to broker a sale of the building to Double Door or compel Strauss to undo the eviction by threatening to engage in an expensive, drawn-out zoning process that could leave the building empty for at least three years. Strauss further said Moreno had a pending amendment to make zoning more restrictive, which cost him both tenants willing to pay market rate and submarined a \$9.6 million sale contract.

Although Strauss alleged Moreno's conduct, and the fact the zoning change would apply only to his building, were enough

## DePaul sued over facial recognition tech used in online exams

DePaul Univ. has become the latest Illinois university targeted under the state's biometrics privacy law over online monitoring of students taking exams.

On March 3, attorney Brian K. Murphy filed suit in Cook County Circuit Court against DePaul. The lawsuit claims the university violated the Illinois Biometric Information Privacy Act [BIPA], in the way it required students to take exams online.

The lawsuit was brought on behalf of a DePaul student, identified only as John Doe, who is a resident of Cook County.

The lawsuit seeks to expand the action to potentially include all students who took online exams

at DePaul in the last five years.

The lawsuit centers on DePaul's use on the online test proctoring service known as Respondus Monitor.

According to the complaint, DePaul uses the proctoring service, provided through a license with Respondus Inc. to monitor students taking tests remotely. Respondus is not named as a defendant in the lawsuit.

According to the complaint, the system is used by "dozens of colleges and universities in Illinois."

The complaint said the system uses artificial intelligence to monitor test-takers by means of "facial detection, motion, and lighting to analyze the student and examination environment,"

It's 3:45 a.m., and many things encircling my noggin, in slumber and out of it, are getting a needed airing. That's the formula, how good writing works for me. It's important to be able to say that. Or write that.

Today is St. Patrick's Day.

Memories of past St. Patrick's Days fill my heart. And my nose. I cannot think of our national feast without the aroma of roasting leg of lamb filling my nostrils. You know, that pungent, most aristocratic of all kitchen smells that punctuates the late winter air of March 17. Hints of fresh rosemary mingled with the roasting pan filled with celery, carrot and onions. Light on the garlic, please. Potatoes roast beside the leg getting a caramel-colored patina. The onions caramelize as well. I cannot remember a St. Patrick's Day without this smell. My father's gravy fashioned from the glory of the roasting pan was always the highlight of the day. It would put the French to shame. (Did you know Charles de Gaulle's grandmother was from Ireland?)

My mother always created a crowd-pleasing spinach soufflé to accompany the leg of lamb, always served pink in our house.

She also made sure we had plenty of mint sauce. Always two kinds of spuds, roasted and creamy whipped, which my father supervised and fussed over. He did extra duty that day. He was required to ensure there were plenty of Brandy Alexanders for all. They were Grandma O'Connor's favorite.

Later he was expected to provide his celebrated Irish music review when we were sated by the lamb. To this day I am a huge fan of crisp, deep green cabbage with leg of lamb. Not over cooked and cut on the bias, with unsalted butter and fresh ground pepper.

Grandma O'Connor would always bake a buttery supply of her Irish scones. She always brought Irish soda bread with heaps of raisins and caraway seeds, as well as an apple tart (which she called cake) with a fine crust of butter and sugar.





"Five years later, out of the blue, Eric texts me that he's putting up his art for a new Jennifer Garner film that is being produced by Netflix," said Mc-Carty. "They are looking for other artists to create a special scene, and would I be interested in being introduced?

And that's how this all got started.

But none of it would have happened without these connections, or even the broken foot starting it all, said McCarty.







#### 15-time felon stole \$4,950 worth of high-end booze from Tao

A 15-time convicted felon who's on parole is facing burglary charges after he allegedly stole six bottles of high-end liquor worth nearly \$5,000 from a River North restaurant.

"I'm doing pretty good on the second chance program," Mark Anderson, 63, told Judge Charles Beach during a bond court hearing after the alleged heist. Beach seemed unconvinced.

Anderson, whose felony background includes seven burglary convictions, is currently on parole for committing a robbery on the Magnificent Mile.

Prosecutors said he slipped in the back door of Tao restaurant and nightclub, 632 N. Dearborn, as employees prepared to open for service on Feb. 25. He allegedly made his way to the second floor, took six bottles of premium liquor from the bar, and headed for the door.

Two employees tackled Anderson in the alley and held him until police arrived, according to a CPD report. A restaurant manager told police the restaurant's surveillance cameras recorded the whole thing.

Tao's Chicago outlet is one of the high-priced restaurant group's newer locations. Its Las Vegas venture was the highest-grossing restaurant in the country before COVID set in, with sales of over \$42 million a year. The chain's New York City locations are third- and 14th highestgrossing venues in the country.

In Chicago, Tao offers \$23 Chilean sea bass satay, \$17 potstickers, and bottle service options like \$8,000 Remy Martin and \$28,000 Dom Pérignon, according to its menus.

Anderson's defense attorney said he services buses for the CTA. He's charged with felony burglary and misdemeanor battery in connection with the Tao allegations.

Judge Charles Beach set bail at \$5,000. Anderson went home by posting a \$500 deposit bond.

#### Uptown man beat, tried to shoot acquaintance during home invasion, but gun jammed

A man is facing attempted murder charges after he allegedly broke into an acquaintance's Uptown apartment, forced the victim to smoke pot, beat the victim, and then pulled the trigger while pointing a gun at the victim's face, according to prosecutors. But the gun allegedly jammed, and the victim was able to get help when the intruder allowed him to enter Joseph Brennemann Elementary School to pick up a child after class.

According to prosecutors and police the strange tale began March 8 when the alleged victim, age 26, woke up to the sound of Johnny McDowell breaking into his home in the 800 block of W. Eastwood. A relative of McDowell's also lives at the address, prosecutors said, but the victim had only seen McDowell one time before.

McDowell, 32, began to argue with the man about some damage to a relative's car from a year ago and then pulled out a gun that he began waving around while threatening to kill the victim.

He then allegedly punched the victim twice in the face and ordered him to empty his pockets while holding the man at gunpoint. After getting the man's phone, cash, credit cards, Apple watch, and some pot, McDowell ordered the victim to smoke the marijuana with him, prosecutors said.

McDowell allegedly became angry about a comment the victim made after smoking up, and he punched the man in the face two more times before pistol-whipping him in the head twice.

The attack caused the man to experience convulsions, and McDowell threatened to kill him if he didn't stop

At that point, McDowell pointed the gun at the man's face and pulled the trigger. But the gun jammed. Mc-Dowell allegedly cleared the gun, reloaded it, racked the slide, and then placed it on the kitchen table. Shortly be-

School, a fact

that McDowell allegedly confirmed by calling the child's mother.

The men got into the victim's car and the victim drove to the school, 4251 N. Clarendon, while McDowell held him at gunpoint and ordered him not to do anything stupid, prosecutors alleged.

The victim sought help from school staff members when he got inside. Police arrived quickly and found Mc-Dowell sitting outside the school in the victim's Jeep.

Cops recovered the victim's ID, phone, credit cards, and Apple watch from McDowell and found a loaded handgun under the driver's seat, prosecutors said.

Prosecutors charged him with attempted first-degree murder and armed robbery.

"There's something in these facts that just don't add up," McDowell's public defender told Judge Marv Marubio during a bond court hearing March 10.

But Marubio said she thought the allegations were clear and ordered him held in lieu of \$250,000 bail. She also ordered him to go onto electronic monitoring if he can post a 10% deposit bond.

#### Cops questioning "multiple" suspects in weeks-long wave of ATM burglaries, carjackings

Chicago police are optimistic that they have dealt a serious blow to a violent carjacking and ATM theft crew that has struck dozens of times across the city in recent weeks, according to multiple law enforcement sources.

At least four people are in custody after police tracked GPS signals from an ATM that was stolen on the Near South Side March 10, the sources said. Two ATMs have been recovered.

The crew sprang back to life around 1 a.m. March 10 when they apparently stole three SUVs from a car rental agency near O'Hare and then broke into several businesses to target ATMs on the Northwest and Near South Sides and in Bucktown.

Police said two white Infiniti SUVs and a black Range Rover were taken from a car rental agency parking lot near O'Hare around 1 a.m. Cops and witnesses would later report seeing white Infiniti SUVs bearing "fleet" license plates at the burglary scenes.

After getting the SUVs, the crew got to work doing what they've done dozens of times: burglarizing businesses for ATMs and cash registers.

They broke into Christina's Place, 3759 N. Kedzie, around 2:50 a.m. and took the ATM. A white SUV was seen leaving the area.

About 20 minutes later, cops turned

a corner and apparently saw the crew sitting outside their next target, a Mexican restaurant on the 3500 block of W. Montrose. But the crew sped away in their white SUV when they saw police rolling up, officers said.

The next stop was in Bucktown where the crew had a close call as a patrol officer came upon them as they burglarized Bucktown Pub, 1658 W. Cortland. The officer briefly pursued their white SUV westbound on North Ave., but they got away.

One of the ATMs they took was equipped with a tracking device that police followed to 19th Street and Lawndale Ave. When cops arrived at the intersection, they didn't find an ATM, but they did find one of the stolen SUVs abandoned in an alley, sources said.

Law enforcement resources were sent to the area where officials focused their attention on a home located in the 1800 block of S. Lawndale.

Around 8 a.m., police chased two men who walked out of the home. One of the suspects reportedly dropped stacks of new currency as he ran. Both men were caught and arrested.

According to a source, police entered the home and found an ATM on the second floor with a crowbar lying next to it. At least two occupants of the home were also taken into custody for questioning.

Another ATM was found around noontime in an alley behind the 4000 block of W. 26th St. in Little Village. Investigators were trying to determine where it came from.

Cracking the criminal crew has been a priority for Chicago police and the FBI's Chicago field office, which joined the hunt on Feb. 28 after 12 businesses were burglarized in one morning by a group of men who used a carjacked SUV to steal ATMs.

The burglary team has been taking ATMs, liquor, cigarettes, and other valuables during early morning raids for weeks. They struck multiple locations on Dec. 26, 2020, Jan. 1, Feb. 3, 4, 23, 24, 26 and 28.

Investigators have linked them to armed carjackings, including one in which a man was shot at a Northwest Side gas station.

#### "Dent scammer" charged with targeting yet another driver — in Lincoln Park this time

A North Center man who was charged last month with ripping off senior citizens with an auto dent repair scam caused more than \$3,000 damage to a 72-year-old driver's vehicle in a similar scheme last December, prosecutors said this week.

Gino Johns, 27, is now charged with felony criminal damage to property in the new case.

According to prosecutors and a CPD report,

Johns began smearing a paste on the dent to "repair" it, but the damage only got worse, and the victim pulled out his phone to call police.

Both of the alleged scam artists fled in the truck they pulled up in.

#### **Executive used HIV-AIDS charity's money** to pay for divorce, go on "lavish" shopping sprees

The former chief financial officer of a charity that provides housing and other support to persons living with HIV and AIDS stole more than \$300,000 from the organization to pay for her divorce, buy an Audi, and go shopping at high-end retailers, prosecutors said.

A close friend of the woman, who worked as the charity's chief program and development officer, is accused of embezzling a lesser amount.

On March 11, Assistant State's Attorney Paul Kiefer told Judge Charles Beach that the thefts from Chicago

House Social Service Agency came to light after the charlaunched investigaan when its tion top finance officer, Andrea Peoples, was

charged last year with stealing money from her previous employer, Planned Parenthood.

Chicago House, which was founded in the early days of the AIDS epidemic, was three days away from shuttering due to lack of funds when the alleged thefts were discovered, Kiefer said.

According to Kiefer, Peoples stole \$350,142.45 of Chicago House funds through electronic transfers and checking deposits to her personal accounts that were disguised as payments to legitimate vendors. The alleged scam also involved the misuse of a credit card the charity provided for business purposes.

"She had lavish spending habits," Kiefer said as he accused her of using money intended to help LGBTQ community members with health and housing resources to go on shopping sprees at Neiman Marcus, Yves Saint Laurent, and Louis Vuitton.

She put \$12,500 of the charity's money toward a new Audi and used

more to pay for her divorce attorney, Kiefer continued. Chicago House was paying her a salary of \$125,000 at the time.

As the charity's chief financial officer, Peoples was "at least com-

plicit or permissive" in allowing her friend and co-worker, Tijana Timatyos, to \$48,588.47

from the organization for personal

Rather than going toward helping people in need, \$48,588.47 of the charity's funds paid for Timatyos' purchases at Ashley Furniture, Darvin Furniture, and American Mattress, according to Kiefer.

Peoples, 42, is charged with felony theft of over \$100,000. Timatyos, 54, is charged with felony theft over \$10,000.

Neither of them is currently employed, according to their defense attorneys.

Judge Beach set bail for Peoples at \$50,000 and ordered her to go onto electronic monitoring if she posts a \$5,000 deposit bond. He released Timatvos on her own recognizance but said she must also go on electronic monitoring.

Chicago House was days away from closing when it learned of the alleged embezzlement, "that's largely because of Ms. People's representations to the board that they were financially solvent when they clearly were not," Kiefer told the judge.

The charity was temporarily unable to make payroll or rent and they were on the cusp of losing federal grants that fund some of its operations.

truck were similar to circumstances in another incident reported a few days earlier in Lakeview, Assistant State's Attorney Franka D'Antignac said.

Investigators found surveillance video of the reported scam on LaSalle and determined that the victim's car was not damaged before the men "worked" on it, but had visible damage after they were done, D'Antignac alleged. The victim later identified Johns as one of the offenders in a photo line-up.

A U.S. Marshals task force arrested Johns at his home this week. Judge Mary Marubio, noting that the alleged incident took place before Johns was arrested in February, released him on his own recognizance.

The dent repair scam is one of the most prolific schemes in Chicago. But the scammers, who sometimes pocket thousands of dollars for phony dent repairs, are rarely caught.

In the Lakeview incident that reportedly helped detectives identify Johns, two victims, ages 82 and 65, were driving in the 3200 block of N. Lincoln around 12:50 p.m. on Nov. 27, 2020, when he caught their attention in traffic and identified himself as a car dealership employee, prosecutors

He directed them into a nearby parking lot, and an unknown co-offender began smearing green paste on their car's front quarter panel, according to the allegations. He told them to leave the paste on for a day and then demanded \$6,500 as payment, prosecutors said.

Johns then allegedly followed the victims to a bank where the 65-yearold withdrew the money and gave it to him. Later, Johns called the victims

and asked to meet again, prosecutors said.

When they met, Johns allegedly demanded another \$6,000. They gave it to him — and then wrote down his license plate number, which police traced to Johns, according to the state.

Cops arrested Johns last week after the older victim identified him as the scammer who called himself "George," did most of the talking, and took their money. The younger victim allegedly identified Johns in a photo line-up after he was arrested.

Prosecutors said the scammers actually caused over \$1,300 in damages to the victims' car.

Prosecutors charged Johns in February with felony theft by deception from a senior citizen and aggravated battery of a police officer. He has a 2012 conviction for burglary.

"The allegation is that you were preying on two individuals with delicate sensibilities based on their age," Judge Arthur Willis said during Johns' bond hearing last month. He then set bail at \$5,000 and ordered Johns to go onto electronic monitoring if he can post a \$500 deposit bond.

#### How a pandemic changes rental apartment hunting

Rental apartment living in Chicago and across the nation may never be the same again a year after the pandemic.

Traditionally, apartment dwellers are always looking for the best rent deal. However, one year into the COVID-19 virus pandemic "more space" beats "cheaper"

Many cramped apartment dwellers now are hunting for better rental digs with open-air amenities and more living space preferably in the city in which they already reside, according to

a new survey of 10,000 prospects who shopped for an apartment on rentcafe.com. Here are highlights of the survey:

- Lifestyle improvement is the main motivator for those looking to rent this spring. Forty-one percent of renters surveyed said open-air amenities" and "more space" as their most essential apartment features in 2021, outranking by far amenities such as "home office" (5%) or "good internet connection" (10%). Only four percent of renters chose to move because they could now be more flexible by working remotely.
- The reasons for moving are within the same spectrum: "looking for better deals" was the top answer for 29% of renters, followed by "the need for a change of scenery" (25%).
- When asked how the pandemic affected their apartmentselection process, 28% of renters said they prefer a place to live by

themselves. "Something cheaper" (25%) and "something larger" (19%) were next on the priority

- Ninety percent of renters said they are looking for long-term rentals. Moreover, 48% wish to remain in the same city in which they currently reside. This trend shows that improving housing conditions is the goal, not necessarily a drastic change like moving to a different city, noted rentcafe.com.
- Many of those who moved in the spring of 2020 seemed to have done so out of need, not because they wanted to. "Expiring lease" was the main reason for moving (26%) last year, while a significant share of renters was concerned whether they'd be "able to pay rent during this time" (32%).
- Of the survey respondents looking for an apartment to move into now, one-third (34%) had moved once before during the past

12 months—and most of them did so because of pandemic-related reasons.

· Looking at those who are just moving now, 33% said that they didn't move earlier because of the pandemic. This means that 67% of the renters currently looking for a new apartment may be committed to making this change now, regardless of the COVID-19 situation, said rentcafe.com.

#### **Cook County enacts Renter's Ordinance**

Inspired by the tough Chicago Residential Landlord and Tenant Ordinance, the Cook County Board has enacted a new ordinance that imposes scores of new regulations on landlords and tenants in the suburbs.

The new ordinance takes effect June 1 and draws its inspiration from Chicago's ordinance, which has been in effect since 1986.

Owner-occupied buildings with six units or less are exempt from the ordinance, in addition to condominium or single-family homes where the housing provider resided in the property at least one month of the previous 12 months.

Under the suburban Cook County ordinance, move-in fees can be charged only for "reasonably related" costs, and landlords must provide tenants with an "itemized list" of these costs. Late fees are limited to \$10 for the first \$1,000 of rent, plus five percent of any amount above that

The number #1 ranked Whitney Young Dolphins are coached by the legendary Tyrone Slaughter who has multiple state championships under his belt. The Dolphins lead the Chicago Public School's Red-West North division.

Kleinschmidt took over as head coach of then Gordon Tech in 2012. As a student and player at Gordon Tech, he led his Rams, under then head coach, Steve Pappas, to the state title game in

Kleinschmidt went on to star at DePaul Univ. under coach Joey Meyer. Prior to returning to his beloved Gordon Tech, Kleinschmidt coached for a year at York High School in Elmhurst.

I was planning to write about Kleinschmidt's achievements at Gordon Tech/DePaul Prep and about the last boys basketball game in the former Gordon Tech's Tom Winiecki Gym.

Coming into that game, the Brother Rice Crusaders (12-1, 11-1), under head coach Bobby Frasor, had put together an impressive undefeated season and lead the powerhouse Catholic League Blue Division.

I remember meeting her out in Beverly Park for Irish Fest. Carmel Quinn was the immigrants' dream. Beautiful. Lyrical. Poetic. And successful in helping the Irish hold on to a bit of their

to prevent cheating.

However, while the system uses facial recognition technology to analyze student biometric data, the complaint said DePaul implemented the system without first securing authorization from students, and without providing students with various notices concerning its use of the face-scanning technology, that are allegedly required by the BIPA law.

"... Prior to Jan. 21, 2021, the terms of use that students must accept before using Respondus Monitor for DePaul exams say nothing about facial recognition, biometric identifiers, or biometric information, and do not disclose to student users that their biometric identifiers or biometric information will be captured, collected, analyzed, or disseminated to the student's Institution," the complaint said.

The complaint seeks unspecified damages of more than \$50,000. Under the BIPA law, however, plaintiffs are allowed to seek damages of up to \$1,000-\$5,000 per violation. Individual violations can be defined as each time a user's biometric identifiers are scanned.

armed home invasion case.

In July 2017, Jackson armed himself with a handgun he was prohibited from owning and broke into his ex-girlfriend's house in violation of a protective order, prosecutors said. He brandished the gun and threatened to kill both the woman and the couple's four-month-old child, prosecutors alleged.

Afterward, the woman called police and told them where they could find Jackson: He had an appointment that morning for pre-hiring screening at the Chicago Police Academy. Officers arrested him there in possession of a loaded handgun.

Jackson was charged with one of the state's most serious crimes, Class X felony home invasion while armed with a firearm. Other felony charges filed included resi-

evidence to support his equal protection claims, the panel said if a zoning "classification has some reasonable basis, it passes constitutional muster even though in practice it results in some inequality." Furthermore, Connors wrote, the notion "Moreno allegedly advocated for the zoning change out of revenge does not mean that the zoning committee and city council endorsed those motives."

The panel further rejected the argument that zoning changes constituted an illegal taking of property by affecting the building's value, noting a 1980 U.S. Supreme Court opinion in Agins v. City of Tiburon, which established municipal planning done in good faith doesn't warrant compensation.

Though Strauss alleged his business was damaged, the panel said, he didn't allege

One year later, Jackson struck a plea deal. Prosecutors agreed to drop all of the most serious charges if he would plead guilty to one count of "attempted burglary." In exchange, he'd get probation.

He jumped at the deal.

Judge Ursula Walowski ordered him to stay in the house from 7 p.m. to 7 a.m. and to wear a GPS home monitor for six months.

Toward the end of the six months, prosecutors filed a violation of probation after Jackson allegedly allowed the batteries to drain out of his home monitoring system.

When Judge Joseph Claps heard about

an inability to lease the space to a tenant that didn't require the same zoning as Double Door, or that he couldn't find someone willing to pay less than his desired \$35,000 per month. He ultimately sold the building for \$9.1 million, but diminished market value doesn't constitute an improper taking.

Turning to tort immunity, Strauss argued his complaint included allegations regarding zoning proposals the council didn't adopt, and that the city failed to show Moreno "either made a policy determination or exercised discretion when he arranged private meetings to convince buyers to back out of purchase contracts and when he physically confronted plaintiff to make a series of threats," according to Connors.

However, the panel found Moreno acted within the color of his role as an alderman by balancing the interests of his constituents against a property owner. That Moreno

the alleged violation on March 8, 2019, he didn't penalize Jackson at all. In fact, he ended Jackson's curfew and ordered him taken off electronic monitoring immediately.

Two weeks later, Jackson — armed with another gun he was not allowed to have and wandering the streets at 3:30 a.m. — allegedly killed Rivera.

"may have acted corruptly or maliciously does not change" his immunity from litigation as a public official because he was allowed to determine policy and exercise professional discretion.

Moreno was ousted from the City Council by voters in 2019, when he was defeated by current Ward 1st Ald. Joseph La Spata.

After losing the election, Moreno was charged with insurance fraud and obstruction of justice, for allegedly reporting his car stolen, when he had allegedly allowed a woman he was dating to drive away with it the night before.

Earlier this year, Moreno spent a week in the Cook County Jail in January on drunken driving charges stemming from an incident on Astor St. in the Gold Coast that occurred while we was out on bond for those other charges.
