Not so funny

Two of North Side's top comedy spots now up for sale

It is a bad time for comedy on the North Side as two of the most venerable names in comedy have announced plans to put their ubiquitous properties and brands up for sale.

Second City, 1616 N. Wells St., was put up for sale on Oct. 6, reportedly for \$50 million.

As a privately held company it has not disclosed its revenues throughout its 61-year history. It is co-owned by Andrew Alexander and D'Arcy Stuart. Its president, Steve Johnston, also reportedly has a small equity share.

The famous stand-up comedy theater was launched in 1959.

Problems came to light in June at their home stage in Old Town and caused Alexander to announce his plans to remove himself from the famed comedy theater and sell his interests.

Chicago's most famous place for the live comedy theater scene was then devastated by a forced closure after the group of alumni and former staffers came forward with charges relating to issues



Chicago property owners bracing for hefty tax hikes



Mayor Lori Lightfoot's dark vision of the city's 2021 budget deficit skyrocketing to \$1.2 billion is frightening to the average homeowner who will likely see their property taxes used to cover that deficit.

Chicago property owners are financially battered from years of being slapped with higher real estate taxes and municipal fees, so it's not surprising that they are shuddering about what tax increases are on the horizon for 2021.

Mayor Lori Lightfoot's dark vision of the city's 2021 budget

deficit skyrocketing to \$1.2 billion is frightening to the average homeowner who likely will have to dig deeper in 2021 to pay everincreasing real estate tax bills.

Earlier in 2020 the COVID-19 virus spiked the budget shortfall to nearly \$800 million, and the mayor said the deficit would be filled using relief funds, federal dollars, debt refinancing and borrowing.

This bad news comes after ho-

meowners scratched to pay the final installment of the largest property tax hike in Chicago's history—\$589 million phased in over the past four years to pay for pensions for the city's police officers and firefighters.

Analysts say Mayor Lightfoot now is considering a plan to save \$200 million in 2021 by reducing the city's work force of 31,000 full-time and 1,800 part-time employees through furloughs and lavoffs.

Since many city workers are members of municipal unions, the mayor is asking Chicago labor unions to suggest alternatives and measures to help protect workers. Other cost-cutting could come from tapping surplus Tax Increment Financing (TIF) funds.

Chicago property owners will receive the first installment of the 2020 real estate tax bill due on March 1, 2021. Typically, the amount of the first installment is 55% of the last year's total bill.

Dominick St. Bridge plans released

The first major public infrastructure project within the Lincoln Yards development, the Dominick Street Bridge and Dominick Street Extension, is anticipated to begin construction next Summer.

The bridge is an effort to bring significant improvement in traffic circulation, cyclist safety, and pedestrian access to the east side of the river, and will be a rare north/south bridge over the North

Branch of the Chicago River.

The project will extend Dominick between North Ave. and Webster Ave. via North Throop St. This new bridge will feature two 12' wide driving lanes for northbound and southbound traffic, a 10' wide dual direction bike path, and two 10' pedestrian sidewalks on either side of the bridge.

The truss-style arch bridge, de-

Bogus FedEx driver stole \$107,738 worth of phones from Loop Verizon

Things just got real for Romell Funches, the man who prosecutors in January accused of posing as a FedEx driver to steal cellular phone shipments from a Verizon store in the Loop.

Funches was back in bond

court Oct. 11 to hear prosecutors accuse him of committing 17 more thefts from Verizon using the same ruse

a ruse that allegedly netted him \$107,738 worth of stolen phones and accessories.

On Jan. 10, cops arrested Funches after he allegedly dressed as a FedEx employee to steal a phone shipment from Verizon's store at 205 N. Michigan. According to court documents, the pick-up was a trap set by corporate security officials from Verizon and FedEx.

Prosecutors say Funches used to work for FedEx, and he kept uniform parts after he left the

company. He was wearing a FedEx uniform jacket, FedEx uniform pants, and a FedEx baseball hat when they arrested him in January.

The state charged him with felony burglary and felony theft last winter. He went home by posting a \$500 deposit bond.

But investigators continued to look into a series of similar thefts from three Verizon stores between Oct. 23, 2019, and the day he was arrested in January. Their efforts culminated with the filing of 17 additional felonies Sunday.

The crimes were captured on surveillance video, and Verizon employees identified Funches as the thief, according to prosecu-

After hearing the state's allegations, Judge John Lyke told Funches, "you are barred from every Verizon store in the state of Illinois."

The judge then set bail at \$107,738 — the value of the merchandise he's accused of stealing. Funches must post a 10% deposit bond to get out of jail before trial.

What has the quarantine done to you?

When someone is abducted and over time winds up bonding with their abductor, they are said to be experiencing Stockholm Syndrome. So called because of the four employees taken hostage during a bank robbery in the Swedish capitol some years ago. After six days they could only express loyalty to their captors. It was a psychological response to the drama of their being held hostage, like what Patty Hearst experienced.

Now I think I have caught the Stockholm Syndrome.

Pass the Lingonberries, please. After almost nine months of very cautious quarantine, I have gone over to the other side. It sneaks up on you, like a mug of hot Glögg, then bam! You're

Frantic at the weakened condition of my cardiac immune sys-

tem, I have only left my house eryday life. The big things, sure. four times since early March, and two of those were to the doctor's office. I am desperate to stay healthy and largely interact with

Taking my dinner with my upstairs neighbor. No visitors. No fellow painters, old friends or even family. A lot of social media, though. An abundance of non-stop phoning, messaging and emailing. But very little direct or in-person appearances.

Slowly over time everyone starts to look like a Corona spreader. And then, there's my craving for smorgasbord. And King Karl Gustav.

My symptoms have their origins in that isolation and in the more solitary activities of painting, writing and cooking.

Don't get me wrong. These are all healthy activities, the kind people build careers out of, but when put up against a deadly international killer, like a pandemic, they have all the ingredients of witness protection or solitary confinement.

How about you? I know I'm not alone in this. What has the quarantine done to you? What's changed for you?

It's vital to be able to catalogue what's altered for you in your evMaybe way less eating in restaurants, or infrequent attendance at church. Less frequent presence at Wrigley Field. The Saddle and Cycle. Fewer thirst quenchings at Butch McGuire's, pizzas at Pequod's or juicy BBQ ribs at Twin Anchors.

Perhaps this sounds like the recipe for monastery life to you. But maybe it reveals the hidden, more isolated you. The more spiritual you. A different person from the one you're comfortable with. Maybe the person you're becoming in lockdown needs some more time to get used to things. Perhaps there's a side to life for you that actually has gotten used to the slower pace and more quiet isolation.

Perhaps more settled meals at home is starting to become appealing, despite the dirty dishes.

Just maybe breaking up your routine is starting to be healthy. More interesting and calming than you would have thought, despite the worry of catching the virus before a cure can be found.

I've become very good at ordering groceries with Instacart. My pantry is well-stocked. The fridge is full. I even remember to order tin foil, toothpaste and contact lens solution. I look forward to my short chat with the delivery people who are so pleasant and accommodating.

It feels good to be organized and disciplined. When was the last time before the pandemic that we took such methodical control over our lives?

Perhaps this is the real hope to be found in the quarantine. Maybe all is not lost. Maybe some of the change is for the better. If you had told me in March that I would not be eating out in restaurants until September, I would not have believed you. If you told me that I would be at home thinking up exciting home cooked meals for dinner every day, I would have thought you crazed. And I never would believe that I would paint more than 35 new works since Easter. Nor would I believe that I'm way ahead in the research and writing for this weekly column. With a major portion of my cookery book already written and tested. I'd say all that output of energy and accomplishment is really positive. And artistically affirming and very Chicago.

Stay connected. I am taking much more care to keep in touch friends and family. My sister, who's keeping well-quarantined. My pals across the city. My buddies on Facebook. Readers who keep me up to date on what they're doing or what is causing them distress. Mayor Lightfoot, who keeps me on my toes with Chicago's urban mismanagement, and who has, so far, decided to not haul me in for questioning in my severe critique of her executive decisions.

My only regret is the level of quality and civility in the current political discourse. I am grieved at the impoverished thought it presently contains. At the low level of intellect and reason so many display. So much of it is sophomoric. Self-serving adolescent annoyance with little grasp of the true realities of contemporary politics. Just re-warmed cheesy sentiment directed personally at individuals. It's the shame of our nation.

Where is the reasoned thinking that permits disagreement? Why are Americans so paralyzed by emotional disparity that offers no real alternatives to present dilemmas? Do you really think these cultural conundrums are the worst to confront our nation? We go to the voting booths very soon after having experienced great change and unprecedented isolation in our current pandemic.

I wish we could rally our fellow citizens to greater patriotic expressions of civility and reason, which is the legacy of our American Revolution and the legacy of our international interventions and triumphs over the centuries rescuing others from the tyranny of despots.

Maybe our common Stock-

holm Syndrome has led us to the threshold of a more balanced political realism. Perhaps the pandemic has made us more human, more humane. Maybe we can vote in a newer American vision. One that all across the world people less challenged and less free would delight in having available

We have it better than we might think. America is still the noble dream of statesmen and shopkeepers. Fashioned of everyday patriotism and everyday hope. From sea to shining sea.

Cops seek driver who plowed through **Buckingham Fountain fence**

Police are looking for a motorist who crashed through a fence surrounding Buckingham Fountain on Sept. 26.

The fountain itself was not damaged during the 4:48 a.m. incident, but repairs to the southern portion of the fence will cost about \$100,000, police said.

The offender then fled the scene in their black or dark gray General Motors SUV that may be a Chevy Traverse, police said. It sustained damage to its front and sides, including the bumper and lights, according to a bulletin from CPD's Major Accident Investigation Unit.

Two arrested in post-protest incident outside Wrigley Field

It started with Silly String. It ended with two arrests and a felony charge of aggravated battery of police. And the incident was captured start-to-finish on a trusty Wrigley webcam.

A group of about 25 protesters gathered outside the stadium's main entrance Oct. 7 to march around the neighborhood. It was billed as a Black Lives Matter and "abolish the police" rally, but the protest was widely promoted by social media accounts with antifa and anarchist leanings.

After about an hour of marching with a CPD bike team following their every move, the group disbanded on a Wrigleyville side street. And that's where the webcam picks up the story.

Around 8:35 p.m., a small group of people is seen walking south on Sheffield Ave. toward Addison. One of them, a man wearing a white sweatshirt, walks over to an SUV that's waiting for a red light to change and appears to spray something into the vehicle.

A witness who spoke with this newspaper thought it was pepper spray. But it was actually "streamer string spray" — Silly String — CPD spokesperson Kellie Bartoli said. And it allegedly struck the driver in his face. According to Bartoli, the man and the driver, age 40, had been engaged in an argument.

The driver gets out of his car and is heard yelling, "yeah, go run you little f*ggot" as the alleged Silly String attacker runs across the stadium plaza. He doesn't get far. A bike cop has him in cuffs before can get out of the camera's frame.

Then, it gets uglier. As a second officer pedals across the plaza, a man with the protest group drags his own bicycle into the cop's path, causing the cop to crash.

But the cop isn't down for long. He springs to his feet and charges forward, sending the bicyclist and his bike sailing into the side of a nearby planter. Back-up officers place the second man into custody. The officer received an abrasion to his elbow when he fell, Bartoli said.

Prosecutors charged Matthew Sugai, 26, of Avondale with one felony count of aggravated battery of police.

Michael Parks, 25, of McKinley

Park, is charged with misdemeanor battery for allegedly spraying the driver with Silly String. Police said the driver declined to pursue felony charges.

Parks' mugshot was not immediately available because he is only charged with a misdemeanor.

Suspect sought in violent CTA robbery

Chicago police are asking for the public's help as they try to track down a violent robbery offender who attacked a passenger on a Loop subway platform last week.



Detectives released CTA surveillance images of the attacker and the robbery with the hopes that someone will recognize him.

The victim was standing on the Jackson Blue Line platform when the offender kicked and beat him and then took his black backpack at 2:17 a.m. Oct. 6. An ambulance transported the victim to Northwestern Memorial Hospital for treatment.

The robber escaped by boarding a train toward O'Hare, according to a

Disabled man hospitalized by hit-and-run driver in Lincoln Park

A disabled man is hospitalized with serious injuries after a hit-and-run driver struck him in Lincoln Park Oct. 6, police said.

The victim, a 25-year-old man who uses a motorized wheelchair, and his dog were in a crosswalk at Stockton Dr. and Fullerton Ave. when the vehicle struck him around 8:30 p.m., according to a bulletin from CPD's Major Accident Investigation Unit.

Police said the man's wheelchair was struck by a red four-door Toyota sedan that was traveling southbound. According to the bulletin, the driver did not stop after striking the man, and the Toyota continued speeding down Stockton.

CPD did not indicate if the dog was injured in the crash.

Two shot when gunman opens fire on partiers in Lincoln Park

Two men were injured in a drive-by shooting that unfolded in the middle of Lincoln Park steps from Diversey Harbor Oct. 7, police said. No arrests have been made.

The victims, who both have records of contact with Chicago police, were hanging out and drinking with a large group in the 2600 block of N. Cannon Dr. when someone opened fire on them from a passing car at 10:38 p.m., according to CPD and witnesses.

Both men were driven to nearby St. Joseph Hospital in private cars. Police said a 29-year-old man was shot twice in his upper left leg, and a 21-year-old man was shot once in his right calf. Both were listed in good condition.

At the shooting scene, partly-consumed bottles of Modelo were lined up under ribbons of crime scene tape as detectives searched the nearby parkland for evidence. Several shell casings were lying on the ground, and a bullet hole could be seen in a parked car.

Witnesses said the shooter is a Hispanic man who opened fire from a black Nissan Maxima that fled northbound on Cannon Dr.

In July 2019, Chicago police temporarily banned overnight parking along Cannon Dr. after seven people were shot on the nearby lakefront. Town Hall police district leaders and Lincoln Park alderman Michele Smith linked that shooting and other violent crime to car parties along the leafy stretch of road that runs parallel to Diversey

Three weeks later, Smith declared the parking ban an overwhelming success — even though this reporter found there was no measurable change in crime along Cannon Dr. during the parking ban.

Nonetheless, the city subsequently banned overnight parking on the roadway — but only on Fridays and Saturdays between May and Novem-


Man pulled out a gun when Wrigleyville bar cut off service

A Wrigleyville bar manager disarmed an Indiana man who pulled out a handgun when the tavern refused to serve him, prosecutors said. It's the second time in four days that someone from Indiana has been smacked with felony gun charges following disputes at North Side establishments.

Around 11:30 p.m. Oct. 6, staff members at Output bar, 3720 N. Clark, told Dragan Tzanetakos that they

were going to stop serving him, according to prosecutors. Tzanetakos, of Dyer, Indiana, allegedly responded by pulling out a handaun.





The manager flagged down a passing police unit, told them what happened, and pointed them in Tzanetakos' direction. The cops arrested Tzanetakos nearby.

He allegedly told police that he is "allowed" to carry a gun back in Indiana, but authorities could not confirm that claim. Tzanetakos, 33, is not licensed to carry a weapon in Illinois, prosecutors said.

An ambulance transported Tzanetakos to Thorek Hospital for injuries he suffered during the altercation with Output's manager.

Prosecutors charged him with felony aggravated unlawful use of a weapon and misdemeanor aggravated assault with a deadly weapon. His defense attorney said Tzanetakos, who earned a master's degree from Purdue University, has no criminal background.

Judge Arthur Willis said the state's llegations were "very concerning" as he ordered Tzanetakos held on \$5,000 bail. Tzanetakos will need to post a \$500 deposit bond to get out of jail before trial. Judge Willis on Saturday set bail at \$5,000.

Four armed robberies, carjacking in Lincoln Park, Lakeview

At least four armed robberies and a carjacking were reported in about three hours Sept. 6 across Lincoln Park and Lakeview. Two offenders armed with at least one handgun were involved in all of the incidents. No arrests have been made.

Most recently, two men with handguns approached a man in a parking area on the 3200 block of N. Seminary around 11:10 p.m., CPD spokesperson

Karie James said. The offenders demanded the 36-year-old's keys and drove away with his silver Acura SUV.

Three earlier incidents unfolded similarly: The first at 10:24 p.m., two men displayed a handgun and demanded keys from a 55-year-old man as he walked on the 600 block of W. Schubert in Lincoln Park. When the victim told them that he didn't have anything with him, they punched him repeatedly until he fell to the ground, James said. The victim declined medical attention. Around 9:45 p.m., a woman reported that two men pointed a gun at her and demanded the keys to her Jeep Compass near the intersection of Lincoln and Sheffield. The woman did not cooperate with the robbers, and they fled in a darkcolored SUV. The victim declined to file a formal report with CPD. And at 8:45 p.m., two men displayed a handgun and took a man's keys on the 2400 block of N. Racine. But the offenders apparently dropped the keys before getting into the victim's car. They ran to an SUV that was waiting nearby and fled the area, according to initial information.

The victims generally described the offenders as two slender Black males in their late teens to mid-20's who stand 5'-8" to 5'-10" tall. One of them reportedly wore a black hoodie with the word "GAP" on the front.

Shots fired in the heart of the Loop

Shots were fired during an argument between two men in the Loop Oct. 6, but no one was injured, police said. There have been no arrests.

The men were arguing on the corner of State and Madison around 2:05 p.m. when one of them pulled out a handoun and shot at the other, according to CPD. Police said the bullet flew through the front window of a nearby business. A passerby said the business is the Body Shop at 3 N.

The shooter hopped into a darkcolored vehicle that fled westbound on Madison after firing his gun, police said. CPD did not offer any descriptions of the gunman or provide any more details about his car.

Concealed carry holder shoots German Shepherd at Loop dog park

No arrests were made after a concealed carry holder shot another man's German Shepherd at a dog park in the Loop Oct. 9. Fortunately, the pooch survived.

The two men were at D'Angelo Dog Park, 438 S. Franklin, when they began arguing shortly before 3 a.m. Friday. One of them released his German Shepherd, which prompted the other — a concealed carry holder - to shoot the animal, according to Officer Hector Alfaro, a CPD spokes-

An officer who pulled up a police camera feed of the dog park moments after the incident said the animal appeared to be moving around without any noticeable problems. The CPD camera was pointed in a different direction at the time of the shooting,

Police transported the dog and its owner to a 24-hour veterinary hospital for treatment. The concealed carry holder, who lives near the dog park, was released. A simple assault report is being completed this

Man charged with pepper-spraying third CTA bus driver of the year

A Chicago man is being held in lieu of \$100,000 bail after he allegedly pepper-sprayed his third CTA bus of the year. Cook County Judge John Lyke also ordered Erick Robie, 46, to stay away from CTA property if he can post a 10% deposit bond.

"You gotta walk, or get a car, or Uber or something," Lyke said.

The first attack was reported back on March 31. In that case, a CTA bus driver reported being peppersprayed by a passenger as she drove a #22 Clark bus near Devon Ave. in Edgewater, Robie was arrested near-

by after the driver identified him as the assailant, according to CPD records.

Prosecutors charged him with simple battery, and he was

released from the police station on a recognizance bond, police records

Then, early on Sept. 2, a CTA bus driver was pepper-sprayed by a passenger at the Jefferson Blue Line station. Robie was arrested when he returned to the station a few hours later and an employee recognized him as the assailant, prosecutors

Prosecutors charged him with simple battery again, and he was released from the police station on another recognizance bond.

Twelve days later, around 1:45 a.m. Sept. 14, a CTA bus driver was pepper-sprayed as they drove a #22 Clark bus near Lawrence Ave. in Uptown. The driver later identified Robie as the attacker in a photo lineup, prosecutors said.

The state charged him with another count of felony aggravated battery of a transit employee, and police caught up with him Saturday to face the allegations.

Unlike the previous two cases that saw him being released from police stations, Robie was taken to face a judge for a bond hearing this time. Unfortunately for him, his date was with Lyke, who has a reputation for being the least-lenient of the county's six bond court judges.

In addition to the six-figure bail amount Lyke handed down for the latest allegations, Robie will need to settle a \$5,000 bail for a separate arrest warrant before he walks free.

Hefty 2020 property tax bill increases could come due in Aug. 2021, when the second installment of the bill arrives.

Along with paying for the skyrocketing city budget, much of the predicted property tax increase also could depend on the work of Cook County Assessor Fritz Kaegi, who said he has dramatically revamped the assessment process, especially how commercial properties are valued.

Kaegi said he started from the ground up, reworking the assessment formula and drawing on Multiple Listing Service information about sales prices. For 2020, the assessor is re-assessing the south and west-ern suburbs.

Crystal-ball gazing into the outlook for the expected 2020 property tax hike, payable in 2021 is cloudy, tax experts say.

"The property tax bill is determined by four factors: the assessment, the equalization factor, or 'multiplier,' the tax rate and the exemptions," said Michael Griffin, a Chicago real estate tax appeal attorney.

Homeowners also should review their exemptions because they can reduce their tax bill if they have the proper exemptions applied to their tax bill, Griffin noted. The three main exemptions are the Homeowner's, Senior Citizen, and Senior Freeze.

The Homeowner's exemption recently was increased to \$10,000 from \$7,000, and the Senior Exemption was hiked to \$8,000 from \$5,000. Those amounts are deducted from equalized assessed value of a home to which tax rates are applied to determine individual tax bills.

Also, more seniors can qualify for the Senior Freeze because the Illinois Legislature increased the maximum annual income to receive the freeze to less than \$65,000 from less than \$55,000.

"Every homeowner should review their last tax bill to see if they received the proper exemptions and contact the assessor if the exemptions are wrong," Griffin advised.

Predicting a hefty property tax increase next year really centers on two wild cards—the tax rate and the state equalization factor, which can't be challenged by taxpayers.

The equalization factor, or "multiplier," is established each year for Cook County to bring property tax assessments in line with other parts of Illinois. The value is determined by the Illinois Dept. of Revenue.

However, the main engine that drives up property tax bills is the amount of money spent by local government.

Property owners who think they are over-assessed should file an appeal. The assessor and Board of Review have expanded the online filing process so a homeowner can file their appeal without having to visit either office.

signed by Rosales & Partners, is the first of many improvements which are part of the Lincoln Yards development approved last year. The bridge is expected to cost \$35 million, and will take two years to complete.

The bridge is just south of Cortland St., where the river turns east-west. A new Riverwalk section will also be built under the bridge as well.

This bridge will also provide a connection to The 606 trail, allowing for the expansion of safer east-west bike travel. The future 606 will eventually cross Ashland Ave., go under the expressway and railroad tracks, and cross Elston Ave. at the viaduct. Then the pathway will continue east to connect with the new Riverwalk and circle up to Dominick St. via a ramp that will exist in the park on Lincoln Yards South.

Developer Sterling Bay is responsible for extending The 606 to meet Dominick St. and then later to connect it to the lakefront. But the entire project was controversial because the decision was made just prior to a mayoral election and included as much as \$1.3 billion in Tax Increment Financing tax funds for the developer, which will pay for many projects and be reimbursed later from property taxes generated by Lincoln Yards. The deal, negotiated by former Mayor Rahm Emanuel, means that Lincoln Yards will receive nearly all the property tax the site generates for 23 years.

Next year the developer also hopes to break ground on an eight-story, 320,000-square-foot building with office and lab space. Sterling Bay hopes to build as much as 14.5 million square feet of residential and commercial space on the 55 acres along the river.

surrounding Second City's relationship with racial equity, diversity and inclusion. Alumni had criticized Second City's prior reluctance to fundraise for the Black Lives Matter movement without also financially supporting police-related causes.

Alexander's exit was part of the theater's response in trying to salvage the business in a pandemic era.

Their property, acting school, stage, brand and a corporate training business are now up for sale.

Next on the chopping block was the iO (once ImprovOlympic), located along the Clybourn Corridor at 1501 N. Kingsbury St. That theater only dates to 1981, but both iO and Second City theaters are forprofit private operations that share a parallel history for stand-up comedy. Each venue had been closed since the economic lockdown enforced in March. Both groups were starved of box-office and drink revenue due to city and state regulations limiting indoor gatherings as a response to the COVID-19 pandemic.

And iO too had faced internal accusations of racial inequity and demands for change from some former students in comedy classes and also from past performers. Founder Charna Halpern said that she was shutting down the theater permanently in June, stating an inability maintain payment on the overhead, mortgages and property taxes

Unlike Second City, which rents space in Chicago's Old Town neighborhood, iO owns its building. Compass Commercial describes the property as dating from 1929 and offering two main theaters with 140 seating capacity each, two cabarets with 65-80 seating capacity each, six classrooms, two event spaces with 200 seating capacity each, a beer garden with 120 seating capacity and a full bar with over 100 seating capacity in addition to an accessory office and a full basement for dry storage.
