It's the sounds of silence for autumn home buying

'It's crickets out there'

First of two articles on the Chicago home-buying market.

Chicago is far from a wilderness where in the still of the night all that can be heard is the sound of crickets.

But apparently the sound of silence is all that can be heard in much of the city's early autumn home-buying market. Veteran residential brokers call it a "cricket's market."

An informal survey by The Home Front column of several top city real estate brokers in the downtown and North Side neighborhoods revealed that late September and early October open houses vastly went unattended by

Complimentary cookies went uneaten and coffee turned cold in the pot. Colorful helium-filled balloons decorating the front porches of for sale homes gradually went flat, just like the autumn market, brokers said.

"It's crickets out there," said one prominent Gold Coast and Lincoln Park broker. "We have

many attractive multi-milliondollar condominium and mansion listings and there currently appears to be little to no interest by affluent would-be purchasers in even taking a tour.'

There's "radio silence" throughout the city and suburbs-from downtown Chicago to Lake Forest and from Oak Park to St. Charles. The only properties that are moving are priced under \$500,000, observed three city and suburban

Apparently, demand is strong for mid-priced homes and 2-flats to 4-flats, and a few ultra-expensive downtown condos continue to sell, analysts say. However, the existing inventory time for properties with less than 3,000 square feet of space is only three or four months, while the inventory period is eight months for homes and condos with more than 3.000 square feet of living area.

"While the wealthy have an abundance of world-class choices, they are also facing a fiscal crisis, a cap on tax deductions, excessive property taxes, ballooning assessments, and a higher transfer tax on luxury sales," noted Phil



Feds come to the rescue with funds for State/Lake CTA station

Some \$475 million in new federal money will support 70 transportation improvement projects in Chicago, including the State/ Lake CTA station in the Loop.

The money is coming from three federal sources - Congestion Mitigation and Air Quality Improvement Program, Surface Transportation Program, and Transportation Alternatives Program.

About \$59.4 million will help pay for improvements to the State/Lake CTA station, both the platform above State & Lake and the subway, while \$39.2 million will cover replacement of the La-Salle Street Bridge over the Chi-

Another \$28.8 million will go to Metra to retrofit its locomotives with more fuel-efficient and cleaner-burning engines.

"The investments represented in this year's slate of projects will not just improve air quality for every resident of the region, they will improve commute times, safety, provide bikers and walkers access to new trails and spaces, improve bus service, and reduce emergency vehicle response

times," said Chicago Metropolitan Agency for Planning [CMAP] executive director Erin Aleman.

"Working with our partners, we are excited to see this funding begin to improve people's options for getting around and overall quality of life across the region," said Aleman.

CMAP made the announcements on Oct. 10. The 70 projects were selected from 200 proposals submitted between Jan. 15 and March 15, 2020.

What's your last meal?

Like most Chicagoans, your diet is secretly more expansive than just deep dish pizza, hot dogs without the ketchup, Italian beef sandwiches and the odd White Castle. While they may have made Chicago famous, you need more than that for healthy

If you were ordering your last meal, what would it be?

It doesn't necessarily mean a fancy dinner, though turkey with all the trimmings would be a sure winner for me.

Maybe the secret is more a variety of tastes. From a mixed bag of foods. Touching many things savory and mouth watering.

My last meal starts with a really cold bottle of orange-labeled Veuve Clicquot brut. Everything else will fall into place.

A plate of West Coast oysters with tangy and savory ice shavings, with some pink Irish smoked salmon on homemade brown bread with Kerry Gold

butter. And then some really stinky, soft French cheese, like Epoisses de Bourgogne, the kind that is banned on public transportation in France. Then heirloom tomatoes, open faced, on slices of crunchy baguette, drizzled with fine olive oil and basil leaves. Finally, some strawberry and chocolate gelato.

Yes, it sounds more like a final cocktail party than a last meal, but it's rather simple. And no real cooking time involved.

There's such a wide assortment of tastes in this little feast. And it would hardly break the bank, even in a prison. It's all about the flavors, from the brine of the oysters to the acidity of the tomatoes and the smokey oak tones in the salmon that makes the fresh brown bread such a treat, enhanced by the dusty complexity of the champagne.

This "bon voyage" for my money is reasonable and intelligent. Nothing extravagant. But a fitting feast of departure.

For most people there might be a tendency to overdo this last meal, turning it into a feast for hard to find extravagance. The kind no warden would approve. But that "last meal" really should all be about comfort. You know, the foods that calm.

Most of us know the foods that bring us instant peace and genteel tranquility. The morsels that put the eater at ease. The comestibles

that restore some comforting humanity. I don't need oysters for that. I could do it with a plate of very wet, creamy French scrambled eggs... the very purest of foods. The kind of eggs they do in the morning at Cafe Deux Magots in Paris. Simple. Unadorned. With a sprinkle of pepper and a croissant. Totally uncomplicated. Human nourishment at its best. Layers of nurturing texture that instantly say "be calm."

Such creamy eggs can also be the perfect Sunday night supper. You can dress it up or dress it down. Like a navy blue blazer or a little black cocktail dress. I can remember enjoying such eggs at the most refined venue, the Ritz in Paris, who never minded creating a simple dish for guests after a day of feasting. Food, for the French, is all about balance. You don't even have to explain. They

Most meal menus reveal a lot about the eater. Wherever they are, prison cell or a back table at the Ritz.

Any self-respecting criminal would tend to order a big steak for the final journey. Or maybe some BBQ ribs. There would be little interest in quiche (except among the art thieves and forg-

I also think there would be high interest in nostalgic meals. You know, vittles that mamma or grandma cooked that still waft through the nostrils of even the most hardened criminal. Pork chops and homemade apple sauce surely haunt the memories of many. Or homemade lasagna. Or brisket. Macaroni and cheese might rise high on the list. It's a soothing menu item beloved by children and adults, galvanizing the memories of more wholesome times. Same thing with grits and

I'm guessing that liver and onions never reaches the same kitchen primacy. Too much of an acquired taste. Popular only among the bank fraud crowd.

Perhaps what people miss the most, emotionally, in their lives

pads the list, from mashed potatoes to apple pie. So much is recalled through the telescope of time. Stews and soups and the family Jell-O.

As a child, my favorite food was seasonal, Strawberry Shortcake. But those were the days before I tasted pizza, a food that totally rearranged my palette.

Pizza totally unclogged my tastebuds and perceptions about food. Opening doors and adventures.

That's the great thing about Chicago, it challenges our tastes and sense of what captivates our eating. We are an urban plateau brimming with the foods and diets of the whole globe. We have the opportunity and ability to engage the cuisines of the world. Ripe, rank and rapacious. We have the wits and reason to explore the traditions of cultures far and wide. Spicy, savory, sweet, sour. Refocusing our awareness of where we stand and how we live. Upright and generous. Dour and stingy. Cautious and miserly. Enlivening and nourishing. Well-fed and committed to the nourishment of others. Finding our comfort food. Making others welcome. For our first meal or our last.





CTA Red Purple Modernization meetings in November

As the North Side braces for the largest public works project in decades that is sure to disrupt traffic and access to the North Lakefront, CTA and the RPM contractor Walsh-Fluor will host another round of community meetings to share information about plans for the coming construction project.

Meeting locations have not yet been announced but interested parties should mark the calendar for Tuesday, Nov. 19, when issues relating to South of Foster businesses and residents will be discussed; and Thursday, Nov. 21 where similar issues till be debated for businesses and residents located North of Foster.

Chiricotti, editor of Data Analytics Illinois, Inc.

At the request of multiple frustrated agents, some major brokerage firms recently held closeddoor round tables to explore the current state of the market. One agent asked: "What are we going to tell our sellers?"

Buyers also are worried about a "graduated state income tax, growing concerns over the next economic contraction, a big increase in luxury rentals, meaningful new construction and reduced foreign buying," Chiricotti said.

As a result of the cricket's market, many motivated sellers are listening to broker advice about the market shift and are lowering prices, or taking properties off the market until the spring of 2020. Others are considering renting their homes.

"I've never seen the city home market this slow—even during the Great Recession of 2008," observed another veteran North Side broker.



"The best thing that could happen is for mortgage interest rates to rise so buyers have a sense of urgency. Purchasers are complacent—they're waiting for rates to fall lower," said another North Side broker.

Why is the city market dead? From a home buyer's perspective, there appears to be growing doubt that the city of Chicago—under the new Mayor Lori Lightfoot—will be able to raise enough cash to solve its pension obligations to police, firefighters, teachers and municipal employees.

Four years ago, under the leadership of former Mayor Rahm Emanuel, the pension deficit was

of \$822 million in real estate property

taxes, new waste management collection fees, astronomical water and sewer charges, a boost in 911 phone fees and predatory ticket writing the pension deficit now is over the moon at a whopping \$30 billion.

Why? Largely because of decades of financial mismanagement and poor forecasting by the managers of the city's investment portfolio, which dates back to the Daley administration, experts say.

Here's an example of excessive and ununiform real estate taxation. Former Cook County Assessor Joseph Berrios hiked the estimated fair market value of a vintage Old Town 3-flat 93% to an astronomical \$1,973,610 from \$1,021,100. After a mildly successful appeal at the Board of Review, the property owner swallowed a 65% assessment increase, and the 2018 tax bill jumped

a hefty 27.5% to \$28,033 from \$21,991 in 2017. "How can I pass on a \$6,000-plus rent increase to cover this," the owner asks. "Rents would have to nearly double."

Revenue from a soon to be built city gambling casino, along with

the state of Illinois' income-tax hikes may help defray some of the deficit, but the long-range outlook is bleak.

• Recession fears

Home buyers watch CNN and can see how our great President Donald Trump—who now is under impending threat of impeachment—is running the country. Trade wars with China are wiping

out tens of thousands of farming and industrial jobs in America. Tariffs of up to 25% are forecast this month on imported French wines and fine European cheeses. Chicago's fine restaurant owners must be rolling their eyes.

• Chicago and Illinois exodus

The U.S. Census Dept. reports that people have been steadily leaving Chicago and Illinois since 1970. In 2018 the out-migration rose to 6.5 people for every 1,000 residents.

What's worse is Illinois ranks third to last in the U.S. in immigration. Including immigrants, some 266,000 folks moved to Illinois in 2018. A total of 195,000 of those newcomers came from other states. Unfortunately, a whopping 339,435 disenchanted souls left the Land of Lincoln.

Despite all the gloom and negativity, there are some positives on the radar for prospective city home buyers in 2019 and early 2020.

$\bullet \ Affordable \ mortgage \ rates \\$

On the upside, buyers who venture into the dark foliage of the autumn market would greatly benefit from some of the lowest mortgage rates in years.

Freddie Mac's Primary Mortgage Market Survey reported on Oct. 3 that lenders were charging an average of 3.65% on benchmark 30-year fixed home loans. A week earlier the rate was 3.64%. A year ago, 30-year fixed loans averaged 4.71%.

Even though a recession may loom on the horizon, Sam Khater, Freddie Mac's chief economist put a positive spin on it. "As economic growth decelerates, it is clear that low mortgage rates will continue to support the mortgage market and we expect that to persist for the remainder of the year," said Khater.

There's one ray of sunshine for home sellers to consider in the cricket's market. Throughout Chinese and Native American history, crickets have been revered and regarded as a sign of good fortune and prosperity.

Support building for ban on red-light cameras

Critics say devices are a 'revenue grab' for cities and source of political corruption

Bipartisan support appears to be building in the Illinois General Assembly for a statewide ban on red-light cameras.

Those are devices that some municipalities install at intersections to detect drivers running through red lights or turning without coming to a full stop.

Critics of those devices, however, argue they serve only to generate revenue and are a potential source of political corruption.

Chicago's own introduction - with it's corruption, rigged yellow light timing, city hall bribery and jail terms - has now become the world-wide case study on what not to do when introducing red light cameras to your town.

In another Midwestern city where citizens are actually allowed to vote on such things, Cleveland has stopped employing traffic cameras to enforce speed and red light violations after voters in 2014 overwhelmingly approved a measure that effectively banned their use. More than 77% of voters there approved a ballot initiative that said the city could enforce traffic camera violations only if a police officer writes the ticket. So no mailing it in as is the practice today in Chicago.

In 2017, Chicago approved a settlement of nearly \$40 million after a class-action lawsuit alleged that the city's red light program had violated 1.2 million motorists' due process rights by using illegal tactics.

Chicago's red-light and speed camera program has proven quite lucrative for city government, generating over \$57.6 million in revenue in 2018 alone, with total revenues over the last decade of \$670 million, according to records obtained through a Freedom of Information Act request.

And Chicago is no safer due to the cameras either.

"Studies have shown that it does not improve safety. In fact, that it increases rear-end collisions," State Rep. David McSweeney, said. "So this is really a revenue grab by local governments. And, as we've seen recently, this is obviously tied up, but likely with corruption."

McSweeney was referring to recent news reports indicating that one private company, SafeSpeed LLC, which supplies red-light cameras to several Chicago suburbs, is the focus of a federal probe that led to raids on the offices and home of state Sen. Martin Sandoval, chairman of the powerful Senate Transportation Committee.

In 2017, the Chicago Tribune reported that Sandoval had personally interceded, on SafeSpeed's behalf, with Illinois Dept. of Transportation officials to get ap-

proval for a red-light camera in Oakbrook Terrace while accepting tens of thousands of dollars in campaign donations from the company.

McSweeney has introduced several bills in recent years to ban the use of red-light cameras. One of those passed the House in 2015 but died in the Senate. Another one, HB 323, introduced in January, is still pending in the House, and last week it picked up two new Democratic co-sponsors, State Reps. Rita Mayfield and Sam Yingling.

And on Oct. 7, State Rep. Grant Wehrli introduced a virtually identical bill, HB 3909.

In a news release, Wehrli also

claimed the devices are a source of political corruption.


"As the FBI's federal investigation into Sen. Sandoval's shady dealings intensifies, it's time to re-examine the use of red-light cameras in Illinois and consider the type of ban he has repeatedly blocked," Wehrli said.

Sandoval, who has not yet been charged with any wrongdoing, did not respond to a request for comment

McSweeney, meanwhile, said that even without the alleged corruption, he would still oppose the use of red-light cameras.

"My issue is that I think the red-

Police said in an arrest report th their body cameras recorded Barnes as he admitted to being a Black P Stone gang member for his entire life. He also told them he bought the gun for \$350 in the Austin neighborhood.

Prosecutors charged Barnes with being a felon in possession of a weapon and criminal trespass to statesupported land. Judge David Navarro ordered him held without bail.

CPD records show four other adults are facing criminal trespass to statesupported land charges in connection with Sunday's incident. One of them is also charged with possession of 8.7 grams of crack.

Barnes was found guilty in 2003 of firing a gun into a group of men outside an apartment building on the 1500 block of W. Pratt two years

One of the shooting victims said at trial that Barnes approached the group, got within five feet, and said, "What's up, folks?"

Then, Barnes began shooting. One man was shot in the chest. Another was shot in both legs and a shoulder.

Barnes was sentenced to 25 years for attempted murder plus additional time for weapons and aggravated battery charges, but a judge later reduced the attempted murder sentence to 17 years.

Businesses burglarized in Lakeview, Roscoe Village

A burglar threw bricks through the glass doors of two North Side businesses one night this week, police said. Once inside, the thief took money from the cash registers and fled.

The burglar broke into the first establishment at 11:29 p.m.Oct. 9, according to a CPD community alert. A driver reported the burglary at Man-Jo-Vin's restaurant, 3224 N. Damen, a short time later.

Earlier this year, a Lakeview attorney received 18 months of court supervision after pleading guilty to recording under the dress of a woman who was in front of him on a Loop department store escalator.

Recent courthouse decisions leave residents wondering about justice in Cook County

A convicted felon who was found carrying a gun in the River North nightclub district in June 2018 has reached a plea deal with prosecutors. Police stopped Geoffrey Miller, 30, following reports of a man with a gun on the 400 block of N. Orleans.

Officers recovered a loaded handgun, a bag of suspected heroin, and 51 suspected Xanax pills from Miller, according to initial allegations.

Now, Miller has pleaded guilty to being a felon in possession of a weapon. Prosecutors dropped a Class X felony armed violence charge along with eight other felonies in their deal with Miller. Judge William Hooks sentenced Miller to 42 months in prison with credit for 260 days time served while awaiting trial.

In 2013, Miller received two concurrent 16-month prison sen-

tences for reckless discharge of a firearm and filing a false police report.

More decisions follow:

• Cook County Judge Ericka Orr threw out charges against an Alabama man who was facing charges of having two handguns in his room at a River North hotel. Police said they saw two pistols in Gerald Rutherford's room when they went inside to handle a reported domestic incident.

But the other party refused to file complaints against Rutherford and Orr determined that the gun case should not move forward

• Not guilty. That is the verdict from Cook County Judge Carol Howard in the bench trial of a man who police said was carrying a handgun while on bail awaiting trial for a Wrigleyville robbery.

Prosecutors said in a court filing that Jeff Sarfo was in the passenger seat of a car that police pulled over for allegedly having expired plates in Rogers Park on May 8, 2018. Officers saw a handgun lying on the floorboard at Sarfo's feet, prosecutors alleged.

Arresting officers said they heard the sound of metal striking metal in the back seat of their car as they drove Sarfo to the district station. They said they pulled over and found bullets lying in the back seat where Sarfo was sitting.

Their in-car camera allegedly captured footage of Sarfo removing a white envelope containing four bullets from his pocket, but the cops failed to preserve the video. Nonetheless, prosecutors said they still had video from the officers' body cameras showing the cops opening their squad's rear door and shining a flashlight on ammunition in its back seat.

Prosecutors dropped a felony possession of ammunition charge before trial after learning about the video loss. On Oct. 9, Judge Howard found Banks not guilty on all remaining felony counts.

Prosecutors previously dropped all charges against the man who was driving the car that police stopped for having expired plates — Ralph Banks, 21.

At the time of the traffic stop, Banks was on parole for his role in a 2015 shoot-out near Wrigley Field. A North Side rapper was shot during the exchange of gunfire that left dozens of shell casings lying on a residential street.

While awaiting trial on the gun allegations, Sarfo pleaded guilty to robbing a couple outside their Wrigleyville home in the 1200 block of W. Waveland on Sept. 10, 2017.

A judge sentenced him to three years. After receiving credit for time served awaiting trial and a 50% sentence reduction for good behavior, Sarfo left prison three days after arriving. He's on parole in that case until March 18, 2021. He previously served time for aggravated fleeing from police, robbery, and possessing a firearm in public.

• The man accused of threatening another man with a handgun in Uptown on Sept. 16 is off the hook. Judge Donald Panarese struck all charges against Maurice Burt, 30, following a motion by prosecutors during a hearing

Rap star Herbert "G Herbo"
 Wright reached a plea deal with prosecutors who accused him of having a handgun in a limo near State and Roosevelt in February 2018. Two other men in the vehicle were also charged with having

Wright and prosecutors struck a deal in which the rapper pleaded guilty to one count of misdemeanor carrying a firearm while prosecutors dropped four felony gun charges. Judge Matthew

Free flu shots on the North Side

No-cost flu shots are available to residents at a Chicago Dept. of Public Health (CDPH) family flu shot clinic and more than 70 walk-in clinic events.

A family flu shot clinics is scheduled for Saturday, Oct. 19, 9 a.m.-2 p.m., at Harry S. Truman College, 1145 W. Wilson Ave.

The CDPH recommends everyone six months and older receive a yearly flu vaccine as the first, and most important step, in protecting against the flu. To ensure that every resident can access vaccines regardless of ability to pay, CDPH has scheduled this family flu shot clinics and other events over the next two months where residents can get their flu shot for no out-of-pocket cost.

"The flu vaccine reduces the burden of illness and prevents hospitalizations, and we remain committed to ensuring it is affordable and universally available throughout the entire flu season," said CDPH Acting Cmsr. Allison Arwady, MD.

People 65 years and older are at greater risk of serious complications from the flu, and most seasonal flu-related deaths and hospitalizations occur among people in that age group. Other people at high risk from the flu include children younger than 5 years old, especially those younger than 6 months old who cannot be vaccinated, pregnant women, American Indians and Alaska Natives, people who live in nursing homes and other long-term care facilities, people with a weakened immune system due to disease or medications, and people with asthma, diabetes and other chronic heart and lung conditions.

In addition to vaccination, good health habits can help stop the spread of germs and prevent respiratory illnesses like the flu:

- Try to avoid close contact with people who are sick. Stay home when you are sick.
 - Cover your mouth and nose



Coughlan sentenced him to two years probation, nine days time served, and levied a fine of \$494.

One of the other men charged with Wright, Deavonte Kimble, opted for a bench trial last year. Coughlan found him not guilty on all charges: five felony counts of aggravated unlawful use of a weapon with a previous conviction and being a felon in possession of a weapon.

Wright, who is based in Chicago, has worked with Chance the Rapper, Common, and Nicki Minaj, among others.

 A 20-year-old man accused of firing a handgun inside a Streeterville parking garage while having three other pending criminal cases has reached a plea deal. The judge sentenced him to only one year on the gun charge, but he had worse luck with the other matters.

Prosecutors said surveillance video captured images of Ricardo Ortiz pulling out a handgun in the garage at 240 E. Illinois St. in August 2018. He allegedly fired the weapon at a security camera and then into the garage, striking a 20-year-old man in the abdomen, according to court records. The victim recovered from his injuries and identified Ortiz as the shooter, police said.

Ortiz was on second chance probation for burglary at the time of the incident. He also had pending cases for theft, narcotics, and probation violation. He repeatedly failed to appear in court and had been put on and taken off electronic monitoring in the months before the Streeterville incident.

In a deal with prosecutors, Ortiz received a sentence of one year with 499 days credit for time served in the gun case. Judge Timothy Chambers also sentenced him to concurrent terms of two years for manufacture-delivery of cannabis, two years for a burglary in Justice, IL, and three years for possession of fentanyl.

With time served and an anticipated 50% credit for good behavior, his parole date is set for Feb.

· Prosecutors accused Gerald Hunley, 22, of shooting at people in the 800 block of N. Cambridge on June 9, 2018. He was a registered gun offender at the time due to a previous gun violation.

Hunley reached a deal with prosecutors in which he pleaded guilty to aggravated unlawful use of a weapon while the state dropped two counts of aggravated discharge of a firearm, two counts of being a felon in possession of a weapon, and three other felonies.

Judge Catherine Haberkorn sentenced him to six years in prison with 443 days credit for time served. With an anticipated 50% sentence reduction for good behavior, Hunley will be paroled in July 2021.

• A homeless man who was arrested after he took a gun out of his pocket to "adjust himself" in River North has been sentenced to 30 months probation.

Police said a motorist told them he saw Wakili Boyd walking hear LaSalle St. and Chicago Ave., holding a gun in his hand and pushing a shopping cart on Aug. 8, 2018. But Boyd did not point the gun at him, the man said.

Officers stopped Boyd and found an unloaded handgun in his left pants pocket. He told cops that he "found the gun in his belongings," police said, and he only took it out of his pants because he had to adjust himself after going to the bathroom.

In a deal with prosecutors, Boyd pleaded guilty to one count of aggravated unlawful use of a weapon with a previous conviction. The state dropped charges of being a felon in possession of a firearm and another felony count. Judge William O'Brien oversaw the case.

light cameras, again, are designed for a specific purpose of raising revenue," he said. "I believe that they're unreliable in a number of cases that have been shown. I don't believe they increase safety. In fact, actually, I believe they increase rear-end collisions based on the studies. But of course, if a policeman sees a person violating the law, that person should be ticketed, but it should be done like any other traffic violation, not through an automated system that is designed to produce revenue."



After-words bookstore owner shares how she got started

Beverly Dvorkin, owner of After-words in River North, 23 E. Illinois St., discovered her love for stories as a toddler. At 15, she got her first job at a bookstore and edited her high school newspaper. She spent a semester abroad in London during college and wrote for City Limits, a feminist magazine.

After living in Boston, Washington, D.C., and London, Dvorkin returned to Chicago at 25 to fulfill her dream of opening her very own bookstore in May, 1997.

After-words is one of the few independent bookstores left in downtown Chicago. Their two floors house a wide collection of over 70,000 new and used volumes. They feature a wide variety of fiction, literature, poetry, and children's books. They also carry art and photography books, cookbooks, local books, history books, health, healing, and new age/occult books among other categories.

Over two decades after opening, Afterwords remains one of the few independent bookstores left in Chicago's high rent district.

We asked how old she was when she first recognized your love for writing?

"God, I don't remember a time when I didn't feel that. My mother likes to tell a story when I was like a year and a half old, and we had gone to visit my grandfather at the hospital. She put me down in the waiting room with one of my favorite books that she read to me all the time. It's called "Snow-White and Rose-Red." She said I entertained the whole waiting room because I sat in the chair and read the book with her. I had memorized every word she said to me, and I knew where the page turned to. So, I guess that kind of love of words and books was always me."

How did you get started in writing?

"I was always interested in writing, but I never was a creative writer in that sense. But I always could put words together, and I enjoyed finding the best way to say things. I still do. It's what draws me to literature, too, because there are so many books that I look at, and I'm in awe of, you know, how well the writers are able to draw words together, and I actually have a physical sensation when I see well put together things.

When you were in high school, did you have an idea of which direction you wanted to take your life then?

Not at all. I was accepted at Boston University. I went into school as a history major. Eventually, I became a double major, and did history and journalism. I didn't know what I wanted to do when I graduated. I worked at the Smithsonian as an intern. I was making photocopies and helping with mailings. I was doing courtroom beat reporting for a local chain of papers outside of D.C. in suburban Maryland. For the amount of time I was putting in, it was getting very difficult to justify that [low pay]. I decided that at some point as I was working in bookstores to make ends meet."

What happened after that?

"I was working for Crown Bookstore after I left the used bookstore (a book store that sold used books). The owner of Second Story Books had an amazing collection of books. I learned about evaluating books and editions from him. He was half blind, but he could literally pick up a book and tell you what year it was from the way the paper felt and the books smelled. He would usually be within like five years. At this point, I can't do that, but I can probably tell you within the 20-year frame."

How did you start this bookstore?

"I was working in D.C., and I took the full-time job with Crown bookstore. While I wasn't really paying attention, the truth is that bookstores became my career as op-

posed to journalism. It wasn't because I didn't like writing. It was because I realized that I could have a real life in books and in promoting other people's writing. Then, I took a job as manager of this party store in Virginia, where I ended up working for almost three years. I didn't hate the stuff I was selling, but I had zero passion for it. I was saving money because I was being paid too much. One day, my dad gave me a call. He had purchased a property in River North in Chicago. The next time I was in town, I came and looked at it. We always joked when I was 15, that one day, I'd own a bookstore, and it never really seemed real to me. Eventually, after being gone for a decade, I knew what else was out there. I rented this space in Nov., 1996 and opened it in May, 1997."

from 76 in 2015 to 171 last year. An untold number of similar crimes remain un-

recorded because the victims chose to not file police reports.

Arrests are rare, though.

But cops apparently caught a break last week. A burglar broke into a woman's car on the 1900 block of N. Clark, taking a purse, iPad, MacBook Pro,

AirPods, and a handbag. Combined value? \$3,450, according to police.

Investigators checked footage from a

nearby police camera, and an officer identified the burglar immediately, police said. It was Rayshay Moore, 20, the officer said. Local cops were told to keep an eye out for Moore in the neighborhood.

Two days later, around noon on Oct. 4, police spotted Moore in the 400 block of N. Evergreen and took him into custody. Arresting officers said he had two spark plugs with him.

Ceramic bits from broken spark plugs are commonly used to shatter car windows with ease. The tiny bits even have earned the nickname "ninja rocks" for their effectiveness

Prosecutors charged Moore with felony burglary. Judge David Navarro set bail at \$25,000.
