Payton College Prep will continue to be outpost for Chinese government's Confucius Institute

Some express concerns about PRC propaganda

Located inside Walter Payton College Prep High School, 1034 N. Wells, Chicago's Confucius Classroom has a stated purpose of being an "educational resource for educators, parents and students throughout the greater Chicagoland on the teaching and learning of the Chinese language and culture."

While many have praised the educational opportunities offered through the Chicago Public School's partnership with the Chinese government's Confucius Institute, some have begun to express concerns about a program which includes among its reading materials a glowing biography of Mao Zedong, the founder of the

People's Republic of China. As leader, Zedong was directly responsible for the deaths of more than 45 million people during their Great Leap Forward (1958-

1961), and the Great Proletarian Cultural Revolution (1966-1976).

Critics of the Confucius Institute, which include Republicans and Democrats in Congress, have said the institute uses its influence to shape public opinion in

the United States and has coordinated the placement of Chinese nationals in sensitive positions at research universities throughout the United States. This has caused numerous universities and colleges to end their partnerships with the

Confucius Institute.

"As the de facto "parent" organization of the Confucius Institute program in the United States, the State Dept. designated the "Confucius Institute U.S. Center" [CIUS] as a foreign mission of the

The effort at self-taxation along Michigan Ave has failed. A proposed Special Service Area tax did not advance in City Council Monday due to strong opposition from two local aldermen, Brendan Reilly [42nd] and Brian Hopkins [2nd].

The funds were going to be used for additional security, and to help re-establish the shopping district after a pandemic and corresponding drop in tourists and conventioneers made most of the customers disappear.

Then came the riots and looting of June and August and that pretty much brought the virtual gates down on Boul Mich - in this case gates being plywood board-ups and police barricades.

The Chicago Dept. of Planning and Development earlier was aiding the North Michigan Ave. Association to move a plan through

City Hall that would have raised \$742,000 in 2021 for security, marketing campaigns and other related costs. But the full City Council will not consider the proposal at its meeting this week.

The extra taxes would have been bourn by land owners and landlords, which they'd typically pass on to tenants who would of course get the money from their customers through higher sales prices. Those higher taxes would have put an additional financial burden on the tenants at a time when many are already struggling.

As Chicago's most famous retail strip, Michigan Ave. has suffered amid a plunge in tourism and severe drop in shopper traffic at brick-and-mortar stores. The violence and looting over the summer forced several stores to close temporarily.

Attorney for Chinese investors of failed development skeptical clients will get their money back

An attorney representing a group of Chinese investors who lent \$49.5 million to a New York City-based developer to build a 60-story condominium/hotel tower at the corner of Wabash Ave. and Superior St. remains skeptical the developer will return his client's money.

Symmetry Property Development had initially planned to replace a group of 19th century buildings at 42 and 44-46 E. Superior St. with a new skyscraper designed by Skidmore Owings and Merrill. These existing properties, which were built shortly after the Chicago Fire of 1871, have now been included in the city of Chicago's new Near North Side Multiple Property Landmark District.

While some press accounts have described Symmetry as having agreed to return the money to the Chinese investors, the matter remains far from settled. The "agreement" could simply have been a tactic used in court to buy more time for Symmetry Property Development.

"I think it is premature because the "settlement" gives them 60 days to find the money to pay the Chinese, and if they don't get it, the lawsuit goes right back to where it was. It is not a definitive settlement in any sense," said Doug Litowitz, a Deerfield-based attorney who is representing the group of Chinese investors in a federal class-action lawsuit.

As always, a court ruling would still require the winning side collecting any settlement, and a corporate bankruptcy filing frequently complicates collecting the full sum in large court settlements.

In late 2019, Symmetry had been circulating a series of images in local media and had filed these designs with the city's Dept. of Planning and Development. These images revealed an amalgamation of the original Carillon Tower project which incorporated the facades of the 19th century

Attempts to contact Symmetry have been unsuccessful. A listed phone number for the company is no longer accepting telephone calls and its website is simply a placeholder. The head of Symmetry, attorney Jeffrey Laytin, had once been a high-profile intellectual property attorney in New York City who represented clients

such as professional sports leagues and expensive clothing brands.

The Chinese investors lent their money to Symmetry in order to participate in the federal EB-5 Visa program. Investors participate in the program because they want to become legal residents of

the United States. For that reason, many of these investors will accept a lower-rate-of-return on their investment. Each investor contributed at least \$550,000 in the Symmetry project. Unfortunately, there have been numerous incidents of fraud in the EB-5 program

And no EB-5 Visa will be issued even if the money is not returned.

According to the website of the U.S. Citizenship and Immigration Services (part of the Dept. of Homeland Security), the federal program was initially created by Congress in 1990 "to stimulate

Police oversight worker arrested for Macy's looting — then released

An employee of Chicago's police oversight agency was arrested Dec. 8 in connection with the looting of Macy's State St. store on Aug. 10, according to a CPD internal communication provided to this reporter by a source. The man was later released without being charged, according to a police spokesperson.

A fugitive apprehension team arrested the Chicago Office of Police Accountability (COPA) worker in the 2900 block of S. Michigan around 7:55 a.m. Tuesday, according to the CPD notification. Kellie Bartoli, a CPD spokesperson, confirmed details of the notification and said the COPA employee had been released without being charged by Tuesday afternoon.

In a statement Dec. 8, COPA confirmed that police arrested and later released one of its employees. The agency is conducting a separate internal review of the matter.

"If misconduct has occurred, the employee will be held accountable," the agency said.

"As an agency with high accountability standards and a strict code of conduct, we take these matters very seriously and will work with the Office of Inspector General in any review it may undertake," said COPA Spokesperson Ephraim Eaddy.

The internal CPD communication said police notified the city's inspector general about the arrest at 10:20 a.m. Dec. 8.

Investigators have released several surveillance videos that show scores of looters hauling merchandise out of Macy's Loop store, 111 N. State, during widespread raids of downtown businesses on Aug. 10.

Bartoli, the CPD spokesperson, did not say why the COPA employee was released without being charged. Police did not ask prosecutors to approve felony charges in the case, according to

Afternoon thirsts quenched at local pubs and Christmas carol practice back at Roundwood House like we were living in a dorm at Wellesley. Or rehearsing our party piece like we were Danny Kaye and Bing Crosby looking for Rosemary Clooney and Vera Ellen.

So not being in Ireland and not being together for the first time in 28 years has me cogitating about

How lucky I am to even have such a rational family and quasisane friends. We've embraced Chicago politics together. And deaths of treasured friends, like the dearest Margaret Dargan. It's around noon on Saturday and the knock at my front door lets me know that Megan Edwards and her kindergarten-aged son, Jake, have come to collect my donations for the coat drive at Stone Academy, 6239 N. Leavitt St

Edwards told me that the collection is part of a program called the Stone Academy Circle of Care. It supports families in the school community who are in need, she said.

What a great idea, especially these days when times are tough for so many people.

"Our goal is to help alleviate some financial stress so that students can focus on learning and growing at school," said Edwards.

If you happen to have any warm weather gear you're not using, please consider donating it to the school, which is collecting coats through mid-January. After serving its community, the remaining items will be given to Care for Real -- which brings nourishment and hope to neighbors in need -- and Family Tree Resale, a socially-conscious thrift and consignment store at 5066 N. Lincoln Ave. that serves local charities and school districts by offering a free voucher program.

Edwards first became involved in collecting for the academy after she attended a couple of virtual Friends of Stone Academy [FOSA] meetings during the Stone Circle of Care warm weather clothing drive.

"Volunteering is very important in our family," said Edwards, a West Ridge resident. "Stone Academy has an amazing community within it."

FOSA is a not-for-profit organization of parents and representatives from Stone's faculty, administration and LSC, and Circle of Care is an initiative within FOSA. Wolf, who has known the Moscowitz family for most of his life, shared his thoughts on Eliyahu. "He was super friendly, outgoing, helpful to people of every type. He wasn't closed in and was very embracing of all people."


There is still frustration that Moscowitz's killer has never been caught. Yet those who knew and loved Eliyahu are, "still hopeful," said Wolf, whose brother, Rabbi Yoel Wolf, along with the area's Lubavitch Chabad congregation, makes sure the menorah goes up annually.

As for Rholl, who was walking by and offered his menorah-erecting services, he lives in the neighborhood and was here "when this awful thing happened."

"I heard the shots and I wish I'd run out to figure out what happened," said Rholl. "We think about it all the time. I didn't know him but I still remember.

"I'm so happy to help," said Rholl. "We all care. Everybody cares."

Police shoot man who opened fire on them in Rogers Park

Chicago police shot a man who opened fire as they investigated a domestic incident in Rogers Park on Dec. 8, according to CPD. Police shot the alleged offender, but no officers were wounded by his gunfire, Dep. Chief Randall Darlin said during a press conference tonight.

Officers pulled the man over in the 6900 block of N. Ravenswood to conduct their investigation around 4:56 p.m., police said. According to Darlin, the man got out of the vehicle with a gun and shot at the police. Cops returned fire, striking the man. A CPD spokesperson later tweeted a photograph of a handgun and ammunition magazine that he said belonged to the man.

The man was taken to St. Francis Hospital in Evanston. Darlin said the man's condition was unknown, but fire department personnel previously said the man's condition was "red," which generally means a patient has life-threatening injuries that may be survivable.

Several witnesses, including members of the media, saw police officers being placed into ambulances at the scene, but Darlin released no information about what kinds of injuries cops received or what conditions any injured officers might be in.

The fire department declared an EMS Plan 1, which brought five ambulances and other support personnel to the scene. In addition to the alleged offender, fire department personnel told dispatchers that ambulances were transporting one patient in "green" condition to St. Francis Hospital and three patients in "yellow" condition to Advocate Illinois Masonic Medical Center. Green is the least serious EMS triage level, while vellow indicates that a patient's treatment can be delayed until more critically-wounded patients are treated.

Darlin said Tuesday's incident is the 72nd time this year that people have fired shots at Chicago police officers.

The Chicago Office of Police Accountability is investigating the shooting. All of the officers who were involved will be placed on administrative duties for 30 days per CPD policy, according to Darlin.

Robbers score Instacart grocery delivery in Lakeview

Just when you think Chicago has dished out every possible crime scenario, it whips up a new one.

Two men reportedly pushed and threatened an Instacart grocery driver when he stopped to deliver an order in Lakeview Dec. 7. The courier was not injured, and no arrests have been made.

According to the driver, he parked his car and left the vehicle unlocked as he made a delivery in the 3000 block of N. Sheridan around 8:40 p.m., CPD spokesperson Kellie Bartoli said.

A few moments later, the 44year-old driver saw two men rifling through his car, and he yelled out to them, Bartoli said. The men grabbed delivery bags filled with about \$150 worth of groceries and jumped into a black SUV that sped away southbound, according to the driver.

While a witness said the driver was threatened and pushed, he was

not harmed. Bartoli said police did not have a detailed description of the

A West Town man who was reportedly killed after he shot his friend during a robbery attempt near Goose Island Dec. 6 died almost exactly three years after he robbed another man while claiming to have a gun in the same area, according to court records.

Police found Adan Delgado, 27, with multiple gunshot wounds and a handgun lying nearby in the 1200 block of W. Fry around 4:30 a.m. An-

other man who lives about a block away reportedly told police that his friend, Delgado, shot him in the leg during a robbery attempt moments earlier. The man, 28, said he ran away after Delgado shot him and he then heard more gunfire behind him.

Detectives are trying to sort out who shot Delgado and why.

But court records show Delgado has a history of robbery. In fact, he completed probation last month for battering and robbing a man in the same neighborhood at 5:30 a.m. on

Woman charged with dragging cop "several blocks" in River North, but her passenger gets stricter bail

A driver who allegedly dragged a Chicago cop for several blocks with her car during a traffic stop in River North this week got out of jail by posting just \$5,000 bond after a court hearing, according to court records.

The woman's passenger, who is charged with possessing less than three ounces of marijuana, actually received stricter bail conditions than she did.

According to prosecutors, when

officers pulled Jasmine Smith over for a traffic violation in the 700 block of N. State around 4 p.m., she had a state ID hut no license. Cops said they

smelled burnt weed coming from the vehicle, too.

After Smith and her passenger, Christopher Fleming, repeatedly refused to get out of the car, a cop reached through the passenger-side window to remove Smith's seatbelt, prosecutors said. That's when Smith, 28, allegedly put her car into drive and accelerated down State St. with

the cop hanging out of her

car. The officer the car into park as Smith dragged him down the street, "disregarding

lights" along the way, according to prosecutors. Once the cop managed to put the car into park, Fleming allegedly told her to keep going. Smith put her car back into drive and sped away with the officer still hanging out of the vehicle, an assistant state's attorney said.

The cop shifted the car into park again after being "dragged several city blocks," according to prosecutors. She then allegedly struggled with officers who tried to take her into custody.

An ambulance transported the officer to Northwestern Memorial Hospital in fair condition with a knee injury, according to a CPD statement.

Private security cameras, CPD vehicle dashcams, and officers' bodyworn cameras recorded the incident.

Prosecutors charged Smith with felony aggravated battery of a peace officer; felony aggravated fleeing causing injury; misdemeanor reckless driving; and three citations.

Police said they found 73 grams of cannabis and \$1,507 cash in Fleming's possession during a custody search after the incident. He is charged with felony possession of cannabis.

According to Illinois Department of Corrections records, Fleming, 38, was paroled in April after serving half of a three-year sentence that he received for resisting police. He has previous convictions for aggravated fleeing, home invasion, and robbery, according to IDOC.

Judge Mary Marubio set bail for Smith at \$50,000. Marubio set the same bail for Fleming but also ordered him to go onto electronic monitoring if he posts bond.

Smith, who allegedly dragged the police officer for several blocks, posted a 10% deposit bond and went home after the bail hearing, records show. Fleming remains jailed on the marijuana charge.

Man had CPD taser that went missing during May riots

So that's where the darn thing went! It's always the last place you look.

A three-time felon is facing a fresh felony weapons charge after cops allegedly found a stolen CPD taser in his

car during a traffic stop over the weekend. Prosecutors said the taser was one of many pieces of equipment that were either lost or stolen from Chicago police

during riots, looting, and protests this

On Dec. 6, police pulled over Drevon Jackson, 26, for a traffic violation on the West Side and took him into custody for allegedly driving without a license.

A passenger in Jackson's car took his keys, refused to give the keys to police, and battered officers, prosecutors said. So, they arrested her, too.

Cops agreed to let Jackson's relatives collect items from the vehicle before police towed it. As officers helped them remove property from Jackson's car, an officer discovered a Chicago Police Dept. taser next to a

Investigators found the taser's serial number and determined that the device went missing during a riot and looting at Foot Locker, 3900 W. Madison, on May 31, according to prosecutors. Jackson allegedly told police he found the taser during the civil unrest and he's had it ever since.

Prosecutors said Jackson has been sent to prison twice for gun violations once in 2014 and again in 2015. He is now charged with driving on a suspended license and aggravated unlawful use of a weapon in the taser

Judge Mary Marubio set Jackson's bail at \$5,000. He went home by posting a \$500 deposit bond.

During Jackson's bail hearing, prosecutors said Chicago cops lost other tasers and CPD property during uprisings and protests during the spring and summer.

One beat a man unconscious, the other broke car windows guess who went to prison

One man allegedly beat a guy unconscious inside a Wrigleyville pizza shop, leaving the victim hospitalized. The other was accused of breaking dozens of car windows with rocks.

Our researcher recently discovered the juxtaposition while checking court records for the status of cases we previously reported.

Guess which one got sent to prison?

In June 2019, Liam McIntyre was charged with felony aggravated battery causing great bodily harm after he allegedly beat and kicked a man into unconsciousness at Dimo's Pizza, 3463 N. Clark St. The alleged victim, 23, suffered a concussion, was hospitalized, and suffered headaches for two weeks after the attack, according to a CPD report.

McIntyre, 23, was on bail while awaiting trial for burglary at the time of the alleged attack.

Recently, McIntyre pleaded guilty to burglary and aggravated battery causing great bodily harm. Judge William Raines sentenced him to twoyears probation and 80 hours of community service, according to court

Then there's Patrick Newton.

Police hauled Newton into custody for allegedly breaking out the windows of nearly 20 parked cars on the Far North Side in June 2019.

A couple months later, Newton was arrested again after allegedly breaking the windows of dozens of cars inside Loop parking garages. He was also accused of breaking 23 car windows in west suburban Brookfield and even more in Hyde Park.

According to state records, he spent 322 days in jail before he pleaded guilty to three counts of felony criminal damage to property. A judge sentenced him to one year in prison.

Newton was released from custody on the same day he arrived at Stateville Correctional Center in Joliet because he received 322 days credit for time spent in jail, according to Illinois Dept. of Corrections records. He is now on parole.

Man brandished knife, punched cop who poured out his bottle of Fireball

Charges have been filed against a man who allegedly punched a Chicago cop while brandishing a knife because the officer poured out his bottle of Fireball cinnamon whisky.

Brian Debeleyzer, 55, is charged with two counts of felony aggravated battery in connection with the Dec. 9 incident on the Jackson Red Line platform.

trolling the CTA system escorted Debeleyzer off the Red Line at Jackson around 6:45 p.m. so they could cite him for drinking

beer aboard a train, prosecutors said. Debeleyzer became combative as soon as police asked for his ID screaming, cursing, and threatening the cops, an assistant state's attorney alleged.

During his tantrum, a bottle of Fireball allegedly fell out of his coat and clunked onto the platform. One of the cops poured out the bottle of liquor.

Debeleyzer yelled at him for wasting the liquor and punched the cop in the shoulder while holding a knife in his other hand, prosecutors said. Then, Debeleyzer allegedly punched the cop in the neck with the hand that was holding the knife.

Prosecutors said the cop struck Debeleyzer, who fell to the platform and hit his head. Officers allegedly recovered his knife and then called for paramedics to treat Debeleyzer's injury.

According to prosecutors, as first responders escorted Debeleyzer to an ambulance, he kicked a fireman in the knee. Debelevzer was treated and released. Neither the officer nor the fire department employee required medical attention. The kick and the entire platform incident were reportedly captured on CTA surveillance video.

Judge Mary Marubio set bail for Debeleyzer at \$10,000. He went home by posting a \$1,000 deposit bond.

Prosecutors said Debeleyzer has only one misdemeanor conviction on his record — a 2018 drug possession. But CPD records show Debeleyzer has been arrested six times in the city since September 2018. All of the arrests took place near the Wilson Red Line station in

Parolee, AWOL from electronic monitoring, busted with another gun at River North video shoot

A paroled felon who went AWOL while on electronic monitoring for a pending gun case was arrested with an automatic-fire handgun Dec. 9 after police found a group of people shooting a music video under the Ontario feeder ramp, prosecutors said.

Cops went to an address in the 600 block of N. Kingsbury around 11:45 p.m. after a 911 caller re-

ported seeing a large group of people trading property between vehicles under the expressway ramp. When

officers arrived, they saw about 20 people filming a music video.

As police moved in, two cars sped away and Brandon Milton, 27, ran from the scene on foot, according to prosecutors. Cops ran after Milton, who repeatedly grabbed his waistband while running, an indication that he might be concealing a handgun, an assistant state's attorney alleged during his bond court hearing.

When Milton and the cops reached the 400 block of W. Ontario, a witness intervened and tackled Milton, allowing police to take him into custody.

That may not have been the wisst decision the helpful citize: made.

Prosecutors said a gun with an automatic-fire switch, and an extended ammunition magazine fell to the ground as police tried to take Milton into custody. Automatic-fire switches are illegal devices that convert standard handguns, which require the trigger to be pulled once for each shot, into mini-ma-

Cook County authorities have been looking for Milton since he escaped from electronic monitoring in August. He had been placed on house arrest after he posted \$3,000 to get out of jail while await-

We need a "Marshall Plan" to develop vacant lots



The Home **Front**

Chicago and Cook County's Land Bank has deposits of more than 51,300 vacant and abandoned properties, but developers are not making significant with-

According to a new report by County Treasurer Maria Pappas, the 81-year-old Land Bank's "Scavenger-Sale" program for vacant and abandoned properties has failed.

Developers and small renovators often bid but generally do not close on the vacant lots and abandoned properties because of burdensome bureaucratic red tape. Bids on 80% of the properties do not make it through a complex, lengthy 75-point process. Nearly 7,300 properties have had delinquent taxes for two decades.

As a result, Pappas says, the parcels act as a bureaucratic road block to the revitalization of struggling minority city neighborhoods—including Englewood, Greater Grand Crossing, Park Manor, Auburn Gresham, Chatham, North Lawndale and

"Nobody wants these properties because they are in areas that are losing population, have high crime and aren't worth the property taxes you have to pay to own them," said Pappas.

In addition to the Scavenger-Sale list, the city owns another 15,000 properties, mostly in compromised socio-economic areas.

Pappas urged the Illinois General Assembly, which originally authorized the Scavenger Sale back in 1939, to come up with revised, innovative solutions for restoring such properties to the tax rolls.

Every two years, Cook County conducts the Scavenger Sale to auction tens of thousands of mostly vacant and often abandoned properties with a significant amount of unpaid taxes. However, more than half of the properties bid on in the 2015 and 2017 auctions were never transferred and developed, the report says.

While reform is needed in the program, experts say the problem of vacant and abandoned property is more complex than just improving the Scavenger Sale process.

Black population loss in Chicago has topped 200,000 people in an exodus that began before the Great Recession. Disinvestment in Chicago's African American

neighborhoods dates back to the 1950s redlining and block-busting era-long before the riots, vandalizing and burning that followed Rev. Martin Luther King's assassination in 1968.

after World War II. Of course, this would require a \$1-billion urban-renewal investment by the federal government over a period of years.

• Enterprise zones: Identify vacant-lot areas near CTA elevated lines and public transportation that can be developed quickly using existing Transit-Oriented Development incentives.

• Build a Chicago casino: The vacant 37-acre site of the former Michael Reese Hospital on the Near South Side is a prime site for construction of a world-class gambling casino that would generate hundreds of construction jobs. The city spent \$80 million to acquire the site, and already has invested more than \$100 million into the neighborhood infrastructure

• Build more mixed-income housing: Looking back on the reign of Mayor Richard M. Daley, Boss Daley's son should be applauded for tearing down a halfdozen of the city's most infamous public-housing projects his father built, and replacing them with "mixed-income communities" between 2003 and 2006. Oakwood Shores, a 94-acre mixedincome community on Oakwood Boulevard (39th Street) between Langley and Ellis avenues in the Oakland/North Kenwood neighborhood, was built on the site of the former Ida B. Wells public housing project. The successful plan called for 3,000 new for-sale condominiums and townhomes, market-rate and affordable rental

New-home construction: New home-building is booming in Chicago's suburbs, and builders such as Pulte Homes, Toll Brothers and Lennar are always shopping for vacant land. The city should give the builders free vacant land and work with them to develop affordable housing on acreage donated from the Land Bank as long as union-trained minority workers are hired to do the work. Housing could be Section 8 and market-rate rentals and for-sale units

• Transform vacant factory buildings: Some abandoned industrial properties could become centers for factory-built pre-fabricated affordable housing units. The units could be erected quickly with a crane, then, mechanicals, including solar panels, could be hooked up on-site by union

• Expand trade-union jobs: Carpenter, electrical and plumbing unions should play a key role in the vacant-lot development plan. Abandoned school buildings should be opened and refitted as educational centers for young minority apprentices to be trained in the building trades.

• Innovative housing-design ideas: Because land would be free and builders are essentially working with a blank canvass, innovative architects and land planners should be encouraged to develop planned-unit, suburban-style sub-neighborhoods with curving streets, in-fill parks, ponds, and adjoining retail and schools as anchors.

• Urban farming: Some vacant acreage in the city already is being utilized for urban farming. Now that marijuana is legal, the city should create a program to grow pot in greenhouses on vacant lots, sell it in city-owned

retail stores. The pot business in Illinois recently surpassed the \$100-million threshold in total sales for the first time. Recreational marijuana sales generated a record \$75 million across the state during Oct. 2020. Pot will generate jobs. Of course, security will be needed to keep the marijuana greenhouses safe.

ing trial for being a felon in possession of a weapon in the suburbs, prosecutors said.

Illinois Dept. of Corrections records show Milton was paroled in June after serving six years of an 11-year sentence that he received for armed rob-

Prosecutors charged him with escape, Class X unlawful use of a weapon, and felony unlawful use of a weapon by a felon. Judge Mary Marubio ordered him held without bail for violating the terms of bond in the suburban gun case. She set bail at \$250,000 on the escape charge and another \$250,000 on the new gun case. Authorities will also hold him without bail while state officials consider revocation of his parole.

Man killed 15-year-old while trying to buy pot near Lincoln Square

An Evanston man gunned down a 15-year-old boy in an alley near Lincoln Square during a possible marijuana rip-off earlier this year, according to allegations made in court Dec.

Chicago police arrested Eric Gunn, 21, at his home Dec. 12 and prosecutors laid out the state's first-degree murder allegations against him during a bond court hearing Sunday.

Around 9:30 p.m. March 16, Gunn asked a woman to drive him and his brother to a location so they could get some pot for her to buy, Assistant



State's Attorney Michelle Cunningham said. Gunn allegedly gave the woman directions and eventually told her to stop when they

came upon Esteban Luvianos, 15, standing in an alley on the 2000 block of W. Farragut.

Gunn got out of the woman's minivan, and surveillance video shows a man, allegedly Gunn, struggling with Luvianos for control of a bag. Gunn then fired a single shot, striking the teenager one time in his face.

The woman allegedly told police that she heard a gunshot, and Gunn jumped back into her vehicle, ordering her to "Go! Go! Go!" According to Cunningham, she dropped Gunn and his brother off at their home after they sold her the marijuana.

Luvianos was pronounced dead at

Police contacted the woman after identifying her father as the owner of the minivan seen in surveillance videos. She directed police to Gunn's Snapchat account, where investigators allegedly found photos of Gunn posing with a handgun on the day of Luvianos' murder.

Gunn's Snapchat account pinged his phone location along a path that

Illinois files anti-trust lawsuit against Facebook

Illinois Attorney General Kwame Raoul filed a lawsuit against Facebook Inc. on Wednesday as part of a coalition of 48 state attorneys general and top lawyers from U.S. territories.

In the 123-page complaint filed in the U.S. District Court for the District of Columbia, the 48 states listed as plaintiffs allege that Facebook used illegal tactics to undercut competition "in the personal social networking market in the United States."

The states are asking the federal court to ban Facebook from continuing certain financial practices, restrain their ability to purchase other companies valued at \$10 million or more without notifying the plaintiff states and potentially restructure Facebook by removing assets the court determines were illegally obtained.

The Federal Trade Commission has also filed its own lawsuit against Facebook to "undo and prevent its anticompetitive conduct and unfair methods of competition in or affecting commerce."

"For nearly a decade, Facebook has profited tremendously by monetizing the personal information and online habits of users. Key to its strategy has been impeding and eliminating any perceived competition, ensuring that users have no alternative to Facebook's platform," Raoul said in a release distributed Wednesday afternoon.

"Facebook's ruthless anticompetitive practices have stifled innovation, harmed small businesses, and most importantly, reduced privacy protections and alternatives so that it could continue to earn billions of dollars at users' expense. I am joining

my colleagues around the country to ask the court to end Facebook's monopoly and give consumers the choice and protections they deserve."

Key to both lawsuits filed against Face-book is its 2012 acquisition of the photosharing platform Instagram and its 2014 acquisition of the mobile messaging application WhatsApp. The FTC and states that are suing Facebook allege that the company tracked the metrics of start-ups in industries Facebook was interested in and offered to buy out the companies with offers far above their actual value, inflating the worth of those companies during acquisition and eliminating future competition that could hinder Facebook's growth.

Mentioned in the FTC lawsuit is Face-book's failed attempts to purchase Snap-chat and Twitter, two other now-large competitors, early in their development cycle in 2013 and 2008 respectively.

By purchasing competitors, collecting vast amounts of private information on their customers and freezing out third parties from accessing that data after they became reliant on Facebook, the company was able to establish an advertising monopoly in the social media-sphere, according to the two lawsuits.

While separate from the states' lawsuit against Facebook, the FTC's filing also calls for assets, such as Instagram and WhatsApp, to be removed from Facebook's holdings under existing anti-trust laws.

"Personal social networking is central to the lives of millions of Americans," FTC Bureau of Competition Director Ian Conner said in a release Wednesday.

"Facebook's actions to entrench and maintain its monopoly deny consumers the benefits of competition. Our aim is to roll back Facebook's anticompetitive conduct and restore competition so that innovation and free competition can thrive."

People's Republic of China [PRC] on Aug. 13," a State Dept. spokesman said to this newspaper.

That decision, however, did not affect Chicago's Confucius Classroom, a fact independently confirmed by an official in the State Dept. and an second official at the Chicago Public Schools [CPS].

According to a spokesperson for the CPS, Chicago's Confucius Classroom will continue to remain open.

"According to a letter [we received] from the U.S. State Dept., the formal determination of the CIUS as a "foreign mission," does not apply to the Confucius Institute hosted by Walter Payton High School."

On its own website, Chicago's Confucius Classroom describes itself as a facility which provides professional development to area educators. Its multimedia resource library is open to the public and includes more than 10,000 items.

In late September, U.S. Secretary of State Mike Pompeo gave a speech in Madison, WI, warning U.S. politicians at the state and local level to be vigilant around Chinese diplomats who he said could be trying to woo them as part of Beijing's propaganda and espionage campaign. He pointed to suspicions that the PRC is trying to influence U.S. schools, business groups and local politicians.

"Confucius Classrooms, working through Confucius Institute programs, target Kindergarten through 12th grade classrooms. The [government of the] PRC works through the "CIUS" to fund all these programs and shape what is taught and what messages are conveyed. We recognized the CIUS as an entity advancing Beijing's global propaganda and malign influence campaign on U.S. campuses," the State Dept. spokesperson added.

Walter Payton College Preparatory High School, a selective enrollment high school which opened in 2000, is consistently ranked among the best in the state. On its website, the school is described as "an international model for global teaching and learning."

The Confucius Institute provides the coordination of the CPS Chinese World Language Program, which is housed at 45 schools in Chicago, with an estimated 13,000 students, and 61 full-time Chinese world language teachers teaching in the program. CPS claims that the Confucius Institute is not in any way involved in the design of curricular resources or guidance

documents for the Chinese program. They say it is being developed by CPS teachers with the Office of Language and Cultural Education's supervision.

But on Oct. 24 the Confucius Institute offered an introduction to the newly designed CPS Chinese Curriculum given by Dr. Shuhan Wang. The description on their website notes that "In order to align with the current National Standards for Learning Languages, CPS Chinese World

Language Task Force has created a new Chinese Curriculum Guide and Resources. The workshop [was] to introduce the new curriculum to teachers of Chinese, and help the teachers develop a basic understanding of the conceptual framework and essential elements of the curriculum units and apply them in daily teaching."

So it appears the Confucius Institute was involved with actual training for those doing the teaching. They also host educational delegations from the USA and abroad, coordinate study programs for teachers and students in China, and host Chinese cultural activities and events for students and parents.

Despite not having been designated as a "foreign mission" in August, the status of Walter Payton's Confucius Classroom will remain under review.

"We are continuing to review the operations of the overall program in the United States. CIUS meets the definition of a "foreign mission" under the Foreign Missions Act. By contrast, individual Confucius Institutes and Classrooms are generally structured as partnerships with U.S. colleges, universities, or school systems," she added.

The Chinese government opened its first Confucius Institute in the United States at the Univ. of Maryland in 2004. In May 2006, the Confucius Institute in Chicago opened. The facility operates as a partnership between the CPS, the Chinese Government's Chinese Language Council International and Shanghai's East China Normal (teaching) Univ. It was the first institute in the United States to be located inside a public K-12 school.
